SUMMARY OF CHANGES for Amendment A00003-QUESTIONS

The following have been added by full text:

1. Is it true that every job being produced has to have an anti-reflective coating?

RESPONSE: No, this is not correct.

2. How will VA determine the lowest price for the solicitation if the per fitting fee is multiplies by 1 ea? For instance, if Nashville has a requirement for 10,000 pairs of glasses, will the fitting fee be multiplied against 10,000 (all lens types added together), or 1 ea?

RESPONSE: Yes, it will be multiplied against the total number of eyeglasses for each care site to determine lowest price.

3. Item 00022 on the pricing schedule is an add-on per pair for the optician services at each location.

RESPONSE: The unit cost will be multiplied against the total number of eyeglasses for each care site to determine lowest price.

4. Under the section "Performance, Delivery, Inspection and Acceptance" it states "All deliveries should be sent by 1st class mail...". Can deliveries be made using other methods such as DHL, UPS, etc... if all other delivery requirements are met?

RESPONSE: 1st class mail was used based on price. If a vendor wishes to use another vendor, it is acceptable. However, using another delivery company may increase the price of the bid. The vendor bid must include the shipping cost within the total unit cost.

5. The SOW and amendment A00001 and A00003 detail the number of opticians (fitters) required at each location.

RESPONSE: Huntington 2; Lexington 3; Louisville 1; Mountain Home 2 and 1 at Knoxville; TVHS-Murfreesboro 1; Nashville 2; Chattanooga 1 and Memphis 2.

6. Your stated turn-around of all work is 2 weeks. Is this two weeks calendar days or work days?

RESPONSE: Calendar days (14)

7. There is conflicting statements of the "set-aside". Is this RFP a SDVOSB set-aside?

RESPONSE: Amendment A00002 dated 9/09/13 - set-aside SDVOSB

8. The RFP indicates that "frame samples will not be requested prior to an award". Please confirm.

RESPONSE: Frame Kit will be provided for each dispenser at all locations upon award.

9. In your statement regarding the method for submitting proposals you make no mention of an "electronic submittal" will you please confirm?
