- Contracting Activity: The Minneapolis VA Contracting Office, 708 South 3rd Street, Suite 200E, Minneapolis, MN 55415, is pursuing this sole source emergency procurement for the Department of Veterans Affairs, VISN 23, Fargo VA Health Care Systems (FVAHCS), utilizing a Request for Proposal (RFP) under FAR 6.302-2, unusual and compelling urgency utilizing the 1358 payment process.
- 2. Nature and/or Description of the Action Being Processed: This is an emergency procurement for a new firm, fixed-price Basic Ordering Agreement (BOA) with St. Luke's Home; St. Luke's Nursing Home (St. Luke's Home) in Dickinson, North Dakota. The current BOA with St. Luke's Home is soon to expire. The subject requirement is being pursued as an emergency procurement based on the justifications outlined below.
- 3. <u>Description of Supplies/Services Required to Meet the Agency's Needs</u>: This BOA is for nursing home services. The Independent Government Contract Estimate (IGCE) reflects spend of \$257,000.00, as submitted by the Fargo Contracting Office Representative (COR) in working in combination with Fee Basis and last year's spend to date with projections out to the end of the fiscal year. The performance period shall be from October 1, 2013 to March 31, 2014 with one (1) 6-month extension which extension is allowed pursuant to FAR 52.217-8.

5. Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority): This is an unusual and compelling urgency procurement because we currently have veteran patients residing in St. Luke's nursing home who require a contract for continued care. The Minneapolis VA Contracting Office recently transitioned to product lines whereby it was assigned approximately 190 Basic Ordering Agreements (BOAs) for all of VISN 23. Due to this new workload along with new and inexperienced staff, this office was not able to timely re-procure the renewal of this BOA. Thus, it has become an urgent and compelling issue. These circumstances qualify this requirement for the category of "unusual and compelling urgency", justifying other than full and open competition (sole sourcing to St. Luke's Home). Notably, once nursing home patients are placed in a nursing home, moving them is frequently not consistent with quality medical care. See paragraph #6 directly below.

- 6. <u>Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable</u>: No other offers were sought, because this facility is required for existing patients residing at St. Luke's Home. It is not in the best interest of quality medical care for veteran nursing home patients to be moved to a new nursing home once they have been placed at a nursing home. Moreover, VHA Handbook 1143.2, "VHA Community Nursing Home Oversight Procedures," (June 4, 2004), paragraph 2(a), provides that [f] or more than 35 years, the [Community Nursing Home] CNH Program has maintained....some level of patient choice in choosing a nursing home close to a veteran's home and family...."
- 7. <u>Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable</u>: Costs are pre-established by the State of North Dakota in the form of Medicaid rates for St. Luke's Home. Medicaid rates charged by St. Luke's Home will be the current or prevailing established State Medicaid rates.
- 8. <u>Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:</u> No other offers were sought, because this facility is required for existing patients who have already been placed there. See Section 6 above.

Market Research Report

Emergency Procurement for St. Luke's Home Basic Ordering Agreement (BOA)

The Fargo VA Health Care System (FVAHCS)

- Objective: The objective is to conduct an emergency sole source procurement for a nursing home services Basic Ordering Agreement (BOA) with St. Luke's Home in Dickinson, North Dakota utilizing a Request for Proposal (RFP) for the Fargo VA Health Care System (FVAHCS) under FAR 6.302-2, unusual and compelling urgency.
- 2. Background: The Statement of Work in the BOA provides that the nursing home shall ensure the Contractor shall provide CNH services to beneficiaries at the contractor's facility for whom such care is specifically authorized by the Fargo VA Health Care System (FVAHCS). The Contractor shall meet the health needs and promote the maximum well-being of VA patients. The Contractor shall ensure the total medical, nursing, and psycho social needs of VA beneficiaries. The Contractor shall provide Physician visits, laboratory, x-ray, and other special services for VA patients at the same frequency as that provided to other patients residing there who are receiving the same or comparable level of care. The Contractor shall motivate and educate patients to achieve and maintain independence in the activities of daily living. The Contractor shall keep patients ambulatory to achieve an optimal level of self-care.
- 3. Market Research Sources: Community Nursing Home (CNH) program personnel at the FVAHCS have been a primary source for nursing home care research at the FVAHCS. The FVAHCS indicates which nursing homes it desires to execute new BOAs with. The CNH team also indicates whether a BOA renewal is appropriate for any nursing home (community nursing home) that is presently a part of the CNH nursing home program.
- 4. Market Research Findings: This procurement shall be an emergency sole source Request for Proposals (RFP) pursuant to Federal Acquisition Regulations, FAR 6.302-2 (Unusual and Compelling Urgency), under NAICS code 623110, Nursing and Residential Care Facilities, size standard \$25.5 million. Many nursing homes are non-profit organizations or large corporations. Therefore a full and open procurement is often necessary to acquire as many quality nursing homes as is possible in both rural and urban areas to better service veterans, their families, friends, and relatives that support the veterans while veterans are in nursing homes.
 - It is not in the best interest of quality medical care for veteran nursing home patients to be moved to a new nursing home facility once they have been placed at a nursing home. Moreover, VHA Handbook 1143.2, "VHA Community Nursing Home Oversight Procedures," (June 4, 2004), paragraph 2(a), provides that [f] or more than 35 years, the [Community Nursing Home] CNH Program has maintained....some level of patient choice in choosing a nursing home close to a veteran's home and family..."
- 5. Customary Commercial Terms and Conditions: The contract vehicle shall be a Basic Ordering Agreement (BOA) for 6 months with a 6-month extension. The nursing home requirement is a services BOA which contains a wage determination, Medicaid rates, Statement of Work, etc.

- 6. Market Price: Medicaid rates which are established by the State of North Dakota for each individual nursing home will be used for the nursing home services provided under this BOA. St. Luke's Home Medicaid rates will obviously be used here.
 - The Independent Government Cost Estimate (IGCE) for a 6-month timeframe BOA that we seek with St. Luke's Home follows: \$257,000.00, as submitted by the Fargo Contracting Office Representative (COR) in working in combination with Fee Basis and last year's spend to date with projections out to the end of the fiscal year.
- 7. Acquisition History: The previous procurement was an RFP on the open market. The full and open method for competition was the best possible pursuit for this procurement, because we need the breadth of what the unrestricted market place has to offer for the placement of veterans in nursing homes in both rural and urban areas of North Dakota.
- 8. Other pertinent information: This is an unusual and compelling urgency procurement because we have veteran patients residing in St. Luke's nursing home who require a contract for continued care. The Minneapolis VA Contracting Office recently transitioned to product lines whereby it was assigned approximately 190 Basic Ordering Agreements (BOAs) for all of VISN 23. Due to this new workload along with new and inexperienced staff, this office was not able to timely re-procure the renewal of this BOA. Thus, it has become an urgent and compelling issue. These circumstances qualify this requirement for the category of "unusual and compelling urgency", justifying other than full and open competition (sole sourcing to St. Luke's Home). Notably, once nursing home patients are placed in a nursing home, moving them is frequently not consistent with quality medical care.
- 9. Recommendations: The recommendation is to conduct the procurement as an unusual and compelling urgency, FAR 6.302-2, RFP with a resulting BOA as the objective herein.
