6. Describe your market research efforts and efforts to ensure that offers are solicited from as many potential sources as is practicable:

Abbott/AMO was contacted by the Contract Specialist and was informed that only the OEM (Abbott/AMO) could service their equipment due to the fact that they do not allow third parties access to their proprietary software or help desk support. Additional market research also turned up no qualified vendors. An intent to sole source was issued on 9/3/2013 and closed on 9/5/2013 with no responses. The technical users and COR supported this position that only Abbott/AMO is able to service their own equipment and have provided documentation supporting this position. The Contracting Officer has come to the determination that no other sources are able or qualified to provide the required service on this particular requirement.

7. State why you feel that the anticipated cost to the Government will be fair and reasonable:

I certify that the pricing is fair and reasonable based upon the following: a) Abbott/AMO has provided the government a discount of approximately 36% from their regular (non-government) rate, and agreed not to raise prices during the 4 years of the quote, and b) the cost to purchase new biomedical equipment to replace the current equipment would be cost prohibitive compared to the servicing cost over the contract period, and c) the pricing quoted is representative of pricing for similar services based upon biomedical service agreement quotes received from other vendors.
