The Government will award to the offerer whose offer is the lowest price, technically acceptable. All Offerors shall provide quotes for equivalent items and or that exceed the specifications list in section B.3 of this solicitation

(b) Options. The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. - (10) FSC 9630, Additive Metal Materials.

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

"Restricted business operations" means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub.
