Support services agreement for the ScriptPro medication dispensing system for the Jesse Brown VAMC.

(3) (a) A DESCRIPTION OF THE SUPPLIES OR SERVICES REQUIRED TO MEET THE AGENCY'S NEED:

The Jesse Brown VAMC in Chicago, IL requires system support for the ScriptPro medication dispensing systems that requires software updates, preventative maintenance and service in order to remain operable.

The Jesse Brown VAMC has a requirement for technical support and maintenance for the prescription dispensing system known as ScriptPro. This service is required to maintain the system in good working order and also provides vital software upgrades and updates to the system. The ScriptPro system is manufactured and sold by only one source and the proprietary parts and software are not interchangeable with items sold by any other contractor.

These are "direct replacements" parts/components for existing equipment.

The material/service must be compatible in all aspects (form, fit and function) with existing systems presently installed/performing. Describe the equipment/function you have now and how the new item/service must coordinate, connect, or interface with the existing system.

The new work is a logical follow-on to an original Federal Supply Schedule order provided that the original order was placed in accordance with the applicable Federal Supply Schedule ordering procedures. The original order must not have been previously issued under sole source or limited source procedures.

An urgent and compelling need exists, and following the ordering procedures would result in unacceptable delays.

(5) DESCRIBE WHY YOU BELIEVE THE ORDER REPRESENTS THE BEST VALUE CONSISTENT WITH FAR 8.4 TO AID THE CONTRACTING OFFICER IN MAKING THIS BEST VALUE DETERMINATION:

Replacing medication dispensing equipment currently owned by the Jesse Brown VAMC would be cost prohibitive at this time. The Jesse Brown VAMC is currently paying \$ [REDACTED] for those required services for FY [REDACTED] under PO [REDACTED] and for FY [REDACTED]. Script Pro is offering to the Jesse Brown VAMC a price of \$ [REDACTED] an increase of only [REDACTED]. Therefore, pricing is deemed to be fair and reasonable.


Not having the medication dispensing units working properly at all times would ultimately affect direct patient care at the Jesse Brown VAMC.


