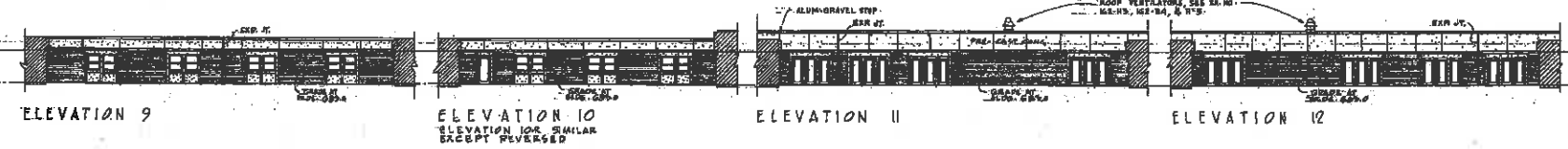
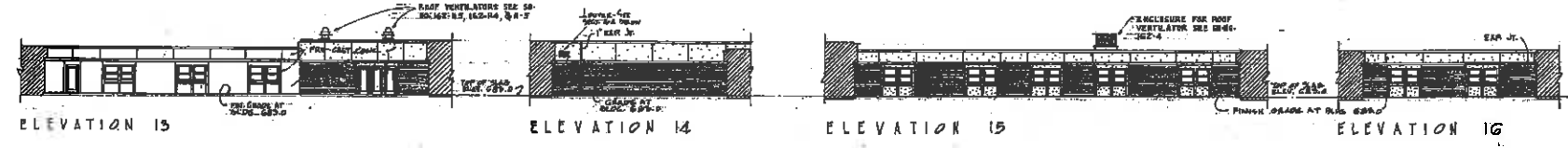


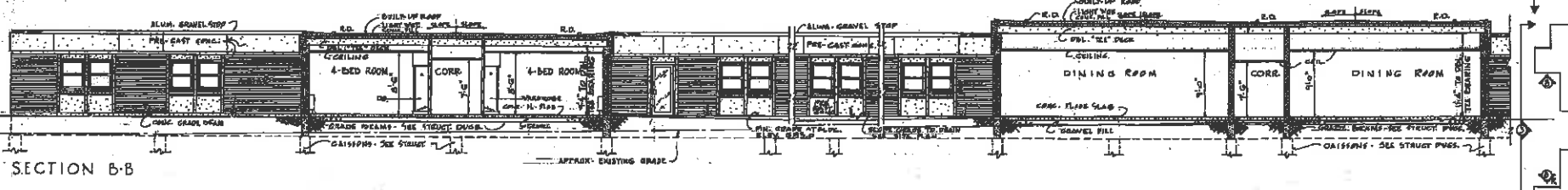
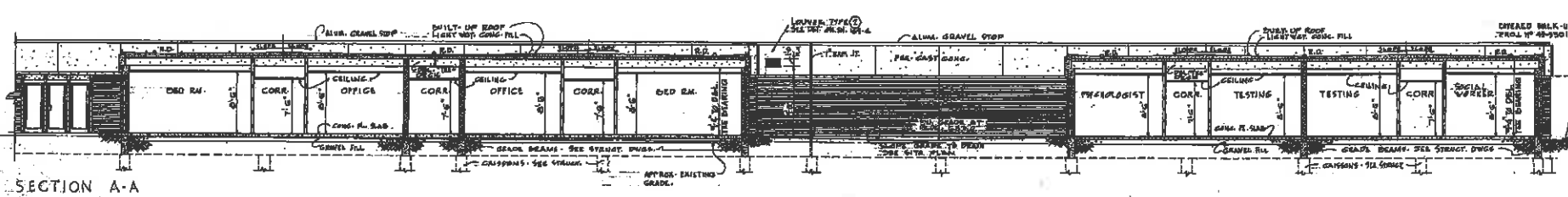
EXTERIOR PERIMETER ELEVATIONS NOS. 1 THRU 8



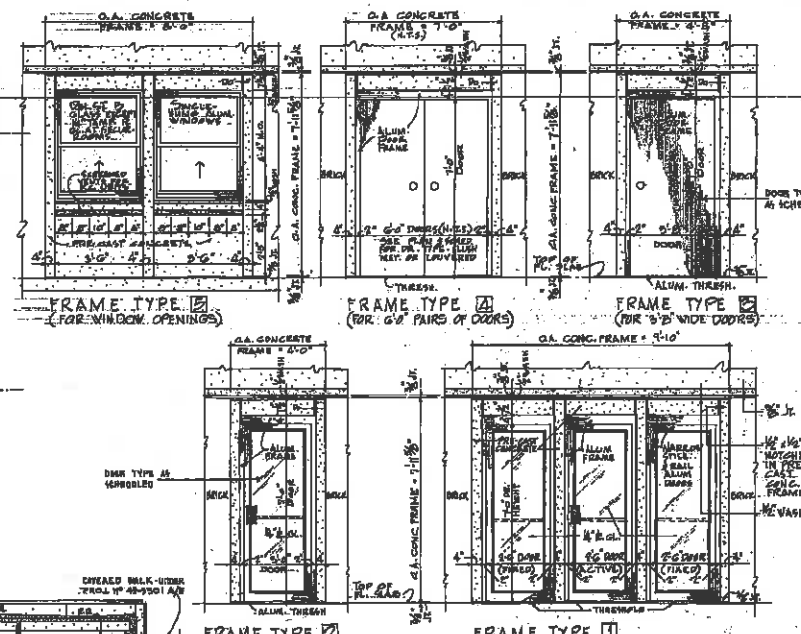
INTERIOR COURTS 1 & 2 - ELEVATIONS 9 THRU 12



INTERIOR COURT 3 - ELEVATIONS 13 THRU 16

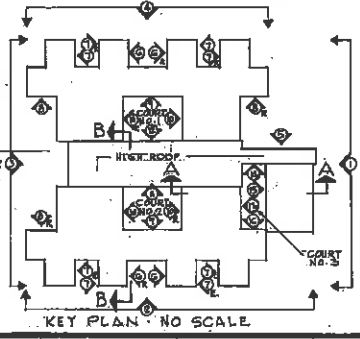


BUILDING CROSS SECTIONS A-A & B-B



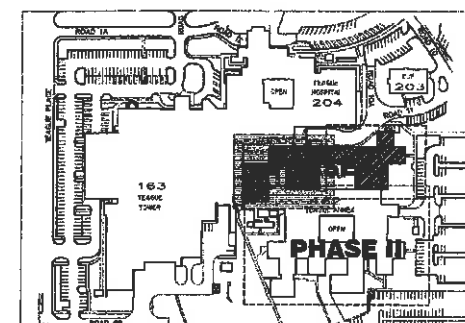
