2. **Nature and/or Description of the Action Being Processed:** The Erie VAMC needs to service the mail-processing machine in the pharmacy because it was not working. After a service call was placed and a Pitney Bowes technician arrived on site, it was determined that the machine needed a new part to function correctly.
3. **Description of Supplies/Services Required to Meet the Agency's Needs:** The Erie VAMC needs the a new part for the mail-processing machine. This is the Midjet Power Supply E-st.
4. **Statutory Authority Permitting Other than Full and Open Competition:**

5. **Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority):**

Pitney Bowes is the only party authorized to work on a Pitney Bowes machine. This sole source justification will be posted to FedBizOpps for three days in order to determine if there are other interested vendors able to meet this requirement.
6. **Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:**

The original mail-processing machine was purchase competitively.

Pitney Bowes is the only party authorized to work on a Pitney Bowes machine. This sole source

justification will be posted to FedBizOpps for three days in order to determine if there are other interested vendors able to meet this requirement.

The price is fair and reasonable. Because this wasn't on contract, open market charges were incurred. Two invoices were received: one for the initial visit to determine the issue and one for the repair service visit.

Invoice 311052 for the repair of the equipment (\$916.16). (a) Two miles of travel charged at \$0.58 per mile (total \$1.16) GSA lists mileage charges for a POV at \$0.565 per mile. This price of \$1.16 is fair and reasonable. (b) Labor charge of two hours at \$150 per hour (total \$300). Pitney charges \$344 for two hours of labor, per their GSA schedule (GS-25F-0010M). This results in an hourly rate of \$172. Pitney charged \$150 an hour. Per FAR 8.404(d), GSA prices are determined to be fair and reasonable at the time of GSA contract award. This cost is fair and reasonable. (c) Travel charge of 001 hours @ \$150 per hour (total \$150). Pitney Bowes was contacted to discuss this cost. They stated that it is charged to all customers requiring service to a machine that is not under contract (see attachment from Pitney Bowes). This charge is fair and reasonable. (d) Midjet Power Supply (\$465). This part was needed to repair the machine. This was found online at the same price. This price is fair and reasonable. I recommend approving the invoice for \$916.16.

Invoice 319771 for the technician to determine the issue with the machine (\$450): Labor charge of three hours at \$150 per hour (total \$450). Pitney charges \$344 for two hours of labor, per their GSA schedule (GS-25F-0010M), which is the minimum amount charged for this type of service. This results in an hourly rate of \$172. Pitney charged \$150 an hour. Per FAR 8.404(d), GSA prices are determined to be fair and reasonable at the time of GSA contract award. This cost is fair and reasonable. I recommend approving this invoice for the full amount: \$450.

If this unauthorized commitment is approved, it will result in a task order against GSA contract GS-25F-0010M with Pitney Bowes.

7. **Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:** Aside from posting this justification on FedBizOpps, no other market research was completed.
8. **Any Other Facts Supporting the Use of Other than Full and Open Competition:** N/A.

The machines are competitively purchased, however, Pitney Bowes is the only party authorized to perform work on Pitney Bowes machines.
