It also shows Jefferson County Carpenters Formbuilding/Formsetting at \$17.55 wage rate and \$3.70 fringe. Then it has a classification for Laborer at \$10.40 wage rate and \$2.62 fringe. How do we classify our crews that are forming, reinforcing, placing and finishing the concrete structure? Can we group them as Laborers?\
