The contractor shall provide armored car services for the VA Health Care System and Veterans Canteen Service located at the following stations.

The contractor's responsibilities shall include the following:

1. The contractor's responsibility for the safekeeping of shipment shall commence when the contractor has received the shipment and a receipt provided. The responsibility shall terminate when delivery is completed a receipted for by VA or bank. A record of all deliveries and pickups shall be maintained in an accountable register furnished by the contractor.
2. After award, the contractor shall provide VA with a list of names and identification of authorized messengers.
3. The contractor will be liable for the loss of shipments.
4. The contractor shall deliver shipments to the designated consignee in the same condition as receipted for. A receipt by the consignee shall be conclusive evidence that shipment was received securely sealed and that the package(s) were free from any cuts, holes, or other defects which could permit a loss of contents. All deposits will be transported in a locked or sealed bag.
5. All firearms will remain holstered while on VA property. Any security related issues, to include the deployment or use of any weapons, will be immediately reported to the VA Police.
6. Bagged money delivered to VA must be handled carefully in such a manner to prevent rolled coins from breaking open.
7. For the entire period of performance of the contract, the contractor shall carry liability insurance at the expense of the contractor. It is understood and agreed to that the maximum liability will likely not exceed twenty-five thousand dollars (\$25,000.00) per trip. Before commencing work under the contract, the contractor shall furnish the VA Contracting Officer with certification from an insurance company indicating proof of proper coverage by bond on all risk insurance against theft and loss of goods, materials, cash, checks, or other securities totaling up to twenty-five thousand dollars (\$25,000.00) minimum.

Services for VA Central Iowa Health Care System includes the following:

1. The contractor agrees to call for and receive from the VA Health Care System and the receipt thereof, funds, securities, and instruments, securely and distinctively sealed and/or locked and tagged as provided, and to transport and deliver the same in like condition to the consignees as designated by VA.
2. Pickups and deliveries to and from the US Bank, 714 E. 2nd Street, Des Moines, IA 50309.
3. Pickup of requests for change orders from VA Central Iowa HCS and delivery of change order to VA Central Iowa HCS.
4. Pickup of deposits from VA Central Iowa HCS and delivery of bank deposit receipts and empty bags to VA Central Iowa HCS.
5. Pickup of cash funds from VA Central Iowa HCS and for purchase of bank checks and delivery of bank checks to VA Central Iowa HCS.

 - c. The pickup times shall be between 1:00 PM CST and 1:30 PM CST.
7. In the event the day designated for the performance of services shall be a federal, bank, legal, or other holiday, or in the event of some other irregularity, performance shall be made on the next business day, unless stated or scheduled otherwise by VA.
8. The VA will prepare in securely and distinctively sealed and/or locked packages or containers properly tagged or marked with the name of the designated consignee of all funds, securities, and/or instruments for prompt delivery. Deposits shall be ready at time of pickup; however, the contractor shall be required to wait no longer than ten minutes.
9. If storage of deposits is required in the contractor's vault overnight or weekend, the deposit of money will be made the morning of the next business day. Receipt shall be obtained from the bank and delivered to the corresponding division at VA Central Iowa HCS.
10. Additional unscheduled trips may be required, with no more than two per month.

VA Nebraska-Western Iowa Health Care System:

1. The contractor shall provide all labor and resources necessary to successfully complete the requirements below. The contractor must be fully bonded and insured.
2. Armored car services are required at the Omaha VA Health Care System located at 4101 Woolworth Avenue, Omaha, NE 68105 to transport cash and coins between U.S. Bank, and the VA Agent Cashier

and the Veterans Canteen Service. U.S. Bank is located at 1700 Farnam Street Omaha, NE 68105 (near 16th St. and Capitol Hill).

3. The contractor shall pick up cash at U.S. Bank and deliver the cash to the Agent Cashier.
4. The contractor shall transport cash from the Veterans Canteen Service to U.S. Bank. Change orders will be called to U.S. Bank and the contractor shall pick up change orders before picking up the deposit from the Canteen. Broadwell Avenue, Grand Island, NE 68803 to transport cash and coins between the Five Points Bank, and the VA Agent Cashier and the Veterans Canteen Service. The Five Points Bank is located at 2015 N Broadwell Avenue, Grand Island, NE 68803.
3. The contractor shall pick up cash at the Five Points Bank and deliver the cash to the Agent Cashier.
4. The contractor shall transport cash from the Veterans Canteen Service to the Five Points Bank.
5. The transfer of cash is required twice each week, as arranged with the Agent Cashier and Veterans Canteen Service. The regularly scheduled pickups are typically on Tuesday and Friday between the hours of 9:00 AM CST and 12:00 PM CST. If co-mingling must be allowed to meet the requirements of the business need, the contractor must ensure that VA's information is returned to the VA or destroyed in accordance with VA's sanitization requirements. VA reserves the right to conduct on site inspections of contractor and subcontractor IT resources to ensure data security controls, separation of data and job duties, and destruction/media sanitization procedures are in compliance with VA directive requirements.
- c. Prior to termination or completion of this contract, contractor/subcontractor must not destroy information received from VA, or gathered/created by the contractor in the course of performing this contract without prior written approval by the VA. Any data destruction done on behalf of VA by a contractor/subcontractor must be done in accordance with National Archives and Records Administration (NARA) requirements as outlined in VA Directive 6300, Records and Information Management and its Handbook 6300.1 Records Management Procedures, applicable VA Records Control Schedules, and VA Handbook 6500.1, Electronic Media Sanitization. Self-certification by the contractor that the data destruction requirements above have been met must be sent to the VA Contracting Officer within 30 days of termination of the contract.
- d. The contractor/subcontractor must receive, gather, store, back up, maintain, use, disclose and dispose of VA information only in compliance with the terms of the contract and applicable Federal and VA information confidentiality and security laws, regulations and policies. If Federal or VA information confidentiality and security laws, regulations and policies become applicable to the VA information or information systems after execution of the contract, or if NIST issues or updates applicable FIPS or Special Publications (SP) after execution of this contract, the parties agree to negotiate in good faith to implement the information confidentiality and security laws, regulations and policies in this contract.
- e. The contractor/subcontractor shall not make copies of VA information except as authorized and necessary to perform the terms of the agreement or to preserve electronic information stored on contractor/subcontractor electronic storage media for restoration in case any electronic equipment or data used by the contractor/subcontractor needs to be restored to an operating state. If copies are made for restoration purposes, after the restoration is complete, the copies must be appropriately destroyed.
- f. If VA determines that the contractor has violated any of the information confidentiality, privacy, and security provisions of the contract, it shall be sufficient grounds for VA to withhold payment to the contractor or third party or terminate the contract for default or terminate for cause under Federal Acquisition Regulation (FAR) part 12.
- g. If a VHA contract is terminated for cause, the associated BAA must also be terminated and appropriate actions taken in accordance with VHA Handbook 1600.01, Business Associate Agreements. Absent an agreement to use or disclose protected health information, there is no business associate relationship.
- h. The contractor/subcontractor must store, transport, or transmit VA sensitive information in an encrypted form, using VA-approved encryption tools that are, at a minimum, FIPS 140-2 validated.
- i. The contractor/subcontractor's firewall and Web services security controls, if applicable, shall meet or exceed VA's minimum requirements. VA Configuration Guidelines are available upon request.

- j. Except for uses and disclosures of VA information authorized by this contract for performance of the contract, the contractor/subcontractor may use and disclose VA information only in two other situations: (i) in response to a qualifying order of a court of competent jurisdiction, or (ii) with VA's prior written approval. The contractor/subcontractor must refer all requests for, demands for production of, or inquiries about, VA information and information systems to the VA contracting officer for response.
- k. Notwithstanding the provision above, the contractor/subcontractor shall not release VA records protected by Title 38 U.S.C. 5705, confidentiality of medical quality assurance records and/or Title 38 U.S.C. 7332, confidentiality of certain health records pertaining to drug addiction, sickle cell anemia, alcoholism or alcohol abuse, or infection with human immunodeficiency virus. If the contractor/subcontractor is in receipt of a court order or other requests for the above mentioned information, that contractor/subcontractor shall immediately refer such court orders or other requests to the VA contracting officer for response.
- l. For service that involves the storage, generating, transmitting, or exchanging of VA sensitive information but does not require C&A or an MOU-ISA for system interconnection, the contractor/subcontractor must complete a Contractor Security Control Assessment (CSCA) on a yearly basis and provide it to the COR.

SECTION C - CONTRACT CLAUSES

C.1 52.204-9 PERSONAL IDENTITY VERIFICATION OF CONTRACTOR PERSONNEL (JAN 2011)

(b) The Contractor shall account for all forms of Government-provided identification issued to the Contractor employees in connection with performance under this contract. The Contractor shall return such identification to the issuing agency at the earliest of any of the following, unless otherwise determined by the Government:

- (1) When no longer needed for contract performance.
- (2) Upon completion of the Contractor employee's employment.
- (3) Upon contract completion or termination.

(c) The Contracting Officer may delay final payment under a contract if the Contractor fails to comply with these requirements.

(d) The Contractor shall insert the substance of this clause, including this paragraph (d), in all subcontracts when the subcontractor's employees are required to have routine physical access to a Federally-controlled facility and/or routine access to a Federally-controlled information system. It shall be the responsibility of the prime Contractor to return such identification to the issuing agency in accordance with the terms set forth in paragraph (b) of this section, unless otherwise approved in writing by the Contracting Officer.

(c) The total duration of this contract, including the exercise of any options under this clause, shall not exceed five years and six months.

(b) All insurance shall be written on companies acceptable to Department of Veterans Affairs, and policies shall include such terms and conditions as required by Department of Veterans Affairs. The Contractor shall provide evidence of acceptable cargo insurance to Department of Veterans Affairs before commencing operations under this contract.

(c) Each cargo insurance policy shall include the following statement:

"It is a condition of this policy that the Company shall furnish--

(1) Written notice to Department of Veterans Affairs, 30 days in advance of the effective date of any reduction in, or cancellation of, this policy; and

(2) Evidence of any renewal policy to the address specified in paragraph (1) of this statement, not less than 15 days prior to the expiration of any current policy on file with Department of Veterans Affairs."

C.8 52.228-10 VEHICULAR AND GENERAL PUBLIC LIABILITY INSURANCE (APR 1984)

(a) The Contractor, at the Contractor's expense, agrees to maintain, during the continuance of this contract, vehicular liability and general public liability insurance with limits of liability for-- (1) bodily injury of not less than \$200,000 for each person and \$500,000 for each occurrence and (2) property damage of not less than \$200,000 for each accident and \$500,000 in the aggregate.

(2) Does not include a government or governmental entity that is not operating as a business enterprise.

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).
