2. **Nature and/or Description of the Action Being Processed:**

Requirement of contractor to use "Milestone" system compatible components, referenced in 28 23 00, for Project No.: 552-14-101, Patient Environmental Enhancement (Bldg. 320 – Pod D) with a J&A estimated construction cost of \$16,000.00.

3. **Description of Supplies/Services Required to Meet the Agency's Needs:**

As part of a project to renovate Building 320, Unit D, for dementia patient at the Dayton VAMC, the existing video recording system will be expanded to provide more efficient monitoring of the patients and will be controlled by the existing Milestone Video Management System.

There have been previous purchases for the Tridium based software. The Contracting Officer will be able to determine a fair and reasonable pricing based on previous procurement history and commercial pricing. A fair and reasonable price determination will be made by the Contracting Officer based on competition.

8. **Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:**

Market research has been previously conducted for prior projects, concerning this subject. Multiple manufacturers produce video management systems. This product is open for the public to purchase, this allows any contractor who has been properly trained on the product to install. The certification classes are also open to the public. There are at least five (5) contractors in the tri-state area who currently can install these products.


No action can be taken in the circumstance due to the equipment being under warranty and the need to maintain this warranty.
