Scriptpro's software is mandated to be used with their prescription dispensing equipment and is proprietary to Scriptpro USA Inc. There are no suitable substitute products.

Replacement parts are required to be original manufacture parts and no other known source exists that can provide generic parts for this equipment.

This task order represents the best value to the government because it aids the pharmacy in accurately counting prescription drugs. Microsoft will no longer support XP and upgrade to WIN 7 must be accomplished for equipment to operate.

Market research was conducted by the contract specialist to determine if this requirement could be met from a mandatory source. A required source was found on a mandatory FSS contract under schedule 65 II A. The government has already purchased the Scriptpro equipment, and ScriptPro is the only authorized contractor to service and provide replacement parts for their Scriptpro equipment. They also provide their proprietary software as a monthly license fee that works with the prescription dispensing machine. No other substitute product was found that could meet the government's requirement.

- (7) IN ACCORDANCE WITH FAR 8.405-6(c)(2)(vii) ANY OTHER FACTS SUPPORTING THE JUSTIFICATION:**

ScriptPro's published Federal Supply Schedule price list dated December 1, 2012, page 75, states that the equipment warranty would be void if the equipment or software is installed or modified other than by ScriptPro; their software is proprietary information of Scriptpro.


