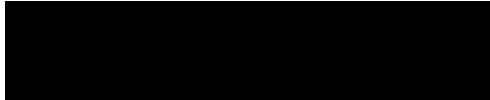

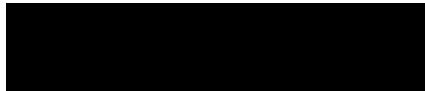

While there are other manufacturers of security system equipment that can meet the Government's minimum requirements, it is not in the Government's best interest to award an acquisition to any other brand. Delta Controls has been implemented at the facility in October 2009. The change is being made at the facility for ease of use and ability to provide the most efficient environmental conditions throughout the station building including the hospital. The existing Johnson Controls are useable by only one operator at the facility and in his absence there is no back up. However, in the interest of generating competition, Johnson Controls are acceptable for this project. The changeover to Delta Controls and the use of Delta Controls will meet the operational need of the Lebanon VAMC by giving the engineering department redundant HVAC operational control. Use of other

manufacturers would lead to storing additional inventory, functioning issues due to non-compatibility with existing equipment, multiplicity of service contracts, and increased training and operator requirements.
