Site visit is scheduled for Wednesday 03/12/14 at 10::00 am at the Learning Exchange located at the Louis Stokes VA Medical Center, 10701 East Boulevard, Cleveland, OH 44106.

This solicitation is for brand name or equal, technically acceptable, low cost, new equipment only. No partial quotes will be accepted.

1. Contract Title.

Audio Visual Equipment for the Simulation Lab located in the Cleveland VA Medical Center Learning Exchange.

2. Background.

This equipment request is for the newly renovated area of the Cleveland VA Medical Center Learning Exchange. Two treatment Sim rooms, two control rooms, and two debriefing rooms are being constructed to enable the medical center to enhance its use of simulation scenario training activities. This equipment request is designed to intergrate the simulation manikins, health care technology, computer software, and audio visual systems.

3. Scope.

This contract covers a turnkey solution for the overall integration of audio visual and manikins training equipment. The solution will be for only the LSCVAMC Learning Exchange renovation project area. The awarded contractor will be responsible for designing and installing a SIM system, and AV equipment, that will work with GFE simulation manikins.

4. Specific Tasks.

The Simulation Capturing system will serve to include the following functions:

Simulation activity capturing

The provided encoder will allow for recording capability from up to four cameras and two high resolution video sources (4 BNC, 2 DVI-I). Of the six possible connected sources, four of the sources need to capture simultaneously. Simulator trends, real medical devices, evaluations, annotations, and other external data are to be captured and transferred via 2 network ports on the encoder. The system includes:

- Simulation Capture system is a rack server form factor. This equipment will be racked along with Audio Visual components in the simulation center control room.
- Simulation Capture mobile unit will be installed in the AV mobile cart. The completed mobile cart solution will have full recording and debrief capability for any space in or outside the simulation center, and recording capability for up to six input devices (4 cameras, 2 high resolution sources).

Simulation Communication Bridge

The simulation solution must provide a communication bridge between remote and local simulation devices and back-end systems via dedicated network or web services. The Simulation Bridge software should be able to function on dedicated GFE (Government furnished equipment) either physical or virtual servers that can be provided by the purchasing agency (Veteran Affairs).

Assessment Monitoring Module

The Assessment Module allows for the creation and association of checklists to sessions. The assessments can be completed in live and post settings and for individuals and teams. The system needs to allow for attaching images and sounds, leverage multiple question types, assign individual and total point values, group by question categories, and automatically store all your work in a reusable library of questions.

Courses Module

The Courses Module needs to be designed to allow the simulation center to manage and administer instructional content through structured curriculum and status updates. Participants are then to be assigned optional or required pre-and post-session evaluations.

Simulation Center Scheduling Module

A Scheduling Module needs to be included that provides administrators and participants with advanced calendaring functions such as self-enrollment, alerting, notifications and multi-section events. Scheduling should also include personal calendars, center asset management, and calendar filtering.

LDAP (Lightweight directory access protocol) Integration Module

The simulation center system should have ability to provide user and administration security modules. This security module should be compatible with LDAP Integration protocols that could allow the simulation center system to provide future migration with the VA's existing user authentication mechanism. Administrators and participants will follow the existing VA standards for security user names and passwords and will need to be able to use their existing user name and password to access the system.

The Simulation Center Audio Visual system will perform the following functions:

Simulation Room 1 & 2

6. Page individual SIM rooms, Debrief Rooms or the Hallway utilizing ceiling speakers in each room.
7. Page all rooms for overhead announcements.
8. The composite video feeds from the cameras will be connected to a matrix switch which will allow the operator to change which cameras feed the Simulation capture system in the room. In Simulation room 1, Simulation room 2, Debrief Room 1 and Debrief Room 2 the operator can select any camera and route it to any of the connected Simulation Capture system assigned to that room. (4) Clearly describe any modifications the offeror plans to make in a product to make it conform to the solicitation requirements. Mark any descriptive material to clearly show the modifications.

(c) The Contracting Officer will evaluate "equal" products on the basis of information furnished by the offeror or identified in the offer and reasonably available to the Contracting Officer. The Contracting Officer is not responsible for locating or obtaining any information not identified in the offer.

(d) Unless the offeror clearly indicates in its offer that the product being offered is an "equal" product, the offeror shall provide the brand name product referenced in the solicitation.

(End of Provision)

E.2 VAAR 852.211-73 BRAND NAME OR EQUAL (JAN 2008)

(Note: as used in this clause, the term "brand name" includes identification of products by make and model.)

(a) If items called for by this invitation for bids have been identified in the schedule by a "brand name or equal" description, such identification is intended to be descriptive, but not restrictive, and is to indicate the quality and characteristics of products that will be satisfactory. Bids offering "equal" products (including products of the brand name manufacturer other than the one described by brand name) will be considered for award if such products are clearly identified in the bids and are determined by the Government to meet fully the salient characteristics requirements listed in the invitation.

(b) Unless the bidder clearly indicates in the bid that the bidder is offering an "equal" product, the bid shall be considered as offering a brand name product referenced in the invitation for bids.

(c)(1) If the bidder proposes to furnish an "equal" product, the brand name, if any, of the product to be furnished shall be inserted in the space provided in the invitation for bids, or such product shall be otherwise clearly identified in the bid. The evaluation of bids and the determination as to equality of the product offered shall be the responsibility of the Government and will be based on information furnished by the bidder or identified in his/her bid as well as other information reasonably available to the purchasing activity. CAUTION TO BIDDERS. The purchasing activity is not responsible for locating or securing any information that is not identified in the bid and reasonably available to the purchasing activity. Accordingly, to insure that sufficient information is available, the bidder must furnish as a part of his/her bid all descriptive material (such as cuts, illustrations, drawings or other information) necessary for the purchasing activity to:

(i) Determine whether the product offered meets the salient characteristics requirement of the Invitation for Bids, and

(ii) Establish exactly what the bidder proposes to furnish and what the Government would be binding itself to purchase by making an award. The information furnished may include specific references to information previously furnished or to information otherwise available to the purchasing activity.

(2) If the bidder proposes to modify a product so as to make it conform to the requirements of the Invitation for Bids, he/she shall:

(i) Include in his/her bid a clear description of such proposed modifications, and

(ii) Clearly mark any descriptive material to show the proposed modifications.

(3) Modifications proposed after bid opening to make a product conform to a brand name product referenced in the Invitation for Bids will not be considered.

(a) The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate offers:

(b) *Options.* The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. The Government may determine that an offer is unacceptable if the option prices are significantly unbalanced. Evaluation of options shall not obligate the Government to exercise the option(s).

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

"Restricted business operations" means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub.
