If the EULA, TOS, or similar legal instrument or agreement is invoked through an “I agree” click box or other comparable mechanism (e.g., “click-wrap” or “browse-wrap” agreements), execution does not bind the Government or any Government authorized end user to such clause.

(3) Any such clause is deemed to be stricken from the EULA, TOS, or similar legal instrument or agreement.

(b) Paragraph (a) of this clause does not apply to indemnification by the Government that is expressly authorized by statute and specifically authorized under applicable agency regulations and procedures.

E. 2 BASIS FOR AWARD

Any award will be made based on the best overall (i.e., best value) proposal that is determined to be the most beneficial to the Government, with appropriate consideration given to the three following evaluation Factors: Technical, Past Performance, and Price. The Technical criteria and past performance history when combined are more important than price. Offerors are cautioned that the award may not necessarily be made to the lowest Price offered.

The best value determination will be made by considering proposals against evaluation factors as follows:

1. Technical Evaluation

The evaluation process will consider the extent to which the proposal demonstrates a clear understanding of the technical features involved in meeting the solicitation requirements and whether the offeror's methods and approach have adequately and completely considered, defined and satisfied the requirements in the Solicitation.

2. Past Performance

- a. The contractor will provide as part of the proposal a description of three separate and recent client references for which the offer has provided comparable service to those described in the Statement of Work.

- b. Past performance will be evaluated against the following criteria:
 - a. Quality of Service – Compliance with contract requirement.
 - b. Customer Satisfaction – Satisfaction with the client and end users with the offer's service.

Technical merit shall be evaluated for each factor listed under the heading "Technical Factors". Technical merit, which reflect the Government's confidence in each offeror's ability, as demonstrated in its proposal, to perform the requirements stated in the RFQ, shall be evaluated based on the following:

Exceptional: Information submitted demonstrates an exceptional and clear understanding of all aspects of the requirements established by the RFQ. The proposal contains no significant weaknesses, deficiencies or disadvantages and significantly exceeds most or all the requirements established by the RFQ.

Above Average: Information submitted demonstrates the Offeror's potential to exceed performance or capability standards. Proposal reflects some strength that may be of benefit to the Government. Deficiencies noted are of a minor nature. The submittal demonstrates all requirements of the RFQ are understood, and all requirements have been met or exceeded.

Average: Information submitted demonstrates Offeror's potential to meet performance or capability standards. Proposal meets the minimum standard requirements of the RFQ. Few or no advantages or strengths. The proposal contains only minor weaknesses. The submitted proposal is complete and comprehensive, reflecting an understanding of the scope and depth of the RFQ.

Marginal: Proposer possesses only a few of the desired attributes and qualities expressed in the RFQ, for the factor being evaluated. The Government may still receive benefit from the proposal submitted. Weaknesses and deficiencies noted are correctable without major revision of the proposal.

Unacceptable: Proposer lacks the desired attributes and qualities necessary to receive a higher rating. Weaknesses and/or deficiencies noted are uncorrectable without a major revision of the proposal.

The Past Performance evaluation will assess the relative risks associated with an Offeror's likelihood of success in fulfilling the solicitation's requirements as indicated by that Offeror's record of past performance.

The Government will conduct a performance risk assessment based on the quality, relevancy and recency of the Offeror's past performance as it relates to the probability of successful accomplishment of the required effort. Offerors are cautioned that the Government will review available past performance data available in the Past Performance Information Retrieval System (PPIRS). The Government reserves the right to obtain past performance information from any available source and may contact customers other than those identified by the Offeror when evaluating past performance. Since the Government may not necessarily interview all of the sources provided by the Offerors, it is incumbent upon the Offerors to explain the relevance of the data provided. Offerors are reminded that the burden of proving low performance risk rests with the Offerors.

In the case of an Offeror without a record of relevant past performance or for whom information on past performance is not available, the Offeror may not be evaluated favorably or unfavorably on past performance.

Past Performance Factor Rating Definitions. The Past Performance Factor rating will be expressed as an adjectival assessment of High Risk, Moderate Risk, Low Risk or Unknown Risk.

High Risk - Significant doubt exists, based on the Offeror's performance record, that the Offeror can perform the proposed effort.

Moderate Risk - Some doubt exists, based on the Offeror's performance record, that the Offeror can perform the proposed effort.

Low Risk - Little doubt exists, based on the Offeror's performance record, that the Offeror can perform the proposed effort.

Unknown Risk - No relevant performance record identifiable; equates to a neutral rating having no positive or negative evaluation significance.

(a) The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate offers:

Technical

Past Performance

Price

Technical and past performance, when combined, are more important than price.

(b) *Options.* The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. The Government may determine that an offer is unacceptable if the option prices are significantly unbalanced. Evaluation of options shall not obligate the Government to exercise the option(s).

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.
