1. **Contracting Activity:** Department of Veterans Affairs, Network Contracting Office (NCO) 21. This is a Justification for Other Than Full and Open Competition for VISN 21, VA San Francisco Medical Center (PR 662-14-1-061-0003) for Blood and Blood Byproduct.
2. **Nature and/or Description of the Action Being Processed:** This action is for an interim contract to provide a continued source of supply for blood and blood byproducts while NCO 21 completes procurement for a one-year follow-on contract with four one-year option periods. The interim contract will be for a period of [REDACTED] with an estimated value of [REDACTED]

The current contractor is Blood Centers of the Pacific.

The US Food and Drug Administration are responsible for the registration of blood banks. There are three active registered blood banks listed in San Francisco. However, only Blood Centers of the Pacific supplies all of the blood products required by the VA.

4. Statutory Authority Permitting Other than Full and Open Competition:

5. Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority):

As indicated in Section 3, above, only Blood Centers of the Pacific is registered and capable of satisfying the VA's requirements.

6. Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:

Only FDA-registered blood banks are allowed to provide blood. VA will review the registered blood bank list on the FDA web site prior to initiating new procurements. In accordance with FAR SUBPART 12.6 and previous procurement history, we will issue a notice of intent to negotiate on a sole source basis on FedBizOpps. Potential Offerors can contact the VA if they have the ability to satisfy the requirement.

7. Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable:

The anticipated cost/price will be considered fair and reasonable based upon historical prices paid and inflation rates for the blood supply and other methods listed at FAR 13.106-3(a) (2).

8. Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:

See para 6, above. The VA has a number of technical experts who monitor local organizations that may be available to provide blood and blood products.

9. Any Other Facts Supporting the Use of Other than Full and Open Competition:

Not applicable. When multi-year replacement contract is awarded, the end result will most likely be the same. Only Blood Centers of the Pacific has the capability to provide blood and blood products to meet the needs of the VA in San Francisco.

10. Listing of Sources that Expressed, in Writing, an Interest in the Acquisition:
