Start going toward the Airport Exit on Aolele St - go 0.2 mi. Turn right on Nimitz Hwy[HI-92] - go 1.4 mi. Turn left on Puuloa Rd - go 1.1 mi. Puuloa Rd becomes Jarrett White Rd - go 1.0 mi. You will see the guard shack and entrance gate to Tripler Medical Center. Provide Identification and inform the guard of your visit.

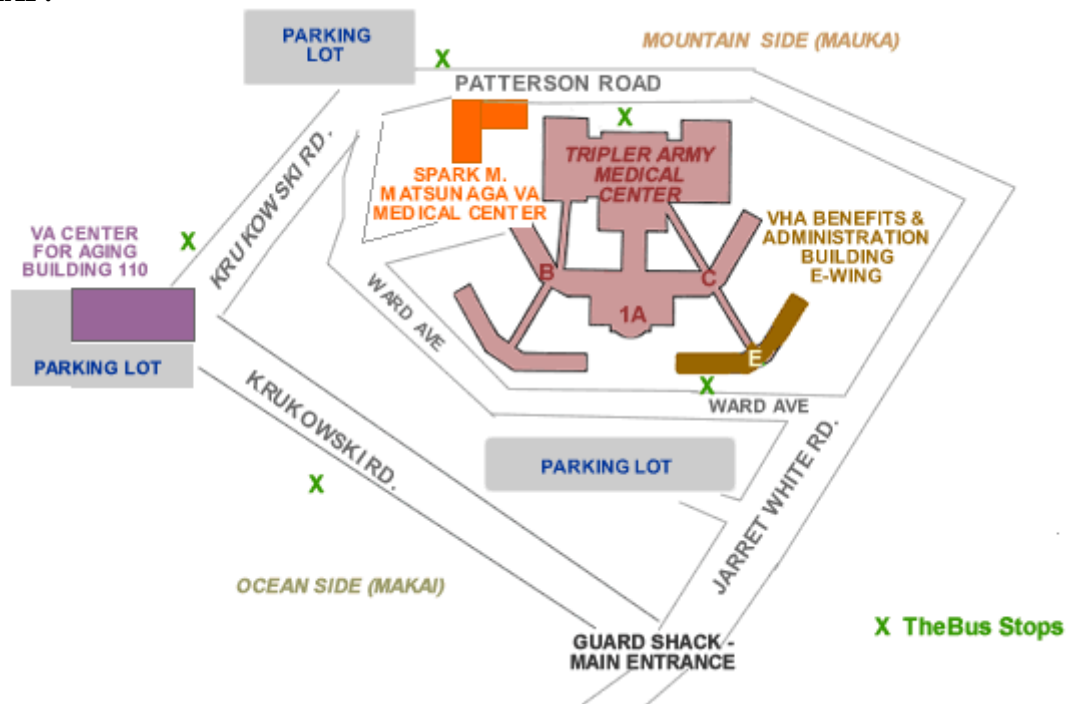
#### **From Waikiki & East Oahu**

Take the Interstate H1 W and keep left to take Interstate H201 W / HI-78 W via Exit 19B toward Fort Shafter / Aiea. Take the Puuloa Rd. / HI-7310 exit- Exit 3- toward Tripler Hosp. Turn right onto Jarrett White Rd / HI-7310 N. Provide Identification and inform the guard of your visit.

#### **From Aiea & West Oahu**

Get on the the Interstate H1 E and merge onto Interstate H201 E / HI-78 E via Exit 13A toward Honolulu and take the HI-7310 N exit- Exit 3- toward Tripler Hospital / Paa St. Turn left onto Puuloa Rd / HI-7310 N. Continue to follow HI-7310 N. Provide Identification and inform the guard of your visit.

## FACILITY MAP:



**LOCATION DETAILS:** When entering the TAMC Campus, proceed straight ahead past the Guard's Shack, onto Jarrett White Road. Stay in the far left-hand lane, which will eventually end, make a left-hand turn onto Ward Road. Ward Road runs along the front area of TAMC Campus, which is referred to as "Ocean Side"; E-Wing will be the first wing encountered.

**ACCESS & PARKING:** The Tripler Army Medical Center (TAMC) Campus is a Department of Defense (DoD) Federal Installation. Please note, that you must provide a valid Driver's License, Vehicle Insurance and Registration upon entering the facility. If you do not have proper identification, access may be denied. You may be required to obtain a Visitor's Pass to further gain entry. Parking will not be reserved and is on a first come- first serve basis. Parking is positioned all along in front of the Ocean Side of the TAMC Campus. There are several levels, which can become filled quickly in the earlier part of the morning.

**DESIGNATED MEETING AREA:** A security guard and waiting lobby is conveniently located in on the first (1<sup>st</sup>) floor of E-Wing. Please sign in with the security guard; you may have to provide valid ID when signing-in. At 10:00 AM HST, we will promptly announce the Site Visit session to begin.

**PLEASE NOTE:** Please allow enough of time to obtain proper access onto TAMC, find parking, and to locate the designated meeting area. Please make plans for early arrival to map out all appropriate directions prior to the scheduled Site Visit, as I may not be readily available 1-2 hours prior to the start of the Site Visit. If you are visiting from another Pacific Region and/or Island, United States Mainland, and/or any other territories outside of the Hawaii Island of Oahu, please feel free to contact the Contracting Officer, Nicole H. Dorsey, prior to your arrival.
