All systems described are core to the safe operation of the facility and give a reasonable standard of care to the patients. The Jesse Brown facility has elected to put the entire campus on the same CCTV system for ease of operation, maintenance, safety, etc. It would be impractical and compromise safety to use different systems at different locations throughout campus. Therefore, the most cost effective solution for expansions or upgrades to the system is to expand the existing ADVENT system.


All these systems and agreements were based on competitive bid awards meeting the VA standards




