B. ITEM II: State the amount for all work in the BASE BID less deductions under ALTERNATE BID NO. 1.

C. ITEM III: State the amount for all work in the BASE BID less deductions under ALTERNATE BID NO.s 1 and 2.

D. ITEM IV: State the amount for all work in the BASE BID less deductions under ALTERNATE BID NO.s 1, 2 and 3.

E. ITEM V: State the amount for all work in the BASE BID less deductions under ALTERNATE BID NO.s 1, 2, 3 and 4.

F. ITEM VI: State the amount for all work in the BASE BID less deductions under ALTERNATE BID NO.s 1, 2, 3, 4 and 5.

G. ITEM VII: State the amount for all work in the BASE BID less deductions under ALTERNATE BID NO.s 1, 2, 3, 4, 5 and 6.

4. ALTERNATE BIDS:

1. DEDUCT ALTERNATE BID NO. 1: DELETE Exam Room Nurse Call equipment shown in Gold Clinic, Blue Clinic, Red Clinic, Outpatient Clinic and Specialty Green Clinic. Procedure Room devices, restroom devices and other equipment shown to remain.

2. DEDUCT ALTERNATE BID NO. 2: Provide 4-button staff stations in Community Living Center (CLC) Resident Rooms in lieu of touchscreen terminals.

3. DEDUCT ALTERNATE BID NO. 3: Provide 4-button staff stations in Inpatient 3A and Inpatient 3B in lieu of touchscreen terminals in all Patient and Procedure Rooms.

4. DEDUCT ALTERNATE BID NO. 4: DELETE remaining Nurse Call devices in First Floor Outpatient Clinic.

5. DEDUCT ALTERNATE BID NO. 5: DELETE Nurse Call devices in South Wing of Community Living Center (CLC).

6. DEDUCT ALTERNATE BID NO. 6: DELETE wireless telephone handsets and wireless Nurse Call middleware.
