2. **Nature and/or Description of the Action Being Processed:**

This is a request to purchase a direct patient care equipment item using unusual and compelling urgency procurement procedures in accordance with FAR Part 13.106-1(b)(1)(i) for a contrast media injector for the Robert J Dole VAMC in Wichita, KS. This action is to approve a Purchase Order (PO) in accordance with the aforementioned procedures. The current LF Angiomat injector has failed and there is no backup equipment. The approval request is being processed in accordance with VHA Procurement Manual Chapter VI: Other Than Full and Open Competition (OFOC) policy.

3. **Description of Supplies/Services Required to Meet the Agency's Needs:**

Purchase request/2237 #: 589-14-2-4805-0018.
Quantity 1 each, Bayer Healthcare LLC, Medrad® Mark 7 Arterion™ Contrast Injector w/ a heat maintainer syringe, installation and manuals. The estimated cost is \$ [REDACTED]

Estimated date of delivery is February 21, 2014 based on issuance of a PO on February 14, 2014. Bayer Healthcare will be using expedited transportation to deliver this equipment.

5. **Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority):**


The existing equipment was in use in the standard operating room has reached end of life and is no longer in use. The equipment failed to function during a surgical case. Parts for maintenance and repair of existing equipment are outdated and no longer available. There is no other equipment in

the facility that can be used in place of existing equipment. All cases requiring this equipment have been put on hold or will be outsourced.

6. Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:

Due to the urgent nature of this requirement, no efforts were made beyond contacting Medrad/Bayer Healthcare.

7. Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable:

The Contracting Officer anticipates the cost to the Government will be fair and reasonable based on comparison to previous prices paid for similar devices for facilities within VISN 15. VA255-13-P-0647, 

8. Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:

A search was completed online and through the other departments with contrast injectors by the requesting service. No small business concerns were identified. The urgency of this requirement did not facilitate any further research possibilities.

9. Any Other Facts Supporting the Use of Other than Full and Open Competition:

With the current equipment not functioning, the VAMC is unable to schedule patients. Procuring the equipment from the same manufacturer of other department contrast injectors, staff are very familiar with the equipment which will result in less delay in resuming procedures. The failed equipment is not cost effective to repair. Parts are outdated and unavailable.
