### Replace Roofing Bldg. 6 (Denver)

1. This project specifies Davis-Bacon wages as 'Building' rates which does not specify roofers or roofing laborers. At this time I would request a determination for these disciplines as they are not listed.

This group can be classified as “laborers.”

2. In Specs, Section 01 00 00 General Requirements, Letter B states: “Visits to the site by Bidders may be made by appointment with the Medical Center Engineering Officer.” Will you please provide his/hers name and contact number?

Per the solicitation a pre-bid site visit was already held on 6/12/14. That statement should had been deleted, and is not relevant.
