B.2 STATEMENT OF OBJECTIVE

1. Overview

The VA Palo Alto Health Care System's (VAPAHCS) is constructing a new Polytrauma and Blind Rehabilitation Center (PTBRC) to be located in Palo Alto, CA. The PTBRC will be a multidisciplinary building on the Palo Alto Division campus of the VA Palo Alto Health Care System. The new Rehabilitation Center will consolidate outpatient and inpatient rehabilitation programs, including Polytrauma, Blind Rehabilitation, Physical Medicine Rehab (PM&R), and Physical & Occupational Therapy departments. When completed, this 174,000 square foot, 3-story building will be the largest multi-discipline rehabilitation center in the Department of Veterans Affairs. This project is expected to be complete and open for patients in the fall of 2015.

2. Objective

- a. **Obtain installation of a wheelchair-accessible clinical driving simulator (DriveSafety CDS-250 or "equal to")** which is a non-immersive driving simulation system optimized for use in clinical settings. It is designed as a clinical tool for occupational and physical therapy, as well as driver rehabilitation and driving and related skills performance measurements to be utilized in the new PTBRC.

Features shall include (see salient characteristics for more details):

- Authentic automotive controls environment,
- Three channel real-time visual simulation
- High quality audio
- Vection™ or "equal to" run-time simulation software

3. Installation

Equipment shall be installed at PTBRC during normal business hours (Monday-Friday). Final installation schedule is dependent upon the construction schedule and may be adjusted. Currently all equipment shall be installed no sooner than (NST) May 4th, 2015 and no later than (NLT) May 29th, 2015. At least fourteen (14) calendar day notice of installation is required to the Contracting Officer (CO) and must be coordinated with Activation Integration Project Team (IPT). At the installation, the Contractor shall provide all operating manuals to the Activation IPT.

4. On-site Training after installation

Activation schedule is dependent upon the construction schedule and may be adjusted. Initial on-site training is expected in the summer/fall of 2015; on or about August 3rd, 2015 to October 30th, 2015.

5. Site conditions, Identification, Parking, Smoking, Cellular Phone Usage and VA regulations

- a. The Contractor shall follow all campus safety, rules and regulations; including safety and security requirements, unless otherwise directed by the activation IPT and/or Contracting Officer (CO).
- b. The Contractor shall perform an on-site inspection with the activation IPT and/or CO to verify existing site conditions. The Contractor shall assess, evaluate and confirm existing site conditions prior to delivery/installation. The Contractor shall provide the activation IPT and/or CO a written notice of pre-existing damages.
- c. The Contractor shall coordinate with the activation IPT and/or CO to identify staging areas prior to delivering/installing simulator.
- d. The Contractor shall prepare the site for delivery, assembly, and installation prior to installing the simulator. Site preparation includes implementing proper protective measures; such as protective runners, pads, etc. to protect the site and building (elevators, walls, stairs, floors, etc.). The Contractor shall be liable for damage to the work site caused by the Contractor (accidentally or purposefully).
- e. The Contractor shall be responsible for installing the simulator in accordance with all local, state and federal requirements and regulations including, but not limited to, seismic standards in accordance with California Administrative Code Title 24, Part 2, Section 2-2312.
- a. Contractor delivery and installation personnel shall maintain a professional appearance while visiting the Palo Alto Division (PAD) campus and shall wear visible identification and VA's visitor badge at all times while on the premises of the VAPAHCS.
- f. The Contractor shall keep the work site clean and remove all trash and debris from the work site daily, including staging areas used by the Contractor.
- b. On-Site parking is limited and available for VA patients and designated employees. On-Site parking may not be available for Contractor employees or subcontractors. The Contractor agrees to arrange parking for employees and subcontractors during on-site installation activities. The VAPAHCS will not invalidate or make reimbursement for parking violations of the Contractor under any conditions.
- c. The COR may request the removal of any Contractor employee without cause if the Government suspects the employee of violating this condition

- d. The Contractor shall abide by a zero tolerance policy for drugs and alcohol. Smoking shall only be in designated areas. The activation IPT and/or CO may request the removal of any Contractor employee without cause if the Government suspects the employee of violating this condition.
- e. Cellular phones and two-way radios are not to be used within six feet of any medical equipment.
- f. Possession of weapons is prohibited on all VA campuses. Enclosed containers, including tool kits, shall be subject to search.
- g. Violations of VA regulations may result in a citation answerable in the United States (Federal) District Court, not a local district state, or municipal court.

B.3 SALIENT CHARACTERISTICS

a. DriveSafety CDS-250W Wheelchair-accessible Clinical Driving Simulator or Equal

1. General

The DriveSafety CDS-250W is a compact, non-immersive driving simulation system optimized for use in clinical settings. It is designed as a clinical tool for occupational and physical therapy, as well as driver rehabilitation and driving and related skills performance measurement.

2. Warranty

- a. Manufacturer warrants its products to be free from defects in materials and workmanship for a period of 1 year from the date of acceptance.
- b. 3 year technical support & software maintenance includes annual on-site service visit, system software updates and SimClinic™ scenario updates.

3. Simulation System, Services and Support

- a. Wheelchair-accessible Clinical Driving Simulator with removable driver seat platform and controls console electric lift for different height wheelchairs. Includes authentic automotive controls environment, three channel realtime visual simulation and high quality audio. Includes transfer frame and 4-in-1 interchangeable hand controls set from SureGrip and spinner knob.
- b. Run-time simulation software.
- c. Standard Library – package of nineteen interactive driving scenarios and exercises,
 1. Nineteen (19) interactive driving scenarios and exercises
 - a) Includes: Nine (9) adaptation and instruction scenarios, one (1) brake reaction timer, one (1) steering reaction timer, five (5) naturalistic scenarios, and three (3) escalating hazard scenarios
- d. On-site installation & travel.
- e. Shipping/handling.
- f. Initial Onsite Training.

4. Expansion Module Options

- a. **Learning Basic Controls** – Introduces clients to the movements and modulation of basic vehicle controls. Effective clinical introduction for patient use of adaptive equipment and for basic skills training for inexperienced drivers. Includes GasAndBrake(3), Steering(3), SpeedControl(3), PedalsChase(2), SteeringChase(3) and LaneChangeAndBrake.
- b. **Interactive Exercises** – Visual scanning, divided attention, working memory, information processing, coordinated movements, anticipation and planning, etc. Includes FunctionalObjectDetection(4), CopyCat, Slider(3), and StopLightAndSteering(3).
- c. **Advanced Functional Object Detection** – Clinical exercise that combines basic driving tasks with divided attention and visual scanning. The driver taps his/her brake when the lead vehicle's brake light is illuminated. The driver's speed can be configured by the therapist to use either the gas pedal or the cruise control to different pre-set speeds. The driver searches the visual field for targets which are configurable by the therapist: pop-in or fade-in, number of targets, location of the targets, duration of presentation, number of presentations, & orientation of the target (left, right, up, down). Additional tasks are also available including: numbers in the mirrors after the depression of the brake pedal & letters presented in a display above the lead vehicle. The driver can either steer the vehicle or the therapist can use an autosteer (which locks the vehicle into the middle of the lane). The therapists can choose to use 1 or 2 steering wheel input buttons.

5. Simulator Cab

- a. Cab provides a high-quality, authentic automotive control environment based on a midsize Ford Focus passenger car.
- b. Standard driver controls and information systems.

- c. Live steering wheel with active force feedback, automatic transmission gear select, turn signals, analogue speedometer, gas and brake pedals, driver response input buttons and vent fan control.
- d. Deluxe driver seat with wide range of adjustment is standard, as is a functional seatbelt.
- e. Driver seat platform is removable to allow wheelchair access to controls console, which is electrically height adjustable for different sized wheelchairs.
- f. Digital audio simulation of the sounds of driving with Bose powered subwoofer and stereo speakers.
- g. Car stereo with a /CD/MP3 player.

6. **Cab Size**

- a. Compact design allows it to be placed into small clinics or medical offices with ease, even through standard single-width 36" access doors.
- b. Width: 36" access doors
- c. The system is nominally 7.75 feet (2.36 meters) long by 4 feet (1.22 meters) wide

7. **Power Requirements**

- a. 120 Volt 20-Amp wall plug.
- b. Line conditioner provided for clean power from wall plug.

8. **Display System**

- a. Configured with three, 19 inch LCD flat-panel displays subtending ~70 horizontal degrees.
- b. Usable virtual field of view (FOV) rendered is 110 horizontal degrees.

9. **Computational Systems and Software**

- a. Real-time driving and traffic simulation is provided by software from manufacture..
- b. Host computer is a real-time Linux-based system which runs the simulation's vehicle dynamics, cab instrumentation I/O processing, scenario control, and data collection.
- c. Host also controls the 3 graphics channel computers running high performance graphics accelerators responsible for the scene rendering.

10. **Applications**

- a. Standard Library of adaptation and training driving scenarios designed to assist therapists getting participants comfortable and effective operating the simulator in a variety of driving tasks.

PART II - CONTRACT CLAUSES

SECTION I - CONTRACT CLAUSES

I.1 52.212-4 CONTRACT TERMS AND CONDITIONS—COMMERCIAL ITEMS (MAY 2014)

(a) Inspection/Acceptance. The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. If repair/replacement or reperformance will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies or services. The Government must exercise its post-acceptance rights—

- (1) Within a reasonable time after the defect was discovered or should have been discovered; and
- (2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) Assignment. The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). However, when a third party makes payment (e.g., use of the Government wide commercial purchase card), the Contractor may not assign its rights to receive payment under this contract.

(c) Changes. Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) Disputes. This contract is subject to 41 U.S.C. chapter 71, Contract Disputes. Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising under or relating to this contract shall be a dispute to be resolved in accordance with the clause at FAR 52.233-1, Disputes, which is incorporated herein by reference. The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(e) Definitions. The clause at FAR 52.202-1, Definitions, is incorporated herein by reference.

(f) Excusable delays. The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence such as, acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(g) Invoice.

- (1) The Contractor shall submit an original invoice and three copies (or electronic invoice, if authorized) to the address designated in the contract to receive invoices. An invoice must include—
- (i) Name and address of the Contractor;
 - (ii) Invoice date and number;
 - (iii) Contract number, contract line item number and, if applicable, the order number;
 - (iv) Description, quantity, unit of measure, unit price and extended price of the items delivered;
 - (v) Shipping number and date of shipment, including the bill of lading number and weight of shipment if shipped on Government bill of lading;
 - (vi) Terms of any discount for prompt payment offered;

- (vii) Name and address of official to whom payment is to be sent;
- (viii) Name, title, and phone number of person to notify in event of defective invoice; and
- (ix) Taxpayer Identification Number (TIN). The Contractor shall include its TIN on the invoice only if required elsewhere in this contract.
- (x) Electronic funds transfer (EFT) banking information.
 - (A) The Contractor shall include EFT banking information on the invoice only if required elsewhere in this contract.
 - (B) If EFT banking information is not required to be on the invoice, in order for the invoice to be a proper invoice, the Contractor shall have submitted correct EFT banking information in accordance with the applicable solicitation provision, contract clause (e.g., 52.232-33, Payment by Electronic Funds Transfer—System for Award Management, or 52.232-34, Payment by Electronic Funds Transfer—Other Than System for Award Management), or applicable agency procedures.
 - (C) EFT banking information is not required if the Government waived the requirement to pay by EFT.
- (2) Invoices will be handled in accordance with the Prompt Payment Act (31 U.S.C. 3903) and Office of Management and Budget (OMB) prompt payment regulations at 5 CFR part 1315.

(h) Patent indemnity. The Contractor shall indemnify the Government and its officers, employees and agents against liability, including costs, for actual or alleged direct or contributory infringement of, or inducement to infringe, any United States or foreign patent, trademark or copyright, arising out of the performance of this contract, provided the Contractor is reasonably notified of such claims and proceedings.

(i) Payment.—

- (1) *Items accepted.* Payment shall be made for items accepted by the Government that have been delivered to the delivery destinations set forth in this contract.
- (2) *Prompt payment.* The Government will make payment in accordance with the Prompt Payment Act (31 U.S.C. 3903) and prompt payment regulations at 5 CFR part 1315.
- (3) *Electronic Funds Transfer (EFT).* If the Government makes payment by EFT, see 52.212-5(b) for the appropriate EFT clause.
- (4) *Discount.* In connection with any discount offered for early payment, time shall be computed from the date of the invoice. For the purpose of computing the discount earned, payment shall be considered to have been made on the date which appears on the payment check or the specified payment date if an electronic funds transfer payment is made.
- (5) *Overpayments.* If the Contractor becomes aware of a duplicate contract financing or invoice payment or that the Government has otherwise overpaid on a contract financing or invoice payment, the Contractor shall—
 - (i) Remit the overpayment amount to the payment office cited in the contract along with a description of the overpayment including the—
 - (A) Circumstances of the overpayment (e.g., duplicate payment, erroneous payment, liquidation errors, date(s) of overpayment);
 - (B) Affected contract number and delivery order number, if applicable;
 - (C) Affected contract line item or subline item, if applicable; and
 - (D) Contractor point of contact.
 - (ii) Provide a copy of the remittance and supporting documentation to the Contracting Officer.
- (6) *Interest.*
 - (i) All amounts that become payable by the Contractor to the Government under this contract shall bear simple interest from the date due until paid unless paid within 30 days of becoming due. The interest rate shall be the interest rate established by the Secretary of the Treasury as provided in 41 U.S.C. 7109, which is applicable to the period in which the amount becomes due, as provided in (i)(6)(v) of this clause, and then at the rate applicable for each six-month period as fixed by the Secretary until the amount is paid.
 - (ii) The Government may issue a demand for payment to the Contractor upon finding a debt is due under the contract.
 - (iii) *Final decisions.* The Contracting Officer will issue a final decision as required by 33.211 if—

- (A) The Contracting Officer and the Contractor are unable to reach agreement on the existence or amount of a debt within 30 days;
 - (B) The Contractor fails to liquidate a debt previously demanded by the Contracting Officer within the timeline specified in the demand for payment unless the amounts were not repaid because the Contractor has requested an installment payment agreement; or
 - (C) The Contractor requests a deferment of collection on a debt previously demanded by the Contracting Officer (see 32.607-2).
- (iv) If a demand for payment was previously issued for the debt, the demand for payment included in the final decision shall identify the same due date as the original demand for payment.
- (v) Amounts shall be due at the earliest of the following dates:
- (A) The date fixed under this contract.
 - (B) The date of the first written demand for payment, including any demand for payment resulting from a default termination.
- (vi) The interest charge shall be computed for the actual number of calendar days involved beginning on the due date and ending on—
- (A) The date on which the designated office receives payment from the Contractor;
 - (B) The date of issuance of a Government check to the Contractor from which an amount otherwise payable has been withheld as a credit against the contract debt; or
 - (C) The date on which an amount withheld and applied to the contract debt would otherwise have become payable to the Contractor.
- (vii) The interest charge made under this clause may be reduced under the procedures prescribed in 32.608-2 of the Federal Acquisition Regulation in effect on the date of this contract.

(j) Risk of loss. Unless the contract specifically provides otherwise, risk of loss or damage to the supplies provided under this contract shall remain with the Contractor until, and shall pass to the Government upon:

- (1) Delivery of the supplies to a carrier, if transportation is f.o.b. origin; or
- (2) Delivery of the supplies to the Government at the destination specified in the contract, if transportation is f.o.b. destination.

(k) Taxes. The contract price includes all applicable Federal, State, and local taxes and duties.

(l) Termination for the Government's convenience. The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges the Contractor can demonstrate to the satisfaction of the Government using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred which reasonably could have been avoided.

(m) Termination for cause. The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(n) Title. Unless specified elsewhere in this contract, title to items furnished under this contract shall pass to the Government upon acceptance, regardless of when or where the Government takes physical possession.

(o) Warranty. The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

(p) Limitation of liability. Except as otherwise provided by an express warranty, the Contractor will not be liable to the Government for consequential damages resulting from any defect or deficiencies in accepted items.

(q) Other compliances. The Contractor shall comply with all applicable Federal, State and local laws, executive orders, rules and regulations applicable to its performance under this contract.

(r) Compliance with laws unique to Government contracts. The Contractor agrees to comply with 31 U.S.C. 1352 relating to limitations on the use of appropriated funds to influence certain Federal contracts; 18 U.S.C. 431 relating to officials not to benefit; 40 U.S.C. chapter 37, Contract Work Hours and Safety Standards; 41 U.S.C. chapter 87, Kickbacks; 41 U.S.C. 4712 and 10 U.S.C. 2409 relating to whistleblower protections; 49 U.S.C. 40118, Fly American; and 41 U.S.C. chapter 21 relating to procurement integrity.

(s) Order of precedence. Any inconsistencies in this solicitation or contract shall be resolved by giving precedence in the following order:

- (1) The schedule of supplies/services.
- (2) The Assignments, Disputes, Payments, Invoice, Other Compliances, Compliance with Laws Unique to Government Contracts, and Unauthorized Obligations paragraphs of this clause;
- (3) The clause at 52.212-5.
- (4) Addenda to this solicitation or contract, including any license agreements for computer software.
- (5) Solicitation provisions if this is a solicitation.
- (6) Other paragraphs of this clause.
- (7) The Standard Form 1449.
- (8) Other documents, exhibits, and attachments
- (9) The specification

(t) System for Award Management (SAM).

(1) Unless exempted by an addendum to this contract, the Contractor is responsible during performance and through final payment of any contract for the accuracy and completeness of the data within the SAM database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the SAM database after the initial registration, the Contractor is required to review and update on an annual basis from the date of initial registration or subsequent updates its information in the SAM database to ensure it is current, accurate and complete. Updating information in the SAM does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(2)(i) If a Contractor has legally changed its business name, "doing business as" name, or division name (whichever is shown on the contract), or has transferred the assets used in performing the contract, but has not completed the necessary requirements regarding novation and change-of-name agreements in FAR subpart 42.12, the Contractor shall provide the responsible Contracting Officer a minimum of one business day's written notification of its intention to (A) change the name in the SAM database; (B) comply with the requirements of subpart 42.12; and (C) agree in writing to the timeline and procedures specified by the responsible Contracting Officer. The Contractor must provide with the notification sufficient documentation to support the legally changed name.

(ii) If the Contractor fails to comply with the requirements of paragraph (t)(2)(i) of this clause, or fails to perform the agreement at paragraph (t)(2)(i)(C) of this clause, and, in the absence of a properly executed novation or change-of-name agreement, the SAM information that shows the Contractor to be other than the Contractor indicated in the contract will

(i) Any such clause is unenforceable against the Government.

(ii) Neither the Government nor any Government authorized end user shall be deemed to have agreed to such clause by virtue of it appearing in the EULA, TOS, or similar legal instrument or agreement. If the EULA, TOS, or similar legal instrument or agreement is invoked through an "I agree" click box or other comparable mechanism (e.g., "click-wrap" or "browse-wrap" agreements), execution does not bind the Government or any Government authorized end user to such clause.

Bids offering "equal" products (including products of the brand name manufacturer other than the one described by brand name) will be considered for award if such products are clearly identified in the bids and are determined by the Government to meet fully the salient characteristics requirements listed in the invitation.

Accordingly, to insure that sufficient information is available, the bidder must furnish as a part of his/her bid all descriptive material (such as cuts, illustrations, drawings or other information) necessary for the purchasing activity to:

- (i) Determine whether the product offered meets the salient characteristics requirement of the Invitation for Bids, and
 - (ii) Establish exactly what the bidder proposes to furnish and what the Government would be binding itself to purchase by making an award. The information furnished may include specific references to information previously furnished or to information otherwise available to the purchasing activity.
- (2) If the bidder proposes to modify a product so as to make it conform to the requirements of the Invitation for Bids, he/she shall:

(3) Documents not available from ASSIST may be ordered from the Department of Defense Single Stock Point (DoDSSP) by?

(4) Nongovernment (voluntary) standards must be obtained from the organization responsible for their preparation, publication, or maintenance.

(j) *Data Universal Numbering System (DUNS) Number.* (Applies to all offers exceeding \$3,000, and offers of \$3,000 or less if the solicitation requires the Contractor to be registered in the System for Award Management (SAM) database. The offeror shall enter, in the block with its name and address on the cover page of its offer, the annotation "DUNS" or "DUNS +4" followed by the DUNS or DUNS +4 number that identifies the offeror's name and address. - (3) The overall ranking of all offerors, when any ranking was developed by the agency during source selection.
- (4) A summary of the rationale for award;
- (5) For acquisitions of commercial items, the make and model of the item to be delivered by the successful offeror.

(6) Reasonable responses to relevant questions posed by the debriefed offeror as to whether source-selection procedures set forth in the solicitation, applicable regulations, and other applicable authorities were followed by the agency.

ADDENDUM to FAR 52.212-1 INSTRUCTIONS TO OFFERORS—COMMERCIAL ITEMS

Provisions that are incorporated by reference (by Citation Number, Title, and Date), have the same force and effect as if they were given in full text. Upon request, the Contracting Officer will make their full text available.

The following provisions are incorporated into 52.212-1 as an addendum to this solicitation:

SECTION M - EVALUATION FACTORS FOR AWARD

M.1 52.212-2 EVALUATION—COMMERCIAL ITEMS (JAN 1999)

(a) The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate offers:

This is a brand name or equal procurement. The Government shall evaluate quotes based on the lowest priced, responsible, technically acceptable offer. The following factors shall be used to evaluate offers (listed in descending order of importance):

FACTOR 1: TECHNICAL - The Activation Integration Product Team (IPT) have put forth significant efforts into industry equipment for the new Polytrauma and Blind Rehabilitation Center (PTBRC). There is a strong preference to acquire the technically acceptable brand name equipment.

- a. Quotes offering "equal to" products (including products other than the one described by brand name) will be considered for award if such products are clearly identified in the responses and are determined by the Government to meet fully the all material respects to the products specified; including salient characteristics listed in the RFQ.
- b. Manufacturer consistency is imperative among identified furniture items. Offerors shall provide "all or nothing" quotes from like manufacturer. Quotes offering BOTH brand name, and "equal" items will receive an unfavorable rating.

FACTOR 2: PRICE: The total quote must be fair and reasonable to the Government based on comparison of the proposed prices to the government estimate and comparison of other quotes (market price).

EVALUATION: Technical factors are significantly more important when compared to Price. Price will be considered and evaluated in determining the overall best value to the Government. As the technical merits of the quotes become more equal, price may become the determining factor.

(b) *Options.* The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. The Government may determine that an offer is unacceptable if the option prices are significantly unbalanced. Evaluation of options shall not obligate the Government to exercise the option(s).

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

M.2 VAAR 852.215-70 SERVICE-DISABLED VETERAN-OWNED AND VETERAN-OWNED SMALL BUSINESS EVALUATION FACTORS (DEC 2009)

(a) In an effort to achieve socioeconomic small business goals, depending on the evaluation factors included in the solicitation, VA shall evaluate offerors based on their service-disabled veteran-owned or veteran-owned small business status and their proposed use of eligible service-disabled veteran-owned small businesses and veteran-owned small businesses as subcontractors.

(b) Eligible service-disabled veteran-owned offerors will receive full credit, and offerors qualifying as veteran-owned small businesses will receive partial credit for the Service-Disabled Veteran-Owned and Veteran-owned Small Business Status evaluation factor. To receive credit, an offeror must be registered and verified in Vendor Information Pages (VIP) database.

(c) Non-veteran offerors proposing to use service-disabled veteran-owned small businesses or veteran-owned small businesses as subcontractors will receive some consideration under this evaluation factor. Offerors must state in their proposals the names of the SDVOSBs and VOSBs with whom they intend to subcontract and provide a brief description of the proposed subcontracts and the approximate dollar values of the proposed subcontracts. In addition, the proposed subcontractors must be registered and verified in the VetBiz.gov VIP database (<http://www.vetbiz.gov>).
