Salient Characteristics

1) Essential/significant physical, functional, or performance characteristics.

The Aquamantys Bipolar Pump Generator is an electrosurgical generator with a rotary peristaltic pump which is for use only with Aquamantys single-use disposable bipolar devices for concurrent delivery of radiofrequency (RF) energy with saline for hemostatic sealing of soft tissue and bone at the operative site. It is intended for, but not limited to, endoscopic and open abdominal, orthopaedic, spine and thoracic surgery.

Aquamantys utilizes Transcollation Technology, a proprietary technology used in surgery. Our patented integration of RF energy and saline delivers controlled thermal energy to tissue. This combination allows the device temperature to stay at approximately 100°C - nearly 200°C less than conventional devices, which produces a tissue effect without the charring associated with other methods. The Aquamantys System, consisting of the Aquamantys pump generator (the "Generator") and the Aquamantys bipolar sealers (the "Disposables"), features transcollation technology. This technology integrates RF energy and saline in a controlled

relationship that permits haemostatic sealing and coagulation of soft tissue planes and bone. Transcollation technology allows tissue planes to be treated with a "painting" motion in addition to traditional spot sealing. The one (1) to two (2) millimeter depth of effect assures haemostatic sealing without the resultant charring typically associated with electrosurgery.

The ability to have a controlled depth of penetration allows surgeons to use the device to pre-seal tissue where they anticipate bleeding. Because the temperature of the sealed tissue stays at approximately 100 degrees C, the collagen seal is less likely to crack and re-bleed post operatively like the carbon char seal associated with standard electrosurgery. The Aquamantys does not get hot enough to dessicate tissue either, and because of the lower temperature the surgeon can be more proactive during surgery in controlling bleeding due to less thermal damage to target tissue. The result is better visibility during surgery, reduced OR time chasing bleeding, less blood loss, and a reduction in transfusion and use of other blood products.

(a) *Definitions.* As used in this clause—
