Statement of Work (SOW)

Replace Bottle Orientation Feeders at Dallas CMOP



Background:

There are seven Consolidated Mail Outpatient Pharmacy (CMOP) programs located across the United States. This Department of Veterans Affairs (VA) Program utilizes advanced automation to produce excess of 112 Million prescriptions a year or 85 Million packages for Veteran patients. For the purpose of and as used throughout this solicitation, and any resultant contract(s), the Consolidated Mail Outpatient Pharmacy will be defined as "CMOP." CMOP utilizes integrated, automated dispensing systems to be able to process high volume mail prescription workloads. The current bottle orientation feeders are highly mechanized, over 10-years old and a key choke point on the production line. They simply cannot keep up with production demands because they are outdated and due to their one-of-a-kind construction, are exceptionally difficult to maintain and repair. **CMOP Dallas currently utilizes four rotary bottle orientation feeders and intends to replace all four with three (3), state-of-the-art bottle orientation feeders and three (3) bottle printers. The bottle orientators feed directly into the bottle printers.** Only two of the orientation feeders will be utilized at any one time. The third orientation feeder will be used during peak production and at times when the other orientation feeders are offline for maintenance or repair. **This Request For Proposal (RFP) is for three (3) state-of-the-art orientation feeders and three (3) bottle printers (labelers).**

Site Visit

A site visit before final proposal submission is optional and will be held at the Dallas TX CMOP (address on SF 1449, First Page, block 15) upon request. The offeror is to contact the Contracting Officer, Candice Guice via email (Candice.Guice@va.gov) to request access and a visit will be coordinated with local CMOP personnel for the requested date. The offeror may take notes, measurements, and pictures of the area and equipment to be replaced during the site visit. Questions may be asked, however all questions will be answered via a FBO amendment to the solicitation. **Questions are due to the contracting officer by June 12, 2014 2:00 p.m. CT. Answers will be posted as received, with final posting by June 13, 2014.**

1. Location:

1.1. The DALLAS-CMOP, located at 2962 S. Longhorn Drive, Lancaster, Texas 75134.

2. Applicable Standards:

2.1. National Electric codes. (NEC).

2.1.1. System meets all NEC Standards.

2.1.2. Installation meets all NEC Standards.

2.2. OSHA Requirements.

2.2.1. Lock Out/Tag Out requirements will be adhered to at all times by contractor personnel.

- 2.2.2. Orientation Feeder ambient noise levels shall not exceed 85 decibels within one (1) foot of any one Orientation Feeder with no more than two orientation feeder in operation simultaneously.
- 2.2.3. Orientation Feeder shall have all required OSHA warning labels.
- 2.2.4. Protective housing is required at all pinch points.

3. Objectives:

- 3.1. Offeror shall provide schematics that include locations and planned routing of necessary utilities needed. **Note: A site visit is not mandatory for this requirement but highly encouraged.**
 - 3.1.1. Schematics of planned routing of utilities will be turned in to the Contracting Officer (CO) no later than seven (7) days after contract award.
- 3.2 The Offeror shall utilize existing footprint for the new Orientation Feeder and Labeler systems.
 - 3.1.2. The new system shall be able to be maintained by CMOP maintenance staff with no more than 5% down time per day.
- 3.2. The new system shall **not** require re-routing of existing conveyor systems and shall feed a correctly orientated bottle directly into bottle labelers.
- 3.3. The new system shall be compatible with CMOP existing computer control system (QMSI) and emergency cutoff system.
- 3.4. System shall include at least one (1) emergency stop.
- 3.5. Each Orientation Feeder must be adjustable from 30 to **60** bottles per minute. Normal operating feed will be **30** bottles per minute.
- 3.6. The new system shall be compatible with the current compressed air system at the facility of 120 psi.
 - 3.6.1. The new system shall have a Manual Dump Valve or other device capable of releasing compressed air from the system if pressurized air is used.
- 3.7. The system shall contain a visual alert system utilizing flashing lights mounted at not less than four (4) feet above the bottle orientation system. Visual alerts as follows:
 - 3.7.1. Green – Normal operation, no failures
 - 3.7.2. Red – Bottle Feeder Jams, Orientation Feeder Jams and Empty Orientation Feeder
 - 3.7.3. Yellow – Low Orientation Feeder
- 3.8. The minimum service life of the system shall be 15 years at specified reliability based upon two 8- hour shifts per day, 5 days per week production.
- 3.9. **The new system will integrate a bottle orientation system which properly orientates the bottle prior to entering new bottle labelers.** Maximum improper orientation rate is 5% (five bottles for every 100 properly orientated).
- 3.10. The new system will employ a device for ensuring improperly orientated bottles are rejected **PRIOR** to entering the entering bottle labelers.
- 3.11. The system must be compatible with the existing system to include, but not limited to, the Operating System order management and inventory control software, Version 1, Think and Do control system version 5.7, and conveyor routing systems. Implementation of interface/integration software must be compatible with systems written using the MS Visual Studio 2008 development platform and provide real time data exchange.
- 3.12. This contract requires the Offeror to install and conduct on-site “go”, “no-go” operational testing on all installed machines.

- 3.13. The new system will require at least a 30 cu. ft. bottle hopper.
- 3.14. The new system will require a photo-optic conveyor discharge safety bottle back up switch which disables the machine in the event of a bottle back up.
- 3.15. The new system will require an automatic rate feeder meter to determine bottles per minute be orientated at any given time.
- 3.16. The new system(s) will be installed at 30-day intervals over a 90-day period with one new system being installed during each 30-day period.
- 3.17. Non-stainless steel system components will power-coated or plastic-coated.
- 3.18. Bottle delivery to new system pre-feeder to be provided by the government. See Photos:

**4. Offeror
Responsibilities:**

4.1 Offeror is encouraged to perform a pre-bid site visit, scheduled with the Contracting Officer, at the

Dallas, CMOP, 2962 S Longhorn Dr. Lancaster, TX 75134. This site visit is used to determine:

- 4.1.1. New system footprint requirements.
- 4.1.2. New system electrical requirements.
- 4.1.3. New system bottle feed into existing labelers requirements.
- 4.1.4. New system pneumatic (compressed air) requirements.
- 4.1.5. Other requirements as outlined by the Offeror.
- 4.2 Offeror shall provide schematics to include locations of necessary utilities needed such as electrical, compressed air as explained in Section 3.1 above.
- 4.3 Offeror shall provide a list of installation team members requiring Government access 30 days prior to install and provide management and quality control and quality assurance oversight of this team throughout the installation.
- 4.4 The Offeror, their personnel, and their sub-contractors shall be subject to the Federal laws, regulations, standards, and VA Directives and Handbooks regarding information and information system security as delineated in this contract.
 - 4.4.1 The winning Offeror must Enroll in the Veterans Administration (VA) Talent Management System and complete the "Contracting" course at <https://www.tms.va.gov/user/login>. This training must be completed prior to the start of work.
 - 4.4.2 The Offeror shall provide to the Contracting Officer and/or the COR a copy of the training certificates and certification of signing the Contractor Rules of Behavior for each applicable employee within one (1) week of the initiation of the contract and annually thereafter, as required.
- 4.5 Failure to complete the mandatory annual training and sign the Rules of Behavior within the timeframe required, is grounds for suspension or termination of all physical or electronic access privileges and removal from work on the contract until such time as the training and documents are complete.
- 4.6 Offeror shall provide initial on-site training, on the installed system, for operators, and supervisors.
- 4.7 Offeror shall provide on-site training, on the installed system, for maintenance personnel to include, standard preventive maintenance, routine adjustments to maintain proper operation, and adjustments needed in the event of a failure and emergency shutdown procedures.
- 4.8 Offeror shall provide system upgrade training if the system is updated during the Warranty period.
- 4.9 Offeror to remain on site during normal operating hours until product is accepted and at least two full shifts post acceptance. The individual(s) on site must be capable of troubleshooting and resolving any and all product issues.
- 4.10 Offeror shall provide the Government with their access needs to the Government building during non-production and production hours 30 days in advance.
- 4.11 Offeror to provide all scanners, readers, photo eyes or other input devices and accessories needed to control the Orientation Feeder(s).
- 4.12 Offeror to provide any additional computer servers, switches or any other devices needed to control or interface the Orientation Feeder (s) with the existing system.
- 4.13 The Offeror is responsible for removing and disposal of all replaced equipment following approval by the Contracting Officer (CO) and Contracting Officer Representative (COR).
- 4.14 The Offeror is responsible for removing and disposal of all crating and shipping materials used to transport the equipment to the Government.

5. Government Responsibility:

- 5.1. Assign Project Manager / Contracting Officer Representative (COR).
- 5.2. Provide power, compressed air, fiber network access points as needed by Offeror.
- 5.3. Provide storage space for parts and equipment one week prior to installation and during installation process, until acceptance has occurred. Offeror will be permitted no more than two weeks to remove excess property after acceptance.
- 5.4. Provide security access for installation staff that has undergone background checks.
- 5.5. Removal and disposition of old parts and equipment by Offeror to be reviewed by VA prior to disposition. VA will determine if Offeror will be permitted to claim removed parts, or if CMOP will retain them.

5.6. CMOP shall coordinate utility connections with building owner wherever necessary, and provide Offeror access to electrical power and compressed air and any other utilities needed as outlined in section 3.1 above.

5.7. Provide around the clock access to facility, if needed for installation, with at least a 24 hour advance notice by Offeror.

6. Delivery:

6.1 Utility Schematics will be turned in to the Contracting Officer (CO) no later than seven (7) days after contract award.

6.2. There will be a pre-installation meeting (Kickoff) to be attended by all necessary VA and Offeror Representatives. The purpose of this meeting will be to resolve any questions either party may have regarding the project. The meeting shall occur no later than 14 days after contract award.

6.3. DALLAS-CMOP will complete all required installations of necessary utilities.

6.4. All preliminary installation work shall be completed prior to actual installation of product to aid in reducing system downtime.

6.5. Installation shall be performed during non-production hours. Exceptions to that shall be approved by the Project Manager (PM) / Contracting Officer (CO) for each site. **Current Dallas normal operating time(s): 6:00 AM – 2:30 PM (Monday – Friday) and 4:00PM to 2:00AM (Monday - Thursday).**

6.6. Installation shall begin no later than 90-days after the Kickoff Meeting.

6.7. Offeror is to remain on site from completion of installation for at least two (2) days. The individuals on site must be capable of troubleshooting and resolving any deficiencies within the system.

6.8. Installation shall not exceed 48 hours at each site.

6.9. Final payment shall be made to the Offeror when approved by the CO but not before all “punch list” items are completed and signed off by the COR.

7. Documentation: (All documentation provided shall be in English.)

7.2. Schematics Mechanical and Electrical: Offeror shall provide two printed and one electronic copy of electrical and mechanical schematics in .pdf and AutoCAD format. Mechanical schematics should include an exploded view identifying all assemblies and sub-assemblies and individual component parts with identification numbers.

7.3. Parts list Original Equipment Manufacturer (OEM):

7.3.1. Offeror shall provide a full parts list including part name, part number and quantity.

7.3.2. Offeror will provide a recommended (OEM) spare parts list including source information and provide on hand spares for identified high failure components. (Note: Spare parts shall be in sufficient quantities capable of maintaining the machine on an annual basis).

7.4. Maintenance schedule:

7.4.1. Offeror shall provide two printed and one electronic copy in .pdf format of their recommended cleaning and preventative maintenance program.

7.4.2. Offeror shall provide two printed and one electronic copy in .pdf format each of Operator's Manual, Maintenance Manual, and Troubleshooting Guides.

8. Acceptance Criteria:

8.2. Validation of minimum feed rate of 30 bottles per minute per 8 hour shift per day. The validation will run for two (2) days. During one (1) two-hour period during acceptance, two of the three bottle orientation feeder must run at the maximum feed rate of 60 bottles per minute.

8.3. Five percent (5%) system downtime (non-scheduled) related to Offerors equipment for a period of no less than 30 consecutive days following system integration.

8.4. All required documentation requested by the SOW have been properly submitted and approved by the Contracting Officer (CO).

8.5. Orientation Feeder noise shall not exceed 85 decibels within one (1) foot of the machine with not more than two orientation feeder in operation simultaneously.

8.6. The new system shall have a capability of handling CMOP standard, non-capped prescription vials of 100 cc and 250 cc.

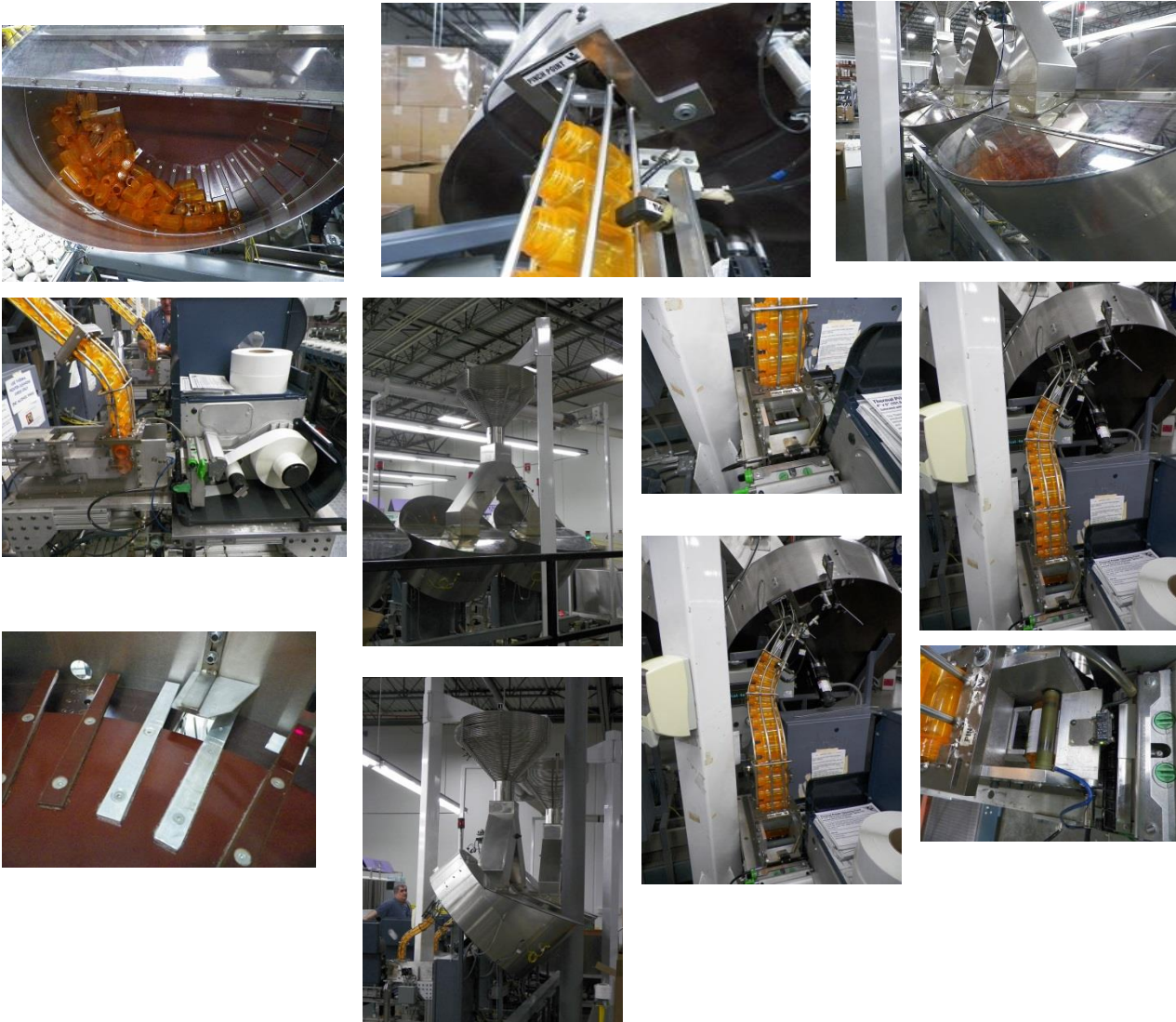
8.6.1. The speed of the belt must be adjustable and must have system output of a minimum 30 bottles per minute to a maximum of 60 bottles per minute for two hours.

- 8.6.2. System must demonstrate a sustainable feed rate of 30 bottles per minute for an entire 8-hour period.
- 8.6.3. System must have a no more than 5% downtime per day. **Based on an 8-hour period this equates to 24 minutes of total downtime per 8-hour shift.**
- 8.6.4. System demonstrates 95% accuracy of proper bottle orientation prior to entering printer chute.
- 8.6.5. System demonstrates 5% improper orientation rate (five bottles for every 100 properly orientated).
- 8.6.6. System demonstrates that improperly orientated bottles are rejected PRIOR to entering the labeling chute.
- 8.7. Successful Orientation Feeder installation shall also include but not be limited to:
 - 8.7.1. Verified and documented end-user competency through training is accomplished through Offeror provided on-site training.
 - 8.7.2. End-users are defined as government identified personnel, to include operation and routine maintenance personnel.
 - 8.7.3. Installed system performs at or above the Standards, Specifications, and Requirements within the 30-60 Bottles per minute requirement.
- 8.8. All items on the "Punch List" have been addressed and properly brought to closure.
- 8.9. System successfully passes Quality Assurance Test which consists of system meeting requirements outlined in paragraph 8 (Acceptance Criteria) for two consecutive 8-hour periods.

9. Warranty:

- 9.2. The Offeror shall provide warranty repair (parts and labor) and adjustments, at no additional cost to the VA, for the first year. The one year start date of the one year warranty will begin after receipt of final payment.
- 9.3. All parts to include routine maintenance items, as outlined in the Offeror provided maintenance schedule shall be available from the Offeror or commercially for a period of not less than five years after system acceptance.
- 9.4. If at any time during the five year period a part becomes obsolete and/or unavailable and subsequently needs replacement within the system, the Offeror shall upgrade or otherwise modify the installed system at Offerors expense.
- 9.5. Availability of a maintenance agreement for support, repair, and calibration after the initial one year warranty, with a cost breakdown for each additional year's coverage for a total of five years.
- 9.6. Customer Service Help Desk free of charge available 24 hours a day 7 days a week for hardware and software related problems during the warranty period. After the warranty period has expired Help Desk Support will respond within 2 hours of the initial call to the service.
- 9.7. During the warranty period Service Technicians must be onsite for repairs no later than 48 hours after initial call to Customer Service.

E.1 52.212-2 EVALUATION—COMMERCIAL ITEMS (JAN 1999)

(a) The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate offers:

Technical and past performance, when combined, are equal to price .

(b) *Options.* The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. The Government may determine that an offer is unacceptable if the option prices are significantly unbalanced. Evaluation of options shall not obligate the Government to exercise the option(s).

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

"Restricted business operations" means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. (ii) Certifies that the offeror, or any person owned or controlled by the offeror, does not engage in any activities for which sanctions may be imposed under section 5 of the Iran Sanctions Act; and

(iii) Certifies that the offeror, and any person owned or controlled by the offeror, does not knowingly engage in any transaction that exceeds \$3,000 with Iran's Revolutionary Guard Corps or any of its officials, agents, or affiliates, the property and interests in property of which are blocked pursuant to the International Emergency Economic Powers Act

(50 U.S.C. 1701 *et seq.*) (see OFAC's Specially Designated Nationals and Blocked Persons List at <http://www.treasury.gov/ofac/downloads/t11sdn.pdf>).

(3) The representation and certification requirements of paragraph (o)(2) of this provision do not apply if—

(i) This solicitation includes a trade agreements certification (*e.g.*, 52.212–3(g) or a comparable agency provision); and

(ii) The offeror has certified that all the offered products to be supplied are designated country end products.

E.3 52.216-1 TYPE OF CONTRACT (APR 1984)

The Government contemplates award of a Firm-Fixed-Price contract resulting from this solicitation.

E.4 52.217-5 EVALUATION OF OPTIONS (JUL 1990)

Except when it is determined in accordance with FAR 17.206(b) not to be in the Government's best interests, the Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. Evaluation of options will not obligate the Government to exercise the option(s).
