

**SPECIAL NOTICE**  
**GUARANTEE PERIOD SERVICES**

- A. Offerors are advised that this solicitation and any resulting contract contain Guarantee Period Services. The specifics of these services are listed in specification **SECTION 48 20 10**.
- B. A Service Contract Act Wage Determination has been included in the solicitation. Payment for employees performing work under that portion of any resulting contract shall be in accordance with the wage determination and/or any amendments thereto.
- C. Upon award of a contract, the contractor will be required to submit a schedule of costs/values with a cost breakdown of the branches of work. This breakdown will include a line item cost for the Guarantee Period Services portion of the contract for each system. The cost must state both the yearly total and the monthly total cost for the services. The cost must accurately reflect the current market rate for these services and must be approved by the Contracting Officer prior to the first progress payment being made.
- D. The original installer of the equipment shall be required to provide the Guarantee Period Service.
- E. Performance and Payment Bonds will be required in the amount of 100% of the contract price upon acceptance. The bonds must include coverage for the Guarantee Period Services portion of the contract. Upon completion of the actual construction, the value of the bonds will be adjusted downward for this portion of the contract, but must maintain enough bonding to cover this portion of the contract through the full ONE (1) year of service, following complete acceptance of the entire project.
- F. Requests for payment for the Guarantee Period Services are to be in the form of a certified invoice and may be invoiced monthly or quarterly in arrears. Payments will be made upon receipt and certification of the invoice in accordance with the appropriate payment clause.
- G. The contract will not be closed out until ALL Guarantee Period Services required have been provided. Please take note that the performance period (completion time) for the construction portion of the contract is 540 calendar days after receipt of notice to proceed.
- H. The term of the Guarantee Period Services commences “after completion and acceptance of the Combined Heat and Power project.”

The Government agrees to pay the Contractor \$ \_\_\_\_\_ [*state the total amount withheld for payment of the guarantee period services*] for guarantee period services to be performed during the maintenance schedule. Payment will be made in arrears pursuant to the schedule noted below or in the contract, upon satisfactory performance and presentation of a properly executed invoice. Post contract guarantee period services shall commence upon acceptance of the installation of the warranted equipment by the Government as set forth in the contract.
