


1. **Contracting Activity:** Department of Veterans Affairs, VISN 04, James E Van Zandt VA Medical Center justification for other than full and open competition to PRISM MEDICAL HOSPITAL GROUP.
2. **Nature and/or Description of the Action Being Processed:** Expand existing patient lift overhead track system in Rehab to service the treadmill. Load test and recertify both new and existing installation to 125% of design capacity. (1.25 x 625 lbs. = 782 lbs. *minimum*.)
3. **Description of Supplies/Services Required to Meet the Agency's Needs:** This is not a new installation. The existing Patient Lift installed by Prism needs to be modified per the above. Only Prism can tie into their existing equipment and re-certify.
4. **Statutory Authority Permitting Other than Full and Open Competition:**
  - (X) (1) Only One Responsible Source and No Other Supplies or Services Will Satisfy Agency Requirements per FAR 6.302-1;

5. **Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority):** No other Lift installer would be willing to re-certify existing equipment they did not install. They would bid on ripping out the old system and installing their own product. This would be a waste of taxpayer money, and would result in VA having to arrange inspections of two different vendors.
6. **Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:** None to date.....It is not advisable to "mix-and-match" products from various vendors for overhead equipment used to carry patients weighing up to 625 lbs.....The only way this could be accomplished would be to have Ward 1 using products from Vendor A, Ward 2 using products from Vendor B, etc.....Even then it would be difficult to service all lift equipment at this VAMC.




