Question 1a: “Is it the intent under the solicitation to back fill and compact the new fill alongside the roadway only with no work to the existing roadway?”

Response 1a: Unless the soil under the roadway is disturbed by the constructions activities, no work will be required under the existing roadway. However, if the soils are disturbed, compaction of the soils disturbed will be required.
