Identica Dental CAD Scanner with accessories. \$25,406.00
5. **List the proposed contractor (name, contact, and phone number) and describe the unique knowledge or capabilities of the proposed contractor:** Dental Arts Lab Technology Systems, 888-894-2148. The Green Bay Dental Lab has already purchased a Identica scanning system and milling unit to design custom dental implants for patients throughout the VISN. The purchase of this CAD Add-on package would allow for the dental lab technicians the ability to design additional implants currently not available. The CAD Add-on package needs to be compatible with the existing Identica scanning system and milling unit.
6. **Describe your market research efforts and efforts to ensure that offers are solicited from as many potential sources as is practicable:** A search of Federal Prison Industries website utilizing the keywords "dental milling equipment" produced no matches. A search of Ability One website utilizing the keywords "dental milling equipment" produced no matches. A search of GSA Advantage using "dental milling equipment" produced no results. A search VetBiz utilizing the keywords "dental milling equipment" produced 10 SDVOSB possibilities but after reviewing the capabilities, none were for Dental equipment. Same search for VOSB, produced 8 possibilities, but after reviewing the capabilities, none were for Dental equipment. A google search of "Dental Milling Equipment" produced numerous results, drilling down further and including "Scanner" in the search I was able to find 1 one small business distributor of the exact item requested.
7. **State why you feel that the anticipated cost to the Government will be fair and reasonable:** Purchasing CAD add-ons other than those from DT Technologies which are compatible with the current Identica unit will result in the clinic needing to purchase a new Dental Milling unit, as well as educating the lab technicians on how to use a new system, would not be cost effective and would be disadvantageous to the VA.


