



1. Contracting Activity: The Department of Veterans Affairs, VA Medical Center, Dayton, OH, VISN 10 Contracting – Dayton Facility. Purchase Request Number: 552-14-2-6932-0019.
2. Nature and/or Description of Action Being Processed: The requirement of contractor to utilize Milestone System Compatible components for our video recording management system.
3. Description of Supplies/Services Required to Meet the Agency's Needs: As part of a project to renovate Building 411, housing Food and Nutrition section at the Dayton VAMC, the existing video recording system will be expanded to provide more efficient monitoring of the areas in the building and will be controlled by the existing Milestone Video Management System. The Estimated Value for the Milestone System is \$ _____.

5. Demonstration of Contractors Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (Applicable Authority): The Milestone system is used throughout the medical center to achieve integration of our video camera system
6. Description of Efforts Made to Ensure that offers are solicited from as many Potential Sources as Practicable: The video management system that is utilized at the Dayton VAMC is the Milestone System and must be used in order to tie in to the existing system.
7. Determination by the Contracting Officer of the Anticipated Cost to the Government as being Fair and Reasonable: It is in the best interest of the government to use this product. The price is in line with pricing provided to the vendor's other commercial customers, and is considered to be fair and reasonable. There have been previous purchases for the Milestone System. The Contracting Officer will be able to determine a fair and reasonable pricing based on previous procurement history and commercial pricing. A fair and reasonable price determination will be made by the Contracting Officer based on competition.
8. Description of Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted: No Market Research was conducted. The cost for this component will be compared with commercially published price lists and catalogs on similar video systems. In addition the entire project will be procured by competitive Invitation for Bid (IFB).




