The software is proprietary, thus, no other software is compatible for the Medical Center to use.
6. Description of Efforts Made to Ensure that offerors are solicited from as many Potential Sources as practicable: Software House CCure 900 will maintain the integration with the existing communication closet system.
7. Determination by the Contracting Officer that the Anticipated Cost of the Government will be Fair and Reasonable: It is in the best interest of the government to use this product. The price is in line with pricing provided to the vendor's other commercial customers. The price will be determined to be fair and reasonable to the government based on competition. The entire project will be competed as an Invitation for Bid (IFB).
8. Description of Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted: A "google" search of the software was conducted. Tyco Security Products is the manufacture. Tyco has a Dealer Certification program which allows for multiple vendors to supply the software.

Any Other Facts Supporting the Use of Other Than Full and Open Competition: Maintenance and system familiarity, while secondary to the issue of warranty or UL Listing, are other important factors to consider. Attempting to introduce new Software of a different manufacture would no doubt compromise the communication closet network.
