



- GENERAL NOTES:**
- COORDINATE ALL CONSTRUCTION ACTIVITIES WITH THE CEMETERY DIRECTOR TO AVOID CONFLICTS AND DISRUPTIONS OF DAILY CEMETERY OPERATIONS. SEQUENCE WORK AS NECESSARY TO ENSURE DAILY CEMETERY OPERATIONS REMAIN UNINTERRUPTED DURING CONSTRUCTION OPERATIONS.
 - CONTRACTOR SHALL MAINTAIN PROPER SIGNS, BARRICADES, AND FENCES TO PROPERLY PROTECT THE CONSTRUCTION AREA FROM TRAFFIC AND PEDESTRIANS. ALL EXCAVATION SHALL BE COVERED WITH VEHICLE RATED STEEL PLATES DURING NON-WORKING HOURS AND WHEN THERE IS NO ACTIVE CONSTRUCTION AT THE SITE.
 - EXISTING UTILITIES: DETAILED UNDERGROUND UTILITY INFORMATION IS UNAVAILABLE FOR THE DESIGNATED CONSTRUCTION AREA. CONTRACTOR SHALL VERIFY THE LOCATION AND DEPTH OF ALL EXISTING UTILITIES IN COORDINATION WITH THE CEMETERY STAFF IN DETERMINING THE POSSIBLE EXISTENCE AND LOCATION OF ALL ABOVEGROUND AND UNDERGROUND UTILITIES IN THE DESIGNATED AREAS UNDER CONSTRUCTION. USE CAUTION WHEN EXCAVATING DUE TO THE POSSIBLE EXISTENCE OF UNRECORDED UTILITIES.
 - EXISTING IRRIGATION SYSTEM: THE LOCATION OF THE IRRIGATION SYSTEM LINES AND COMPONENTS SHOWN ON THE REFERENCE DOCUMENTS ARE PROVIDED FOR INFORMATION ONLY AND NOT ALL IRRIGATION SYSTEM COMPONENTS (I.E., CONTROLLER SIGNAL WIRING, ETC.) ARE SHOWN ON THE REFERENCE DRAWINGS. COORDINATE WITH THE CEMETERY STAFF IN DETERMINING THE POSSIBLE EXISTENCE AND LOCATION OF ALL IRRIGATION SYSTEM COMPONENTS IN THE DESIGNATED AREAS UNDER CONSTRUCTION. USE CAUTION WHEN EXCAVATING DUE TO THE POSSIBLE EXISTENCE OF UNRECORDED IRRIGATION SYSTEM COMPONENTS.
 - ANY DAMAGE INCURRED TO EXISTING UTILITIES, IRRIGATION SYSTEM COMPONENTS, INSIDE AND OUTSIDE THE LIMITS OF WORK DUE TO CONTRACT OPERATIONS INCLUDING DAMAGE TO PAVEMENT, CURB AND GUTTER, AND OTHER STRUCTURES BY THE CONTRACTOR SHALL BE REPAIRED BY THE CONTRACTOR AT NO ADDITIONAL COST TO THE GOVERNMENT. IF ANY EXISTING UTILITIES, UTILITY STRUCTURES, OR IRRIGATION SYSTEM COMPONENTS ARE UNCOVERED OR ENCOUNTERED DURING CONSTRUCTION, THEY SHALL BE SHIELD/BOARDED, PROTECTED FROM DAMAGE, AND SUPPORTED AS NECESSARY.
 - ALL AREAS ADJACENT TO THE SITE SHALL BE MAINTAINED IN A CLEAN CONDITION, WIND AND DUST FREE AT ALL TIMES.
 - THE CONTRACTOR IS RESPONSIBLE FOR INSTALLATION OF ANY EROSION CONTROL MEASURES NECESSARY TO PREVENT EROSION AND SEDIMENTATION.
 - AREAS OUTSIDE OF THE CONSTRUCTION LIMITS IMPACTED BY OPERATIONS OF THE CONTRACTOR SHALL BE RETURNED TO THE STATE IT WAS FOUND PRIOR TO NEW CONSTRUCTION, EXCEPT WHERE NEW WORK IS SHOWN.
 - ALL TREES SHALL BE PROTECTED FROM DAMAGE TO TRUNKS, BRANCHES AND ROOTS. NO EXCAVATING, FILLING, OR GRADING IS TO BE DONE INSIDE THE DHP LINE OF TREES UNLESS OTHERWISE APPROVED BY THE CEMETERY.
 - ALL EXCESS SOIL SHALL BE RELOCATED TO AN APPROVED LOCATION ON CEMETERY PROPERTY.
 - ALL DEBRIS, DMC, ETC. SHALL BE RELOCATED OFF CEMETERY PROPERTY AND PROPERLY DISPOSED OF AT AN APPROVED WASTE DISPOSAL SITE.
 - RESTORE ALL SURFACES AND GRADES TO THEIR ORIGINAL ELEVATIONS AND CONDITION USING SAME MATERIAL AS EXISTING.
 - EXISTING PAVEMENT, CONCRETE CURB AND GUTTER, AND CONCRETE SIDEWALK SHALL REMAIN IN PLACE AND SHALL NOT BE DISTURBED.
 - THOROUGHLY CLEAN UP THE WORK AREA AT THE END OF EACH DAY'S WORK, AND AT COMPLETION OF THE PROJECT. LEAVE PREMISES CLEAN AND FREE OF WASTE, SCRAP, USED EQUIPMENT, OR OTHER MATERIAL INTENTIONALLY OR INCIDENTALLY DELIVERED TO THE SITE BY CONTRACTOR OR CONTRACTORS PERSONNEL.
 - ALL STREET PAVING, CONCRETE SIDEWALK, CURB, AND GUTTER SHALL REMAIN AND BE PROTECTED FROM DAMAGE, AND IF DAMAGED, SHALL BE REPLACED PROMPTLY TO MATCH EXISTING.






- GENERAL PAVING NOTES:**
- PRIOR TO COMPACTION AND PLACEMENT OF GRANULAR SUBBASE, THE CUT AREA SHALL BE REVIEWED AND PROOFTESTED FOR STABILITY. IF COMPACTION IS REQUIRED, COMPACTION SHALL BE IN ACCORDANCE WITH ASTM D1557.
 - REFER TO SPECIFICATIONS SECTION 321216 FOR WORK AND MATERIAL RELATED TO ASPHALT CONCRETE PAVING.
 - THE JOINT SHAPE FACTOR IS DEFINED AS THE FINAL PRESSED SHAPE OF THE SILICONE MATERIAL. THE TOOLING OPERATION WILL FIRMLY PRESS THE FRESHLY APPLIED MATERIAL IMMEDIATELY AGAINST THE CUT SIDES OF THE RECESS AND THE BACKER ROD SURFACES. THE ROUNDED SHAPE ON TOP AND BOTTOM OF THE SILICONE ALLOWS THE SEALANT TO PROPERLY FLEX BUT MAINTAIN ADHERANCE TO THE PAVING.




PODIUM CIRCLE






