(1). The base contract period shall commence **September 27, 2014** and expire **September 26, 2015**.

(2). At the discretion of the government, and in accordance with 52.217-9, Option to Extend the Term of the Contract, the contract may be extended four (4) one (1) year periods. Notice of an extension must be served in writing by the VA prior to the scheduled expiration date. An extension may be exercised subject to the continued acceptable performance and responsibility of the Contractor, the continued requirement for services, and the availability of funds.

B.4 STATEMENT OF WORK (SOW)

BIOMEDICAL ENGINEERING CONSULTING SERVICES FOR ST. LOUIS MO VA MEDICAL CENTER

(a). GENERAL INFORMATION

- (1). Title of Project: Biomedical engineering consulting services
- (2). Scope of Work: The Contractor shall provide all resources necessary to accomplish the deliverables described in this statement of work, except as may otherwise be specified.
- (3) Location: Contract deliverables are to be furnished to the following Activity:

(4). Background information:

(A). Biomedical Engineering plays a key role in the Hazard and Recall Program for medical equipment during all phases, including identification, communication, investigation, and corrective action(s). Biomedical Engineering staff work closely with other medical center professional staff in the clinical environment and have intimate knowledge about the devices under their care. Furthermore, Biomedical Engineering has access to local equipment histories and to a variety of external sources of information on hazards and recalls. Recalls, as defined by the FDA are hazard notifications and/or recommended actions that generally range from user notification to workarounds and remediation. Very rarely are devices affected by a recall removed from service and returned to the manufacturer. Usually the patient risk of removing devices from service for an undefined period of time outweighs the risk of continued use.

(B). Historically, notifications involving RMD have been issued in multiple ways to VHA Medical Centers through the Center for Engineering Occupational Safety and Health (CEOSH), the Healthcare Technology Management Program Office (HTM), and the National Center for Patient Safety (NCPS). They have been issued via e-mail communications to the potentially affected sites, through memorandums, or via Patient Safety Alerts/Advisories.

- (5). Performance Period: The Contractor shall begin the work required under this SOW commencing with the effective date of award, unless otherwise directed by the Contracting Officer (CO), and shall provide the required services until the date of contract expiration.

- (6). Type of Contract: Firm-Fixed-Price, indefinite quantity.

- (7). Extension of Contract: This contract may be extended for up to four (4) one (1) year option periods at the discretion of the government, in accordance with FAR 52.217 9, Option to Extend the Term of the Contract.

- (b). CONTRACT AWARD MEETING. The Contractor shall not commence performance on the tasks in this SOW until the CO has conducted a kick off meeting, or has advised the Contractor that a kick off meeting is waived.

(c). GENERAL REQUIREMENTS. The contractor shall provide the specific deliverables agreed to in each project plan.

(d). SERVICES TO BE PROVIDED.

(1). Project Management: The Contractor shall provide Project Management Services as required to accomplish projects. Services shall be performed by professional project management personnel with knowledge and proven skills in project management. Personnel shall possess skills necessary to ensure that the contract is executed in a professional, efficient and timely manner. Project management services that may be required are:

(A). Provide an initial contract detailed work plan and briefing for the VA project team, which presents the contractor's plan for completing future project orders. The plan shall be responsive with this SOW and describe, in further detail, the approach to be used for each aspect of the task order as defined in the technical proposal.

(B). Facilitate project meetings, record decisions made, actions assigned, and distribute meeting notes.

(C). Negotiate project plans, deliverables and timetables with the VA.

(D). Management of the overall project progress.

(E). Initiation of corrective action if course corrections become necessary.

(F). Ensuring that the correct contractor employees are assigned and available for all necessary activities.

(G). Ensuring that tasks are kept on schedule; identify tasks (including those that are VA responsibilities) at risk of falling off schedule.

(H). Providing reports (project progress reports, etc.).

(I). Management of schedule risks and recommendations on risk minimization.

(2). Biomedical Engineering. The Contractor shall provide Biomedical Engineering Services as required to accomplish projects. Services shall be performed by professional Biomedical Engineers who possess knowledge and proven skills in specified services. Personnel shall possess skills necessary to ensure that the contract is executed in a professional, efficient and timely manner. Biomedical Engineering services that may be required are:

(A). Provide Medical Device and Equipment Incident Reviews and Reports to include review of overall process.

(B). Provide investigative services of reported safety issues or incidents with medical devices within VA medical centers/health care systems. These investigations shall include understanding the problem, following up with applicable medical center/s or other appropriate contacts within VHA as well as vendor contacts to ensure that root causes have been identified where possible, and lessons learned are collected in a manner that may be shared with all VA Medical Centers. Investigations shall also include research within the FDA Maude database and ECRI's database (through CEOSH membership) to look for trends as well as any other tools that are available to the contractor.

(C). Utilize RCA and HFMEA concepts to complete the work for each investigation.

(D). Documentation of incident investigations shall occur via an agreed upon template. The template will have the following elements as a minimum:

- (i). Score Alert/Advisory based on Detectability, Severity, and Frequency (definitions and scoring matrix to be provided).
- (ii). Evaluate potential VA impact – how many VA Medical Centers have the equipment, how many devices are there at each medical center
- (iii). Evaluate if other manufacturer's equipment has similar problems
- (iv). Describe issue and equipment involved
- (v). Describe/research various resources for trend analysis and/or similar reports: ECRI Alerts, ECRI Journal, MAUDE, Medline, SPOT, Web Searches, etc.
- (vi). Describe Device – hardware and software, replacement cost, acceptable alternatives, disposables involved, etc.
- (vii). Document contacts with VA Medical Centers, vendors, VA Program Offices, etc. Who did you talk to and summary of conversation.
- (ix). Assist Medical Center Biomedical Engineers in figuring out root cause of incident
- (x). Assist Medical Center Biomedical Engineers in conducted HFMEA – healthcare failure mode effects analysis. Contractor shall use VA tools to figure out potential failure modes involved around incident that has occurred and assist facility in figuring out what mitigation factors they can employ to avoid issue in the future. Results shall be shared with the Contracting Officer's Representative (COR).
- (xi). Contractor shall present recommendations for follow on up work to be carried out by the VA Medical center where an incident assigned to the contractor occurred.

(E). The contractor will provide a review of the national process used within VHA for alerts, recalls, and incident investigations, a comparison the VHA process to other large scale health care organizations such as Kaiser Permanente, and providing lessons learned and recommendations for VHA to improve the processes for alerts, recalls, and incident investigations involving medical devices. Proper resourcing and return on investment shall also be evaluated. Project management services will internally be supplied by the VA Veterans Engineering Resource Center (VERC) for the review of VHA processes. An internal workgroup of stakeholders will be formed to assist in the development of the ideal process.

(3). Subject Matter Expert. The Contractor shall provide Subject Matter Expert Services as required to accomplish projects. Services shall be performed by professionals with extensive knowledge and experience in a wide variety of biomedical engineering topics who possess proven expertise and skills in the specified services. The Subject Matter Expert shall provide guidance, oversight and review of deliverables. Personnel shall possess skills necessary to ensure that the contract is executed in a professional, efficient and timely manner.

(e). CONTRACTOR EXPERIENCE REQUIREMENTS.

(1). Project Management, Biomedical Engineer and Clinical Subject Matter Expert personnel are considered key personnel to this contract.

(2). The contractor must notify VA in advance and the VA will approve or reject proposed contractor key personnel for the performance of this contract. The contractor shall submit a resume of qualifications to the COR for key personnel. If a key person becomes unavailable to complete the project, the proposed substitutions of key personnel shall be made only as approved by the Contracting Officer or the COR. Except for Biomedical Engineer services the government will not dictate specific experience and education requirements of the personnel initially proposed to perform the work stated herein. The contractor shall submit a resume of qualifications for Project Management, Biomedical Engineer and Clinical Subject Matter Expert personnel proposed for the contract. All Contractor personnel will be approved by the COR prior to the authorization of a project. If, at any time from date of award to the end of the contract, key Contractor personnel are no longer available, the VA reserves the right to review the qualifications of the proposed replacement personnel and to reject individuals who do not meet the qualifications for the tasks to be performed.

(3). The Contractor shall remove any personnel from the performance of this contract within five (5) workdays of receiving notice from the Contracting Officer that the personnel's performance is unsatisfactory. All Contractor personnel are subject to immediate removal from performance of this contract when they are involved in a violation of the law, VA security, confidentiality requirements and/or other disciplinary reasons.

(4). The Contractor's Biomedical Engineering personnel must possess the following minimum qualifications:

(A). Bachelor's degree in Biomedical Engineering or very closely related engineering discipline from an ABET accredited university, or

(B). Master's degree in Biomedical Engineering or a related discipline from an ABET accredited university

(C). Certification in Clinical Engineering (CCE) from the US Board of Examiners through the Healthcare Technology Foundation Commission or American College of Clinical Engineering (ACCE).

(D). Experience in incident investigations involving medical equipment.

(f). REPORTING REQUIREMENTS.

(1). The contractor shall provide the COR with monthly written progress reports (delivered electronically). These are due to the COR by the second workday following the end of each calendar month, throughout each project's duration.

(2). The progress report shall cover all work completed during the period and shall present the work to be accomplished during the subsequent month. This report shall also identify any problems that arose, along with a statement explaining how the problem was resolved. This report shall also identify any problems that have arisen but have not been completely resolved, with an explanation.

(3). Quarterly Quality Assurance Program reports addressing any issues discovered by the Contractor shall be provided to the COR within ten (10) work days after the close of that quarter.

(g). TRAVEL. Not Applicable

(h). CONFIDENTIALITY AND NONDISCLOSURE.

It is agreed that:

(1). The preliminary and final deliverables, and all associated working papers, application source code, and other material deemed relevant by VA which have been generated by the contractor in the performance of this task order, are the exclusive property of the U.S. Government and shall be submitted to the CO at the conclusion of the task order.

(2). The CO will be the sole authorized official to release, verbally or in writing, any data, draft deliverables, final deliverables, or any other written or printed materials pertaining to this task order. No information shall be released by the contractor. Any request for information relating to this task order, presented to the contractor, shall be submitted to the CO for response.

(3). Press releases, marketing material, or any other printed or electronic documentation related to this project, shall not be publicized without the written approval of the CO.

(i). **QUALITY ASSURANCE PROGRAM.** The Contractor shall maintain an on-going quality assurance program to objectively and systematically monitor and evaluate the quality of services provided and a self-assessment of compliance with this contract.

(j). **VA RESPONSIBILITIES.** The VA shall furnish background information and contact information that is readily available to the VA for each equipment issue for the contractor to investigate. Triaging of incidents will be performed by the COR.

(k). **ORDERS, DELIVERABLES, AND INVOICING.**

(1). **Project orders:** The Contractor shall accept project orders placed against this contract from the delegated COR. The VA will provide the Contractor a description of the task/s and the deliverable/s required. The VA and the Contractor will negotiate the type and amount of labor required to accomplish the task/s and produce the deliverable. Upon agreement, the VA must provide a written letter, fax or email that will authorize the project. The authorization will:

(A). Assigning a unique project number,

(B). Recap the amount and type of labor projected to be required for accomplishing the task/s,

(C). Recap the deliverable/s agreed to,

(D). Recap time frames agreed to,

(E). Specify an amount that is not to be exceeded in the accomplishment of the project.

(F). All written project orders shall be phrased in layperson language. Statistical and other technical terminology shall not be used without providing a glossary of terms.

(2). **Deliverables:**

(A). The Contractor shall furnish professional personnel knowledgeable and experienced in the services required in this SOW. Deliverables required may be written analysis, projections, evaluations, forecasts, recommendations, or a combination of these items. The deliverables may be required to be provided in written or electronic form in Microsoft Word, PowerPoint or Excel formats. All cost for providing research, documentation, production and presentation is to be included in the hourly rate agreed to, including any supplies that may be required in producing the deliverable.

(B). Upon receipt the VA has ten (10) days to accept or reject the deliverable. Failure to reject the deliverable within the specified ten (10) days will constitute acceptance by the VA. If deliverables are rejected by the VA the Contractor must correct any defects in the deliverables at no additional cost. Reason for rejection may be, but are not limited to, lack of professional quality; errors in research, documentation or presentation; incomplete or missing research, documentation or presentation material. Disagreements between the VA and the Contractor concerning acceptance or rejections will be referred to the Contracting Officer for resolution.

(3). **Invoices:** The Contractor will invoice for the actual number of hours expended in accomplishment of the project up to, but not exceeding, the amount specified in the project authorization. If for some unforeseen reason the project cannot be accomplished in the time and amount authorized the Contractor and the VA must re-negotiate the project and the VA must amend the written authorization before any additional work can proceed.

(A). Payment will be made in arrears after receipt and acceptance of all deliverables required for each project. No partial or progress payments will be authorized.

(B). All hours invoiced will be rounded to the nearest 1/6th of an hour (10 minute period).

(C). The invoice will list each completed project and will provide for each:

- (i). Project number.
- (ii). Date of Delivery.
- (iii). Description of project.
- (iv). Itemized hours and hourly price by Contract Line Item Number (CLIN).

(D). Each project will not require an individual invoice. Several projects that have been accepted in the previous month may be included in the monthly invoice.

(D). Invoices will be sent to the address specified in section B.1.

(I). SPECIAL REQUIREMENTS.

(1). Required registration with Contractor Performance Assessment Reporting System (CPARS):

(A). As prescribed in Federal Acquisition Regulation (FAR) Part 42.15, the Department of Veterans Affairs (VA) evaluates Contractor past performance on all contracts that exceed \$150,000, and shares those evaluations with other Federal Government contract specialists and procurement officials. The FAR requires that the Contractor be provided an opportunity to comment on past performance evaluations prior to each report closing. To fulfill this requirement VA uses an online database, CPARS, which is maintained by the Naval Seal Logistics Center in Portsmouth, New Hampshire. CPARS has connectivity with the Past

(B). Performance Information Retrieval System (PIRS) database, which is available to all Federal agencies. PIRS is the system used to collect and retrieve performance assessment reports used in source selection determinations and completed CPARS report cards transferred to PIRS. CPARS also includes access to the federal awardee performance and integrity information system (FAPIS). FAPIS is a web-enabled application accessed via CPARS for Contractor responsibility determination information.

(C). Each Contractor whose contract award is estimated to exceed \$150,000 is required to register with CPARS database at the following web address: www.cpars.csd.disa.mil. Help in registering can be obtained by contacting Customer Support Desk @ DSN: 684-1690 or COMM: 207-438-1690. Registration should occur no later than thirty days after contract award, and must be kept current should there be any change to the Contractor's registered representative.

(D). For contracts with a period of one year or less, the contracting officer will perform a single evaluation when the contract is complete. For contracts exceeding one year, the contracting officer will evaluate the Contractor's performance annually. Interim reports will be filed each year until the last year of the contract, when the final report will be completed. The report shall be assigned in CPARS to the Contractor's designated representative for comment. The Contractor representative will have thirty days to submit any comments and re-assign the report to the VA contracting officer.

(E). Failure to have a current registration with the CPARS database, or to re-assign the report to the CO within those thirty days, will result in the Government's evaluation being placed on file in the database with a statement that the Contractor failed to respond.

(m). IT SECURITY REQUIREMENTS. Specific training and certification requirements for Contractor personnel for the viewing, handling or storage of confidential information are not applicable to this contract.

SECTION C - CONTRACT CLAUSES

C.1 52.212-4 CONTRACT TERMS AND CONDITIONS--COMMERCIAL ITEMS (MAY 2014)

(a) Inspection/Acceptance. The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. If repair/replacement or reperformance will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies or services. The Government must exercise its post-acceptance rights-

- (1) Within a reasonable time after the defect was discovered or should have been discovered; and
- (2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) Assignment. The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). However, when a third party makes payment (e.g., use of the Governmentwide commercial purchase card), the Contractor may not assign its rights to receive payment under this contract.

(c) Changes. Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) Disputes. This contract is subject to 41 U.S.C. chapter 71, Contract Disputes. Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising under or relating to this contract shall be a dispute to be resolved in accordance with the clause at FAR 52.233-1, Disputes, which is incorporated herein by reference. The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(e) Definitions. The clause at FAR 52.202-1, Definitions, is incorporated herein by reference.

(f) Excusable delays. The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence such as, acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(g) Invoice.

(1) The Contractor shall submit an original invoice and three copies(or electronic invoice, if authorized) to the address designated in the contract to receive invoices. An invoice must include-

- (i) Name and address of the Contractor;

(ii) Invoice date and number;

(iii) Contract number, contract line item number and, if applicable, the order number;

(iv) Description, quantity, unit of measure, unit price and extended price of the items delivered;

(v) Shipping number and date of shipment, including the bill of lading number and weight of shipment if shipped on Government bill of lading;

(vi) Terms of any discount for prompt payment offered;

(vii) Name and address of official to whom payment is to be sent;

(viii) Name, title, and phone number of person to notify in event of defective invoice; and

(ix) Taxpayer Identification Number (TIN). The Contractor shall include its TIN on the invoice only if required elsewhere in this contract.

(x) Electronic funds transfer (EFT) banking information.

(A) The Contractor shall include EFT banking information on the invoice only if required elsewhere in this contract.

(B) If EFT banking information is not required to be on the invoice, in order for the invoice to be a proper invoice, the Contractor shall have submitted correct EFT banking information in accordance with the applicable solicitation provision, contract clause (e.g., 52.232-33, Payment by Electronic Funds Transfer-- System for Award Management, or 52.232-34, Payment by Electronic Funds Transfer--Other than System for Award Management), or applicable agency procedures.

(C) EFT banking information is not required if the Government waived the requirement to pay by EFT.

(2) Invoices will be handled in accordance with the Prompt Payment Act (31 U.S.C. 3903) and Office of Management and Budget (OMB) prompt payment regulations at 5 CFR part 1315.

(h) Patent indemnity. The Contractor shall indemnify the Government and its officers, employees and agents against liability, including costs, for actual or alleged direct or contributory infringement of, or inducement to infringe, any United States or foreign patent, trademark or copyright, arising out of the performance of this contract, provided the Contractor is reasonably notified of such claims and proceedings.

(i) Payment.-

(1) Items accepted. Payment shall be made for items accepted by the Government that have been delivered to the delivery destinations set forth in this contract.

(2) Prompt payment. The Government will make payment in accordance with the Prompt Payment Act (31 U.S.C. 3903) and prompt payment regulations at 5 CFR part 1315.

(3) Electronic Funds Transfer (EFT). If the Government makes payment by EFT, see 52.212-5(b) for the appropriate EFT clause.

(4) Discount. In connection with any discount offered for early payment, time shall be computed from the date of the invoice. For the purpose of computing the discount earned, payment shall be considered to have been made on the date which appears on the payment check or the specified payment date if an electronic funds transfer payment is made.

(5) Overpayments. If the Contractor becomes aware of a duplicate contract financing or invoice payment or that the Government has otherwise overpaid on a contract financing or invoice payment, the Contractor shall--

(i) Remit the overpayment amount to the payment office cited in the contract along with a description of the overpayment including the--

(A) Circumstances of the overpayment (e.g., duplicate payment, erroneous payment, liquidation errors, date(s) of overpayment);

(B) Affected contract number and delivery order number, if applicable;

(C) Affected contract line item or subline item, if applicable; and

(D) Contractor point of contact.

(ii) Provide a copy of the remittance and supporting documentation to the Contracting Officer.

(6) Interest.

(i) All amounts that become payable by the Contractor to the Government under this contract shall bear simple interest from the date due until paid unless paid within 30 days of becoming due. The interest rate shall be the interest rate established by the Secretary of the Treasury as provided in 41 U.S.C. 7109, which is applicable to the period in which the amount becomes due, as provided in (i)(6)(v) of this clause, and then at the rate applicable for each six-month period as fixed by the Secretary until the amount is paid.

(ii) The Government may issue a demand for payment to the Contractor upon finding a debt is due under the contract.

(iii) Final decisions. The Contracting Officer will issue a final decision as required by 33.211 if--

(A) The Contracting Officer and the Contractor are unable to reach agreement on the existence or amount of a debt within 30 days;

(B) The Contractor fails to liquidate a debt previously demanded by the Contracting Officer within the timeline specified in the demand for payment unless the amounts were not repaid because the Contractor has requested an installment payment agreement; or

(C) The Contractor requests a deferment of collection on a debt previously demanded by the Contracting Officer (see 32.607-2).

(iv) If a demand for payment was previously issued for the debt, the demand for payment included in the final decision shall identify the same due date as the original demand for payment.

(v) Amounts shall be due at the earliest of the following dates:

(A) The date fixed under this contract.

(B) The date of the first written demand for payment, including any demand for payment resulting from a default termination.

(vi) The interest charge shall be computed for the actual number of calendar days involved beginning on the due date and ending on--

(A) The date on which the designated office receives payment from the Contractor;

(B) The date of issuance of a Government check to the Contractor from which an amount otherwise payable has been withheld as a credit against the contract debt; or

(C) The date on which an amount withheld and applied to the contract debt would otherwise have become payable to the Contractor.

(vii) The interest charge made under this clause may be reduced under the procedures prescribed in 32.608-2 of the Federal Acquisition Regulation in effect on the date of this contract.

(j) Risk of loss. Unless the contract specifically provides otherwise, risk of loss or damage to the supplies provided under this contract shall remain with the Contractor until, and shall pass to the Government upon:

(1) Delivery of the supplies to a carrier, if transportation is f.o.b. origin; or

(2) Delivery of the supplies to the Government at the destination specified in the contract, if transportation is f.o.b. destination.

(k) Taxes. The contract price includes all applicable Federal, State, and local taxes and duties.

(l) Termination for the Government's convenience. The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges the Contractor can demonstrate to the satisfaction of the Government using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred which reasonably could have been avoided.

(m) Termination for cause. The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(n) Title. Unless specified elsewhere in this contract, title to items furnished under this contract shall pass to the Government upon acceptance, regardless of when or where the Government takes physical possession.

(o) Warranty. The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

(p) Limitation of liability. Except as otherwise provided by an express warranty, the Contractor will not be liable to the Government for consequential damages resulting from any defect or deficiencies in accepted items.

(q) Other compliances. The Contractor shall comply with all applicable Federal, State and local laws, executive orders, rules and regulations applicable to its performance under this contract.

(r) Compliance with laws unique to Government contracts. The Contractor agrees to comply with 31 U.S.C. 1352 relating to limitations on the use of appropriated funds to influence certain Federal contracts; 18 U.S.C. 431 relating to

officials not to benefit; 40 U.S.C. chapter 37, Contract Work Hours and Safety Standards; 41 U.S.C. chapter 87, Kickbacks; 41 U.S.C. 4712 and 10 U.S.C. 2409 relating to whistleblower protections; 49 U.S.C. 40118, Fly American; and 41 U.S.C. chapter 21 relating to procurement integrity.

(s) Order of precedence. Any inconsistencies in this solicitation or contract shall be resolved by giving precedence in the following order:

(1) The schedule of supplies/services.

(2) The Assignments, Disputes, Payments, Invoice, Other Compliances, Compliance with Laws Unique to Government Contracts, and Unauthorized Obligations paragraphs of this clause;

(3) The clause at 52.212-5.

(4) Addenda to this solicitation or contract, including any license agreements for computer software.

(5) Solicitation provisions if this is a solicitation.

(6) Other paragraphs of this clause.

(7) The Standard Form 1449.

(8) Other documents, exhibits, and attachments

(9) The specification.

(t) System for Award Management (SAM).

(1) Unless exempted by an addendum to this contract, the Contractor is responsible during performance and through final payment of any contract for the accuracy and completeness of the data within the SAM database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the SAM database after the initial registration, the Contractor is required to review and update on an annual basis from the date of initial registration or subsequent updates its information in the SAM database to ensure it is current, accurate and complete. Updating information in the SAM does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(2)(i) If a Contractor has legally changed its business name, "doing business as" name, or division name (whichever is shown on the contract), or has transferred the assets used in performing the contract, but has not completed the necessary requirements regarding novation and change-of-name agreements in FAR subpart 42.12, the Contractor shall provide the responsible Contracting Officer a minimum of one business day's written notification of its intention to (A) change the name in the SAM database; (B) comply with the requirements of subpart 42.12; and (C) agree in writing to the timeline and procedures specified by the responsible Contracting Officer. The Contractor must provide with the notification sufficient documentation to support the legally changed name.

(ii) If the Contractor fails to comply with the requirements of paragraph (t)(2)(i) of this clause, or fails to perform the agreement at paragraph (t)(2)(i)(C) of this clause, and, in the absence of a properly executed novation or change-of-name agreement, the SAM information that shows the Contractor to be other than the Contractor indicated in the contract will be considered to be incorrect information within the meaning of the "Suspension of Payment" paragraph of the electronic funds transfer (EFT) clause of this contract.

(3) The Contractor shall not change the name or address for EFT payments or manual payments, as appropriate, in the SAM record to reflect an assignee for the purpose of assignment of claims (see Subpart 32.8, Assignment of Claims). Assignees shall be separately registered in the SAM database. Information provided to the Contractor's SAM record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the "Suspension of payment" paragraph of the EFT clause of this contract.

(4) Offerors and Contractors may obtain information on registration and annual confirmation requirements via SAM accessed through <https://www.acquisition.gov>.

(u) Unauthorized Obligations.

(1) Except as stated in paragraph (u)(2) of this clause, when any supply or service acquired under this contract is subject to any End User License Agreement (EULA), Terms of Service (TOS), or similar legal instrument or agreement, that includes any clause requiring the Government to indemnify the Contractor or any person or entity for damages, costs, fees, or any other loss or liability that would create an Anti-Deficiency Act violation (31 U.S.C. 1341), the following shall govern:

(i) Any such clause is unenforceable against the Government.

(ii) Neither the Government nor any Government authorized end user shall be deemed to have agreed to such clause by virtue of it appearing in the EULA, TOS, or similar legal instrument or agreement. If the EULA, TOS, or similar legal instrument or agreement is invoked through an "I agree" click box or other comparable mechanism (e.g., "click-wrap" or "browse-wrap" agreements), execution does not bind the Government or any Government authorized end user to such clause.

(iii) Any such clause is deemed to be stricken from the EULA, TOS, or similar legal instrument or agreement.

(2) Paragraph (u)(1) of this clause does not apply to indemnification by the Government that is expressly authorized by statute and specifically authorized under applicable agency regulations and procedures.

(End of Clause)

- (10) Past performance information, when included as an evaluation factor, to include recent and relevant contracts for the same or similar items and other references (including contract numbers, points of contact with telephone numbers and other relevant information); and
- (11) If the offer is not submitted on the SF 1449, include a statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation. "Inverted domestic corporation", as used in this section, means a foreign incorporated entity which is treated as an inverted domestic corporation under 6 U.S.C. 395(b), i.e., a corporation that used to be incorporated in the United States, or used to be a partnership in the United States, but now is incorporated in a foreign country, or is a subsidiary whose parent corporation is incorporated in a foreign country, that meets the criteria specified in 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c). An inverted domestic corporation as herein defined does not meet the definition of an inverted domestic corporation as defined by the Internal Revenue Code at 26 U.S.C. 7874.

"Manufactured end product" means any end product in Federal Supply Classes (FSC) 1000-9999, except—

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

"Restricted business operations" means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). "Sensitive technology"—

(i) To restrict the free flow of unbiased information in Iran; or

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

"Service-disabled veteran-owned small business concern"—

(iii) Each service employee who will perform the services under the contract will spend only a small portion of his or her time (a monthly average of less than 20 percent of the available hours on an annualized basis, or less than 20 percent of available hours during the contract period if the contract period is less than a month) servicing the Government contract; and

(iv) The compensation (wage and fringe benefits) plan for all service employees performing work under the contract is the same as that used for these employees and equivalent employees servicing commercial customers.

(3) If paragraph (k)(1) or (k)(2) of this clause applies—
