

1. Contracting Activity: Department of Veterans Affairs, VISN 23, Iowa City Medical Center NCO 23 Iowa City "Justification for Other than Full and Open Competition." Project Number 636-201.
2. Nature and/or Description of the Action Being Processed: This request is for Square D brand switchboards, electrical panels, and metering. This is a partial requirement of Minor project 636-201, titled "Expand Building 1 for PACT, Ambulatory Care, Radiology, Egress Stairwell Addition." This project will be solicited as 100% set aside for Service Disabled Veteran Owned Small Business and is a Request for Proposal (Lowest price, technically competent) type of contract.
3. Description of Supplies/Services Required to Meet the Agency's Needs: One (1) Square D distribution panel board with "Power Logic" metering on each feeder, and 7 Square D Panel boards with "Power Logic" feeder capability. Requirement estimated at [REDACTED] and will be provided by the Electrical subcontractor.
4. Statutory Authority Permitting Other than Full and Open Competition:
 - (1) Only One Responsible Source and No Other Supplies or Services Will Satisfy Agency Requirements per FAR 6.302-1;
 - (2) Unusual and Compelling Urgency per FAR 6.302-2;
 - (3) Industrial Mobilization, Engineering, Developmental or Research Capability or Expert Services per FAR 6.302-3;
 - (4) International Agreement per FAR 6.302-4
 - (5) Authorized or Required by Statute FAR 6.302-5;
 - (6) National Security per FAR 6.302-6;
 - (7) Public Interest per FAR 6.302-7;
5. Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority):

The Iowa City campus has, in recent years, converted to Square D's Power Logic for our campus power management system. Power Logic electrical metering system is a highly specialized and focused power management system that provides intelligence for the entire power distribution infrastructure of our Medical Center. It provides insight into the operation of our electrical system, and ensures our data center can be operated at the maximum reliability levels while minimizing energy costs and waste.

Square D is the only company capable of interfacing with Power Logic and it is essential to the Medical Center that this major system be fully integrated and communicative
6. Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable: Final determination that the cost will be Fair and Reasonable will be made by the Contracting Officer.

7. Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:
As described in Section VI above, market research, in accordance with FAR Part 10, was conducted by synopsis of the proposed acquisition, advising industry of the pending acquisition and soliciting inquiries from interested parties.
8. Any Other Facts Supporting the Use of Other than Full and Open Competition: New components must tie into an existing, operational system. At this time, there are no competing vendors capable of providing fully integrated products.
9. Listing of Sources that Expressed, in Writing, an Interest in the Acquisition: See Section VI above.

A Statement of the Actions, if any, the Agency May Take to Remove or Overcome any Barriers to Competition before Making subsequent acquisitions for the supplies or services required: There are no other vendors available who have fully integrated products for the Power Logic system. If, in the future, other vendors are capable of supplying such products, the Iowa City VA HCS will open competition to their products.

Requirements Certification: I certify that the requirement outlined in this justification is a Bona Fide Need of the Department of Veterans Affairs and that the supporting data under my cognizance, which are included in the justification, are accurate and complete to the best of my knowledge and belief.
