1. Contracting Activity: Department of Veterans Affairs, VISN 23, Iowa City Medical Center NCO 23 Iowa City "Justification for Other than Full and Open Competition." Project Number 636-201.
2. Nature and/or Description of the Action Being Processed: This request is for GE Telegence Nurse Call System. This is a partial requirement of Minor project 636-201, titled "Expand Building 1 for PACT, Ambulatory Care, Radiology, Egress Stairwell Addition." This project will be solicited as 100% set aside for Service Disabled Veteran Owned Small Business and is a Request for Proposal (Lowest price, technically competent) type of contract.
3. Description of Supplies/Services Required to Meet the Agency's Needs: Project calls for a complete nurse call system in Primary Care and the Emergency Department. Components include consoles, annunciators, emergency call stations, code blue stations, duty stations, staff stations, patient stations, dome lights and staff patient notification control panels. 5. Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority):

The Iowa City campus has converted to GE Telegence Nurse Call System. New components for this project must tie into the existing, fully operational system.
