2. **Nature and/or Description of the Action Being Processed:** *Procurement of Remote Upgrade Services for the HawkEye AP SenSage 4.5 to 5.0.1, transaction 770-14-4-676-0047, for \$47,700.00.*
3. **Description of Supplies/Services Required to Meet the Agency's Needs:** *National CMOP is requesting to procure Remote Upgrade Services for the HawkEye AP SenSage 4.5 to 5.0.1 required prior to the FY15 SenSage contract renewal. Upgrade will migrate current system off the three physical servers that are out of warranty into a virtual environment using the current VMware infrastructure and upgrade the software to latest version.*

An RFI was placed under SEWP to verify if any SEWP contracted vendor was able to provide the software as a third party but we did not receive any interest for any of the SEWP vendors.*
6. **Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:** *An RFI was placed under SEWP to verify if any SEWP contracted vendor was able to provide the software as a third party but we did not receive any interest for any of the SEWP vendors. This demonstrates that the software Upgrade needed can only be provided by Helix Cyber Solutions.*
7. **Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable:** *Based on previous services performed by this vendor and compared with other vendors that have provide similar services the price quoted is competitive in this type of market.*

8. **Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:** *An RFI was issued in SEWP with no positive results. Research was also performed through GSA Advantage Catalog, FBO, VetBiz, and Internet and only Helix Cyber Solutions was found to be able to provide the requested software upgrade. However, constant market research is being performed to give more and different vendors opportunity of future awards of similar services needed.*
