Questions/comments

1. The revised statement of work list the PoP as 270 days in Section 1.1-B and PoP as 160 days section 5.0-A. Please clarify.

Section 1.1-B states: "Work shall be complete, Occupational Safety and Health Administration (OSHA), National Recognized Testing Laboratory (NRTL – i.e. Underwriters Laboratory [UL]) Listed and Labeled; and VA Central Office (VACO), Telecommunications Voice Engineering (TVE 005OP3B) tested, certified and ready for operation within 270 days from Notice to Proceed."

Section 5.1-A states: "Construction shall be completed 160 calendar days from Notice to Proceed."

This means that the contractor has 160 days for construction and to install the system. The 270 days provides an additional 110 days to test, make changes and certify the system before the system needs to be operational.

2. A lot of the existing cables for the nurse call and public address systems are run "free air", can the new system be run "free air" or does it need to be run in conduits?

There is not a requirement for Low voltage wiring to be in conduit above the ceiling grid. There is a requirement that wiring cannot lay on the ceiling grid.

3. Does the old cabling need to be demoed and removed from the ceiling space?

Yes the old cabling will be removed.

4. One of the concerns with the PAMNS project was the number of zones needed.

There will need a minimum of 21 zones with an expansion capability.

5. Notes for the attached drawings:

- The red hatched areas are new construction.
- Building Names 1-A, 1-B, B-1, 1-C, 45, 1-CA and 1-CX are for reference only and should not be used. These are the old names for Arrowhead, Buffalo, Cowboy and Douglas Fir.
- Buildings 18, 19, 20, 23A, 25, 26, 31 and 42 are not to be considered for this project.
