Description

This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in Subpart 12.6, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; proposals are being requested and a written solicitation will not be issued.

This is a request for proposal (RFP). The quote document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular 05-76 August 25, 2014.

The associated North American Industrial Classification System (NAICS) code for this procurement is 621991, with a small business size standard of \$32.5M in Annual Receipts.

To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. SOW- Statement of Work
COMMUNITY BLOOD BANK FOR THE SUPPLY
OF BLOOD AND BLOOD COMPONENTS

PURPOSE:

Contractor shall provide all management, transportation, tools, supplies, equipment and labor necessary to supply blood and blood products to the Transfusion Service, Building 100, Room 2B-111, C.W. Bill Young VA Medical Center, Bay Pines, Florida.

GENERAL REQUIREMENTS:

- a. Offers shall be considered only from bidders whose blood bank is currently registered and licensed with the Food and Drug Administration (FDA), Department of Health, Education and Welfare pursuant to Section 510 of the Federal Food, Drug and Cosmetic Act, dated January 31, 1973.
- b. Prior to award, the successful offeror shall be required to submit proof that they hold an unrevoked U.S. license issued by the Director, Bureau of Biologics, Food and Drug Administration (FDA) under Section 351 of the Public Health Service Act, as a source of supply for blood and blood components.
- c. If interstate or imported shipments of blood / blood components are involved, the offeror shall submit with their offer a statement that such approval has been authorized under the Public Health Service Act.
- d. The offeror shall be accredited by American Association of Blood Banks (AABB).
- e. The offeror shall provide services twenty-four (24) hours, seven (7) days per week.
- f. The offeror shall provide 100% of the Bay Pines VA HCS blood supply needs as well as reference lab and therapeutic services.
- g. The offeror shall deliver STAT blood component requests within 75 minutes of time of request.
- h. The offeror certifies that they shall comply with the requirements outlined below with respect to donors, containers, delivery, etc.
- i. The offeror shall supply the Bay Pines VA HCS Blood Bank with the most current information regarding bidder's operating policies.
- j. The VA reserves the option to inspect the bidder's facilities.
- k. Offers shall be considered only from blood banks capable of providing the VA with 100% "Volunteer Donor" blood in accordance with the FDA, AABB, and the State of Florida criteria.

Definition of a “Volunteer Donor” is a person who does not receive monetary payment for blood donation per FDA guidelines.

DONOR REQUIREMENTS:

- a. The offeror shall maintain readily available blood donor lists including names, addresses and social security numbers. Such lists shall indicate on what date blood/blood components of a particular donor were furnished to the Bay Pines VA HCS under this contract.
- b. Donor selection shall be in accordance with criteria established by the FDA and AABB.
- c. The offeror shall supply information as soon as it is determined regarding donors subsequently found to have infections with HIV, HCV, HBV, WNV, Syphilis, or HTLV I/II who have supplied units to the Bay Pines VA HCS previously. The look-back information supplied by the offeror must allow Bay Pines VA HCS to locate all previously donated units by the now HIV, HCV, HBV, WNV, Syphilis, or HTLV I/II positive donor.
 - The offeror shall contact Bay Pines VA HCS within 3 calendar days if supplied blood and blood components collected from a donor who tested negative at the time of donation but tests reactive for evidence of HIV or HCV.
 - The offeror shall contact Bay Pines VA HCS within 45 days of the test, of the results of the supplemental (additional, more specific) test for HIV or HCV, as relevant or other follow-up testing required by FDA.
 - The offeror shall contact Bay Pines VA HCS within 3 calendar days if supplied blood and blood components collected from an infected donor, whenever records are available, as set forth by 21 CFR 610.48(b) (3).
- d. Units found to be related to bacterially contaminated units/donors or units from donor testing were identified with invalid QC or testing shall be communicated to the Bay Pines VA HCS as soon as determined.

COLLECTION, PROCESSING, AND TYPING OF BLOOD AND COMPONENTS:

- a. All blood and components shall be typed for ABO and Rh antigens and screened for unexpected antibodies in accordance with methods recommended in the current edition of (1) "STANDARDS FOR BLOOD BANKS AND TRANSFUSION SERVICES" and (2) "TECHNICAL MANUAL" published by the AABB.
- b. Only blood/blood components tested and found to be negative for syphilis, hepatitis B surface antigen (HBsAg), HIV nucleic acid (individual or combined HIV/HCV assay), HCV nucleic acid (individual or combined HIV/HCV assay), anti-HIV-1, anti-HIV-2, antibodies to hepatitis B core antigen (anti-HBc), anti-HCV, antibodies to human T-cell lymphotropic viruses, types I/II (anti-HTLV I/II), West Nile Virus (WNV), and anti-T. cruzi (Chagas) antibodies shall be accepted.
- c. Autologous blood units shall be tested for infectious agents according to FDA and AABB regulations. Bay Pines VA HCS shall accept all shipments of autologous units with positive disease markers.
- d. All blood and components shall be collected by a closed system under aseptic conditions and shall be processed in appropriate solutions and the containers so labeled. The label shall also bear the expiration date of the contents and any container of blood with an unbroken seal, returned seven (7) days prior to the expiration date, shall be credited to its full value. The expiration date shall not exceed 42 days from the date of manufacture, which is the date of bleeding the donor, unless the type of preservative used is approved by the FDA for a longer interval.
- e. All blood and components to be supplied shall be free of abnormal color, gross hemolysis, excessive chyle and clots.
- f. There shall be included at least ten (10) properly labeled and originally attached segments of the blood to be used in crossmatching.
- g. Blood and components shall have all processing completed before being shipped to Bay Pines VA HCS.
- h. Only platelets tested for bacterial contamination by an AABB approved method shall be accepted.
- i. Only leuko-reduced red cells and platelet pheresis units shall be accepted, except in rare instances.
- j. The contracting blood bank shall investigate all donors implicated in Transfusion Related Acute Lung Injury (TRALI) after notification by Bay Pines VA HCS.
- k. The contracting blood bank shall follow current AABB guidelines related to plasma components to reduce the risk of TRALI.
- l. The contracting blood bank shall provide only ISBT-128 labeled blood and blood component.

REFERENCE AND THERAPEUTIC SERVICES:

- a. The contracting blood bank shall serve as a reference laboratory to identify clinically significant antibodies for a potential recipient and shall provide this blood within 24 hours as available (as requested by Bay Pines VA HCS Transfusion Service).
- b. The contracting blood bank shall provide consultation for antibody identification or other blood banking related questions.
- c. The contracting blood bank shall provide therapeutic services for BPVAHCS patients. The contracting blood bank is responsible for providing all necessary equipment and consumables for each procedure which is performed on the BPVAHCS campus. All equipment and consumables must be within expiration and meet the requirements of the FDA and AABB. All training and competency records for all operators must be readily available by the contracting blood bank if needed by BPVAHCS personnel to meet regulatory inspections.
- d. The contracting blood bank must be able to perform STAT therapeutic services within 2 hours of the time of request from BPVAHCS.

ORDERING:

- a. Daily blood product orders shall be placed only by the Pathology & Laboratory Medicine Service.
- b. Unless whole blood is specifically requested, requests for blood shall be regarded as red blood cells.
- c. Therapeutic services are request by the clinical provider through consultation and approval by the contracting vendor pathologist.

CHARGES:

- a. Charges shall be inclusive of all transportation charges as defined below in Deliveries and Performance, except those charges incurred and authorized by Pathology & Laboratory Medicine Service. Additional charges over the allowed deliveries shall appear on a monthly, primary invoice.
- b. All charges for blood and blood components shall be based on the contracted blood bank's posted fee schedule for the respective calendar year. Calendar year pricing may override the fiscal year projected price of the previous calendar year.
- c. All charges for reference lab and therapeutic services shall be based on the contracted blood bank's posted fee schedule for the respective calendar year.
- d. The contractor shall provide a monthly detailed invoice for all items and services. Monthly detailed invoices of Contractor charges shall be sent to the Bay Pines Transfusion Service for reconciliation.
- e. Empty transportation containers, blood or other related components, and equipment being returned for credit shall be returned at the Contractor's expense.

- f. All charges shall be inclusive of additional materials required by Contractor to provide services to the BPVAHCS, for example, transfer packs.
- g. There shall be no additional fees for autologous donations for transfusions at Bay Pines VA HCS other than the customary processing fees. These charges shall appear on the contract, or primary invoice.
- h. "Directed Donation" charges are processed on the monthly account invoice and are defined.

PACKAGING AND MARKING:

- a. Blood / blood components shall be shipped according to inventory needs of Bay Pines VA HCS Transfusion Service. The Contractor hereby agrees that blood outdating rate of 1% shall not be exceeded. Bay Pines VA HCS Transfusion Service shall return blood to the Contractor that seven (7) days shelf life remaining for replacement with blood having at least twelve (12) days shelf life remaining.
- b. The blood shall be refrigerated between 1 and 6 degrees Celsius (C). Freezing must be avoided at all times. The blood shall be transported in clean shipping containers provided with refrigeration sufficient to hold the blood at 1-10 degrees C.
- c. Platelet and granulocyte components shall be transported in clean shipping containers with packaging to maintain the temperature at 20-24 degrees C.
- d. Frozen plasma and cryoprecipitate components shall be transported in clean shipping containers with sufficient dry ice to maintain frozen state.
- e. The expiration date of the blood / blood components shall be clearly legible.
- f. Bar code labels (ISBT-128) conforming to International Council for Commonality in Blood Bank Automation, Inc. (ICCBBA) shall be legible on all blood components.

DELIVERIES AND PERFORMANCE:

- a. DELIVERIES: The Contractor shall provide pickup and delivery services three (3) times a day seven days a week.
 - Blood shall be delivered normally within twenty-four (24) hours following request except for emergency requests, which must be delivered within 75 minutes.
 - The Contractor shall provide, at no additional cost to BPVAHCS, three (3) routine deliveries between the hours of 9:00 a.m. and 7:00 p.m. of blood to and/or from the Bay Pines VA HCS Transfusion Service, Bldg 100, Room 2B-111.
 - Transportation for deliveries other than the 3 routine daily pickup/deliveries, including any Priority 1 (Emergent) or Priority 2 (ASAP) requests, shall be provided by the Contractor. VBVAHCS shall be billed at the Contractors posted fee schedule pricing.

- b. In the event blood and components called for under the terms of this contract are not immediately available from the Contractor's blood bank, the Contractor shall be responsible for making all arrangements and shall assume liability for costs to procure the blood from other sources. The contracting blood bank shall serve as a clearinghouse for all blood required by Bay Pines VA HCS. This service shall be available seven (7) days a week, twenty-four (24) hours a day.
- c. The Contractor shall provide service for autologous transfusions and directed donations and ship to Bay Pines VA HCS Transfusion Service as soon as donor testing is completed and units are available.

SECTION C - CONTRACT CLAUSES

C.1 52.203-3 GRATUITIES (APR 1984)

(a) The right of the Contractor to proceed may be terminated by written notice if, after notice and hearing, the agency head or a designee determines that the Contractor, its agent, or another representative—

(1) Offered or gave a gratuity (e.g., an entertainment or gift) to an officer, official, or employee of the Government; and

(2) Intended, by the gratuity, to obtain a contract or favorable treatment under a contract.

(b) The facts supporting this determination may be reviewed by any court having lawful jurisdiction.

(c) If this contract is terminated under paragraph (a) above, the Government is entitled—

(1) To pursue the same remedies as in a breach of the contract; and

(2) In addition to any other damages provided by law, to exemplary damages of not less than 3 nor more than 10 times the cost incurred by the Contractor in giving gratuities to the person concerned, as determined by the agency head or a designee. (This subparagraph (c)(2) is applicable only if this contract uses money appropriated to the Department of Defense.)

(d) The rights and remedies of the Government provided in this clause shall not be exclusive and are in addition to any other rights and remedies provided by law or under this contract.

(End of Clause)

C.2 52.204-4 PRINTED OR COPIED DOUBLE-SIDED ON POSTCONSUMER FIBER CONTENT PAPER (MAY 2011)

(a) *Definitions.* As used in this clause—

"Postconsumer fiber" means— (1) Paper, paperboard, and fibrous materials from retail stores, office buildings, homes, and so forth, after they have passed through their end-usage as a consumer item, including: used corrugated boxes; old newspapers; old magazines; mixed waste paper; tabulating cards; and used cordage; or

(2) All paper, paperboard, and fibrous materials that enter and are collected from municipal solid waste; but not

(3) Fiber derived from printers' over-runs, converters' scrap, and over-issue publications.

(b) The Contractor is required to submit paper documents, such as offers, letters, or reports that are printed or copied double-sided on paper containing at least 30 percent postconsumer fiber, whenever practicable, when not using electronic commerce methods to submit information or data to the Government.

(End of Clause)

C.3 52.204-13 SYSTEM FOR AWARD MANAGEMENT MAINTENANCE (JUL 2013)

(a) *Definitions.* As used in this clause—

Data Universal Numbering System (DUNS) number means the 9-digit number assigned by Dun and Bradstreet, Inc. (D&B) to identify unique business entities, which is used as the identification number for Federal Contractors.

Data Universal Numbering System+4 (DUNS+4) number means the DUNS number assigned by D&B plus a 4-character suffix that may be assigned by a business concern. (D&B has no affiliation with this 4-character suffix.) This 4-character suffix may be assigned at the discretion of the business concern to establish additional SAM records for identifying alternative Electronic Funds Transfer (EFT) accounts (see the FAR at subpart 32.11) for the same concern.

Registered in the System for Award Management (SAM) database means that—

- (1) The Contractor has entered all mandatory information, including the DUNS number or the DUNS+4 number, the Contractor and Government Entity (CAGE) code, as well as data required by the Federal Funding Accountability and Transparency Act of 2006 (see subpart 4.14), into the SAM database;
- (2) The Contractor has completed the Core, Assertions, Representations and Certifications, and Points of Contact sections of the registration in the SAM database;
- (3) The Government has validated all mandatory data fields, to include validation of the Taxpayer Identification Number (TIN) with the Internal Revenue Service (IRS). The Contractor will be required to provide consent for TIN validation to the Government as a part of the SAM registration process; and
- (4) The Government has marked the record "Active".

System for Award Management (SAM) means the primary Government repository for prospective Federal awardee and Federal awardee information and the centralized Government system for certain contracting, grants, and other assistance-related processes. It includes—

- (1) Data collected from prospective Federal awardees required for the conduct of business with the Government;
- (2) Prospective contractor-submitted annual representations and certifications in accordance with FAR subpart 4.12; and
- (3) Identification of those parties excluded from receiving Federal contracts, certain subcontracts, and certain types of Federal financial and non-financial assistance and benefits.

(b) The Contractor is responsible for the accuracy and completeness of the data within the SAM database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the SAM database after the initial registration, the Contractor is required to review and update on an annual basis, from the date of initial registration or subsequent updates, its information in the SAM database to ensure it is current, accurate and complete. Updating information in the SAM does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(c)(1)(i) If a Contractor has legally changed its business name, *doing business as* name, or division name (whichever is shown on the contract), or has transferred the assets used in performing the contract, but has not completed the necessary requirements regarding novation and change-of-name agreements in subpart 42.12, the Contractor shall provide the responsible Contracting Officer a minimum of one business day's written notification of its intention to—

- (A) Change the name in the SAM database;
- (B) Comply with the requirements of subpart 42.12 of the FAR; and
- (C) Agree in writing to the timeline and procedures specified by the responsible Contracting Officer.

The Contractor shall provide with the notification sufficient documentation to support the legally changed name.

(ii) If the Contractor fails to comply with the requirements of paragraph (c)(1)(i) of this clause, or fails to perform the agreement at paragraph (c)(1)(i)(C) of this clause, and, in the absence of a properly executed novation or change-of-name agreement, the SAM information that shows the Contractor to be other than the Contractor indicated in the contract will be considered to be incorrect information within the meaning of the "Suspension of Payment" paragraph of the electronic funds transfer (EFT) clause of this contract.

(2) The Contractor shall not change the name or address for EFT payments or manual payments, as appropriate, in the SAM record to reflect an assignee for the purpose of assignment of claims (see FAR subpart 32.8, Assignment of Claims). Assignees shall be separately registered in the SAM. Information provided to the Contractor's SAM record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the "Suspension of Payment" paragraph of the EFT clause of this contract.

(3) The Contractor shall ensure that the DUNS number is maintained with Dun & Bradstreet throughout the life of the contract. The Contractor shall communicate any change to the DUNS number to the Contracting Officer within 30 days after the change, so an appropriate modification can be issued to update the data on the contract. A change in the DUNS number does not necessarily require a novation be accomplished. Dun & Bradstreet may be contacted—

C.4 52.212-4 CONTRACT TERMS AND CONDITIONS—COMMERCIAL ITEMS (MAY 2014)

(a) *Inspection/Acceptance.* The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. If repair/replacement or reperformance will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies or services. The Government must exercise its post-acceptance rights—

- (1) Within a reasonable time after the defect was discovered or should have been discovered; and
- (2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) *Assignment.* The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). However, when a third party makes payment (e.g., use of the Governmentwide commercial purchase card), the Contractor may not assign its rights to receive payment under this contract.

(c) *Changes.* Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) *Disputes.* This contract is subject to 41 U.S.C. chapter 71, Contract Disputes. Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising under or relating to this contract shall be a dispute to be resolved in accordance with the clause at FAR 52.233-1, Disputes, which is incorporated herein by reference. The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(e) *Definitions.* The clause at FAR 52.202-1, Definitions, is incorporated herein by reference.

(f) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence such as, acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(g) *Invoice.*

(1) The Contractor shall submit an original invoice and three copies (or electronic invoice, if authorized) to the address designated in the contract to receive invoices. An invoice must include—

- (i) Name and address of the Contractor;
- (ii) Invoice date and number;
- (iii) Contract number, contract line item number and, if applicable, the order number;
- (iv) Description, quantity, unit of measure, unit price and extended price of the items delivered;
- (v) Shipping number and date of shipment, including the bill of lading number and weight of shipment if shipped on Government bill of lading;
- (vi) Terms of any discount for prompt payment offered;
- (vii) Name and address of official to whom payment is to be sent;
- (viii) Name, title, and phone number of person to notify in event of defective invoice; and
- (ix) Taxpayer Identification Number (TIN). The Contractor shall include its TIN on the invoice only if required elsewhere in this contract.

(x) Electronic funds transfer (EFT) banking information.

(A) The Contractor shall include EFT banking information on the invoice only if required elsewhere in this contract.

(B) If EFT banking information is not required to be on the invoice, in order for the invoice to be a proper invoice, the Contractor shall have submitted correct EFT banking information in accordance with the applicable solicitation provision, contract clause (e.g., 52.232-33, Payment by Electronic Funds Transfer—System for Award Management, or 52.232-34, Payment by Electronic Funds Transfer—Other Than System for Award Management), or applicable agency procedures.

(C) EFT banking information is not required if the Government waived the requirement to pay by EFT.

(2) Invoices will be handled in accordance with the Prompt Payment Act (31 U.S.C. 3903) and Office of Management and Budget (OMB) prompt payment regulations at 5 CFR part 1315.

(h) *Patent indemnity.* The Contractor shall indemnify the Government and its officers, employees and agents against liability, including costs, for actual or alleged direct or contributory infringement of, or inducement to infringe, any United States or foreign patent, trademark or copyright, arising out of the performance of this contract, provided the Contractor is reasonably notified of such claims and proceedings.

(i) *Payment.*—

(1) *Items accepted.* Payment shall be made for items accepted by the Government that have been delivered to the delivery destinations set forth in this contract.

(2) *Prompt payment.* The Government will make payment in accordance with the Prompt Payment Act (31 U.S.C. 3903) and prompt payment regulations at 5 CFR part 1315.

(3) *Electronic Funds Transfer (EFT).* If the Government makes payment by EFT, see 52.212-5(b) for the appropriate EFT clause.

(4) *Discount.* In connection with any discount offered for early payment, time shall be computed from the date of the invoice. For the purpose of computing the discount earned, payment shall be considered to have been made on the date which appears on the payment check or the specified payment date if an electronic funds transfer payment is made.

(5) *Overpayments.* If the Contractor becomes aware of a duplicate contract financing or invoice payment or that the Government has otherwise overpaid on a contract financing or invoice payment, the Contractor shall—

(i) Remit the overpayment amount to the payment office cited in the contract along with a description of the overpayment including the—

(A) Circumstances of the overpayment (e.g., duplicate payment, erroneous payment, liquidation errors, date(s) of overpayment);

(B) Affected contract number and delivery order number, if applicable;

(C) Affected contract line item or subline item, if applicable; and

(D) Contractor point of contact.

(ii) Provide a copy of the remittance and supporting documentation to the Contracting Officer.

(6) *Interest.*

(i) All amounts that become payable by the Contractor to the Government under this contract shall bear simple interest from the date due until paid unless paid within 30 days of becoming due. The interest rate shall be the interest rate established by the Secretary of the Treasury as provided in 41 U.S.C. 7109, which is applicable to the period in which the amount becomes due, as provided in (i)(6)(v) of this clause, and then at the rate applicable for each six-month period as fixed by the Secretary until the amount is paid.

(ii) The Government may issue a demand for payment to the Contractor upon finding a debt is due under the contract.

(iii) *Final decisions.* The Contracting Officer will issue a final decision as required by 33.211 if—

(A) The Contracting Officer and the Contractor are unable to reach agreement on the existence or amount of a debt within 30 days;

(B) The Contractor fails to liquidate a debt previously demanded by the Contracting Officer within the timeline specified in the demand for payment unless the amounts were not repaid because the Contractor has requested an installment payment agreement; or

(C) The Contractor requests a deferment of collection on a debt previously demanded by the Contracting Officer (see 32.607-2).

(iv) If a demand for payment was previously issued for the debt, the demand for payment included in the final decision shall identify the same due date as the original demand for payment.

(v) Amounts shall be due at the earliest of the following dates:

(A) The date fixed under this contract.

(B) The date of the first written demand for payment, including any demand for payment resulting from a default termination.

(vi) The interest charge shall be computed for the actual number of calendar days involved beginning on the due date and ending on—

(A) The date on which the designated office receives payment from the Contractor;

(B) The date of issuance of a Government check to the Contractor from which an amount otherwise payable has been withheld as a credit against the contract debt; or

(C) The date on which an amount withheld and applied to the contract debt would otherwise have become payable to the Contractor.

(vii) The interest charge made under this clause may be reduced under the procedures prescribed in 32.608-2 of the Federal Acquisition Regulation in effect on the date of this contract.

(j) *Risk of loss.* Unless the contract specifically provides otherwise, risk of loss or damage to the supplies provided under this contract shall remain with the Contractor until, and shall pass to the Government upon:

(1) Delivery of the supplies to a carrier, if transportation is f.o.b. origin; or

(2) Delivery of the supplies to the Government at the destination specified in the contract, if transportation is f.o.b. destination.

(k) *Taxes.* The contract price includes all applicable Federal, State, and local taxes and duties.

(l) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges the Contractor can demonstrate to the satisfaction of the Government using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred which reasonably could have been avoided.

(m) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(n) *Title.* Unless specified elsewhere in this contract, title to items furnished under this contract shall pass to the Government upon acceptance, regardless of when or where the Government takes physical possession.

(o) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

(p) *Limitation of liability.* Except as otherwise provided by an express warranty, the Contractor will not be liable to the Government for consequential damages resulting from any defect or deficiencies in accepted items.

(q) *Other compliances.* The Contractor shall comply with all applicable Federal, State and local laws, executive orders, rules and regulations applicable to its performance under this contract.

(r) *Compliance with laws unique to Government contracts.* The Contractor agrees to comply with 31 U.S.C. 1352 relating to limitations on the use of appropriated funds to influence certain Federal contracts; 18 U.S.C. 431 relating to officials not to benefit; 40 U.S.C. chapter 37, Contract Work Hours and Safety Standards; 41 U.S.C. chapter 87, Kickbacks; 41 U.S.C. 4712 and 10 U.S.C. 2409 relating to whistleblower protections; 49 U.S.C. 40118, Fly American; and 41 U.S.C. chapter 21 relating to procurement integrity.

(s) *Order of precedence.* Any inconsistencies in this solicitation or contract shall be resolved by giving precedence in the following order:

- (1) The schedule of supplies/services.
- (2) The Assignments, Disputes, Payments, Invoice, Other Compliances, Compliance with Laws Unique to Government Contracts, and Unauthorized Obligations paragraphs of this clause;
- (3) The clause at 52.212-5.
- (4) Addenda to this solicitation or contract, including any license agreements for computer software.
- (5) Solicitation provisions if this is a solicitation.
- (6) Other paragraphs of this clause.
- (7) The Standard Form 1449.
- (8) Other documents, exhibits, and attachments
- (9) The specification.

(t) *System for Award Management (SAM).*

Assignees shall be separately registered in the SAM database. Information provided to the Contractor's SAM record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the "Suspension of payment" paragraph of the EFT clause of this contract.

(u) *Unauthorized Obligations.*

(1) Except as stated in paragraph (u)(2) of this clause, when any supply or service acquired under this contract is subject to any End User License Agreement (EULA), Terms of Service (TOS), or similar legal instrument or agreement, that includes any clause requiring the Government to indemnify the Contractor or any person or entity for damages, costs, fees, or any other loss or liability that would create an Anti-Deficiency Act violation (31 U.S.C. 1341), the following shall govern:

(i) Any such clause is unenforceable against the Government.

(ii) Neither the Government nor any Government authorized end user shall be deemed to have agreed to such clause by virtue of it appearing in the EULA, TOS, or similar legal instrument or agreement. If the EULA, TOS, or similar legal instrument or agreement is invoked through an “I agree” click box or other comparable mechanism (e.g., “click-wrap” or “browse-wrap” agreements), execution does not bind the Government or any Government authorized end user to such clause.

(iii) Any such clause is deemed to be stricken from the EULA, TOS, or similar legal instrument or agreement.

(2) Paragraph (u)(1) of this clause does not apply to indemnification by the Government that is expressly authorized by statute and specifically authorized under applicable agency regulations and procedures.

(2) Has a felony criminal violation under any Federal or State law within the preceding 24 months, unless the agency has considered suspension or debarment of the corporation and Suspension and Debarment Official has made a determination that this action is not necessary to protect the interests of the Government.

(b) The Offeror represents that—

The contractor must cite 52.209-9 and request removal within 7 calendar days of the posting to FAPIIS.

(2) The Contractor will also have an opportunity to post comments regarding information that has been posted by the Government. The comments will be retained as long as the associated information is retained, i.e., for a total period of 6 years. Contractor comments will remain a part of the record unless the Contractor revises them.

The minimum requirements set forth in the SOW are not met by the offeror's proposal. The proposal contains one or more deficiencies that will impact performance of the contract.

An inverted domestic corporation as herein defined does not meet the definition of an inverted domestic corporation as defined by the Internal Revenue Code at 26 U.S.C. 7874.

"Manufactured end product" means any end product in Federal Supply Classes (FSC) 1000-9999, except—

- (1) FSC 5510, Lumber and Related Basic Wood Materials;
- (2) Federal Supply Group (FSG) 87, Agricultural Supplies;
- (3) FSG 88, Live Animals;
- (4) FSG 89, Food and Related Consumables;
- (5) FSC 9410, Crude Grades of Plant Materials;
- (6) FSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) FSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) FSC 9610, Ores;
- (9) FSC 9620, Minerals, Natural and Synthetic; and
- (10) FSC 9630, Additive Metal Materials.

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

"Restricted business operations" means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

(1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

(3) The representation and certification requirements of paragraph (o)(2) of this provision do not apply if—

(i) This solicitation includes a trade agreements certification (*e.g.*, 52.212–3(g) or a comparable agency provision); and

(ii) The offeror has certified that all the offered products to be supplied are designated country end products.
