## B.2 Performance Work Statement

### URINALYSIS AND BODY FLUID SYSTEM CPR

1. **GENERAL:** The Government has a requirement for a urinalysis analyzer system with a microscopic system using digital imaging with Auto-Particle recognition software for Urine Specimen analysis and Body Fluid analysis. All materials and services are to be calculated as a cost per reportable (CPR) and fees shall all-inclusive.
2. **SCOPE:**
  - 2.1 The Contractor shall provide all the necessary instrumentation, employee training, preventive maintenance, repairs, parts, service, hot line services, upgrades, all the necessary software, reagents, controls, calibrators, disposables, consumables, other required supplies (such as tables for the analyzers) and shipping for in-house urine specimen testing in the Pathology & Laboratory Medicine Service at the Miami VA Healthcare System (MVAHS) as outlined below. All work shall be performed in accordance with the guidelines established by Federal, State and local ordinances, FDA manufacturer's guidelines, and with all terms, conditions, provisions, schedules and specifications provided herein.

#### **4      PERFORMANCE REQUIREMENTS:**

##### 4.1      Equipment Capabilities:

4.1.1      The clinical laboratory offered under this contract shall comply with all general requirements stated herein. The offered clinical system software shall have the immediate capability to interface with the Governments' current VISTA system without requiring additional commercial software packages.

4.1.2      The contractor shall provide the following new state-of-the-art equipment with all attachments and accessories;

4.1.2.a      One (1) iRICELL plus 2000 ELITE SYSTEM

4.1.2.b      One (1) iChem Velocity Analyzer

4.1.2.c      One (1) iQ200 Elite Plus Analyzer

4.1.2.d      One (1) iQ Body Fluids Module

4.1.2.e      LIS Interface

4.1.3      The contractor shall provide all upgrades to the equipment hardware and operating system software, without any additional cost to the Government.

4.1.4      An operator's manual shall be furnished with each model supplied. Electronic formats (e.g. on CD) are acceptable.

##### 4.2      Inventory control reagents, supplies and disposables:

4.2.1      All consumable supplies (reagents, standards, control, disposables, etc.) required for the proper operation of the contractor's equipment and necessary to perform tests on the equipment provided shall be included, and shall be furnished by the contractor for each clinical laboratory analyzer model.

4.2.2      The COR will place an order based on their expected inventory needs as indicated in their delivery order and or based upon adjustments made during quarterly reconciliations. These items shall be of the highest quality ensuring sensitivity, specificity and tested to assure precision and accuracy. The quality of the products shall be high enough to satisfy proficiency testing standards of the College of American Pathologists (CAP) and the Joint Commission on Accreditation of Health Care Organizations (JCAHO).

##### 4.2.3      Delivery of supplies:

4.2.3.1      On the first day of each month or the next business day following a weekend or Federal holiday (if the 1<sup>st</sup> falls on weekend/holiday), the contractor shall insure that each site is furnished with sufficient consumable supplies to produce a volume of test equal to that stated in the task order.

4.2.3.2      In the event that the consumables are found to be defective and unsuitable for use with the contractor's equipment, or the contractor has failed to comply with requirements for routine supply delivery, the contractor shall deliver the consumable supplies within a period of twenty-four (24) hours after receipt of the verbal order for priority delivery from the Government activity. If either circumstances has occurred, the contractor shall deliver to the Government site the next day without any additional cost to the Government, the necessary

consumables in sufficient quantity as required to allow operation of the contractor's equipment for one (1) week (under normal Government test load volume). If additional request for emergency supply delivery are required by the Government, they shall be honored by the contractor until the arrival of the monthly standing order/routine supplies is delivery at the Government facility.

- 4.2.3.3 The contractor shall immediately notify the COR of any changes in reagents or equipment modifications by electronic means as well as by postal mail with supporting documentation of the change and, detailed guidance on implementation within twenty four (24) hours of its application or according to FDA guidelines.
- 4.3 Maintenance:
  - 4.3.1 General Provisions:
    - 4.3.1.1 The contractor shall provide maintenance (labor and parts) to keep the equipment in good operating condition.
    - 4.3.1.2 Preventive maintenance:
      - 4.3.1.2.1 Contractor shall provide regular, scheduled maintenance to assure the continued reliable operation of the equipment.
      - 4.3.1.2.2 These PM visits shall be of a frequency that conforms to the manufacturer's operation and maintenance instructions for the supported equipment.
      - 4.3.1.2.3 If scheduled maintenance services for commercial customers exceed the manufacturer's operation and maintenance instructions, the same shall be provided to the Government for the same model of clinical laboratory equipment.
    - 4.3.1.3 The contractor shall provide technical assistance (not limited to test performance or equipment malfunction) twenty four (24) hours a day, seven (7) days a week and on all Federal and religious holidays, via direct communication thru a telephone bank with technically capacitated and contractor-certified personnel.
  - 4.3.2 Emergency Repair:
    - 4.3.2.1 Emergency repairs shall be performed after notification that the equipment is inoperative. The contractor shall provide the Government with a designated point of contact and shall make arrangements to enable the maintenance representative to receive such notification.
    - 4.3.2.2 The contractor must be capable of performing emergency repair service twenty-four (24) hours per day, seven (7) days per week.
    - 4.3.2.3 The contractor shall respond to emergency repairs within (24) hours.
    - 4.3.2.4 The contractor shall provide all parts and labor needed to repair the malfunction.
    - 4.3.2.5 Travel, per diem and other expenses associated with the repair will be borne by the contractor.
    - 4.3.2.6 The contractor shall furnish a malfunction incident report to the COR upon completion of each repair call. The report shall include, as a minimum, the following:
      - 4.3.2.6.1 Date and time notified
      - 4.3.2.6.2 Date and time of arrival
      - 4.3.2.6.3 Serial number, type and model number(s) of equipment

- 4.3.2.6.4 Time spent for repair
- 4.3.2.6.5 Description of malfunction and repair
- 4.3.2.6.6 Proof of repair which includes documentation of a sample run of quality control verifying acceptable performance
- 4.4 Maintenance credit for equipment malfunction:
  - 4.4.1 If an instrument remains inoperative due to a malfunction through no fault or negligence of the Government for a total of more than twenty-four (24) hours, the contractor shall be assessed damages which will be applied to the invoice in the form of a credit or deduction, at the rate of 1/30 of the preceding average three (3) month cost-per-test/reportable billings times the total number of day certified as downtime.
  - 4.4.2 In the event that there is no history of cost-per-test/reportable billings then the estimated volumes that were established and agreed to in the contract document.
  - 4.4.3 Downtime for each incident shall start from the time the Government makes a bona fide attempt to contact the contractor's designated representative at the prearranged contact point until the machine is returned in good operating order.
- 4.5 Replacement laboratory equipment:
  - 4.5.1 During the contract period, should the repair record of any laboratory equipment reflect a downtime of 10% or more of the normal working days in one (1) calendar month, a determination will be made by the designated representative of the Government at the using facility requiring the contractor to replace the initial laboratory equipment with new equipment.
  - 4.5.2 The responsibility for maintaining the equipment furnished in good condition shall be solely that of the contractor.
  - 4.5.3 The contractor shall remove the equipment at the expiration of the term of the multi-year pricing arrangement unless the Government opts to retain the equipment at the reduced contract price.
- 4.6 Safety:
  - 4.6.1 The Contractor shall immediately notify the Government of any changes in reagents kits composition, procedure modification, recall notification, equipment modifications, or any changes that will affect the performance of the test or procedure according to FDA regulations.
  - 4.6.2 Notification shall be provided via electronic means as well as by postal mail with supporting documentation of the changes and, detailed guidance on implementation within twenty four (24) hours of its application or according to FDA guidelines.
- 4.7 Training:
  - 4.7.1 The contractor shall provide on-site training for test and procedures offered and conduct instructional course(s) to meet the objectives identified in paragraph 4. In addition, the contractor shall provide handouts and training materials in sufficient quantity for each participant. These are off-the-shelf courses and the contractor shall provide lesson plan, course materials and media (DVD's, CD's, videos, etc. if required) for each procedure at no additional cost to the Government.
- 4.8 Ownership of equipment:



- 4.8.1 Title to equipment provided under this contract shall remain with the contractor. All accessories (unused consumables, etc.) furnished by the contractor shall accompany the equipment when returned to the contractor.
- 4.8.2 The contractor, upon expiration of the contract, replacement of equipment, or notice of termination of the task order or contract shall remove equipment. The contractor shall disconnect the analyzer (gas, water, air, etc.), and shall be responsible for all packing and shipping required to remove the analyzer within seven (7) calendar days.

**5. PERFORMANCE LOCATION AND HOURS:**

- 5.1 The Department of Veterans Affairs Medical Center, Pathology & Laboratory Medicine Service, 1201 NW 16<sup>th</sup> Street, Room A305 Miami, Florida, 33125.
- 5.2 The Government normal duty hours are from 8:00am - 4:30pm, Monday through Friday, including Federal holidays. The primary location provides diagnostic support to the facility 24 hours daily, 7 days per week.

**6. DELIVERABLES:**

- 6.1 The contractor shall deliver all invoices with the term of service included for review according to the established contract at the end of each monthly billing cycle.

**7. KEY PERSONNEL REPLACEMENT AND SUBSTITUTION: Not Applicable.**

**8. CONTRACTOR PERSONNEL AND MANAGEMENT:**

- 8.1 Contractor Personnel. The Contractor shall be responsible for employing technically qualified personnel to perform the work specified in this PWS. The Contractor shall maintain the personnel, organization and administrative control necessary to ensure that the work delivered meets the contract specifications and requirements.
- 8.2 Government Badges. The COR will coordinate through the Security Service Sponsor/Managers the issuance of required visitor badges to Contractor personnel. Contract personnel shall wear identification badges provided by the Government at all times when performing work on-site. Badges shall be worn on the outer garment, attached to the outer shirt or jacket pocket by a button or clip or worn around the neck secured by an appropriate identification card lanyard.
- 8.2.1 Government issued identification badge remains the property of the Government and shall be returned to the issuing office or other designated Government personnel upon transfer of Contractor employees from the contract.
- 8.3 Contractor Badges. Notwithstanding the requirement to wear a Government furnished badge, Contractor personnel shall also wear a contractor identification badge at all times when performing services under this Contract, including when on Government directed travel the badge will contain a personal picture, name of employee, and Contractor's name. Badges shall be worn on the outer garment attached to the outer shirt or jacket pocket by a button or clip or worn around the neck secured by an appropriate identification card lanyard.
- 8.4 Safety/Security Requirements. The Contractor shall comply with all applicable federal, state and local laws and ensure performance is secure while protecting material, equipment, and supplies from damage and loss. Government security personnel shall have the express right to inspect for security violations at any time during the term of the contract.

- 8.4.1. All information generated in performance of this contract becomes property of the Government and must be surrendered upon request and/or completion of the contract. The Contractor must protect against the destruction and/or misplacement of all information produced under this contract, unless directed under local policy to destroy. This includes both hard and soft copies of data.
- 8.4.2. The Contractor shall not release any information (including photographs, files, public announcements, statements, denials, or confirmations) on any part of the subject matter of this contract or any phase of any program hereunder without the prior written approval by hospital director or designated representative.
- 8.5 Standards of Conduct:
  - 8.5.1 Conduct of Personnel. Contractor personnel shall conduct themselves in a professional manner (i.e. timeliness, communication; spoken and written etc.). The Contracting Officer may require the Contractor to remove from the job site any employee working under this contract for reasons of suspected misconduct, a suspected security breach, or suspected to be under the influence of alcohol, drugs, or any other incapacitating agent. Contractor employees shall be subject to dismissal from the premises upon determination by the Contracting Officer that such action is necessary in the interests of the Government. The hospital director or designated representative has the authority to bar individuals from the Government facility. The removal from the job site or dismissal from the premises shall not relieve the Contractor of the requirement to provide sufficient personnel to perform the services as required by this performance work statement. The Government shall not reimburse the Contractor for travel and other expenses associated with the removal of personnel.
  - 8.5.2 Contractor personnel are not authorized to carry or possess personal weapons to include, but not limited to, firearms and knives with a blade length in excess of three inches, while assigned under this contract.
  - 8.5.3 Working Attire and Appearance. Contractor personnel shall present a professional appearance commensurate with standards delineated for Government civilian personnel acting in similar capacities.
  - 8.5.4 The Government reserves the right to review Contractor personnel qualifications. Upon request, resumes shall be provided to the Contracting Officer prior to clearance approval, for review and acceptance by the COR. The intent is for verification purposes and not for the Government to become the hiring authority.
9. **TRAVEL:** If training for key operator requires travel, arrangements to an off-site location will be paid and arranged by the Contractor in accordance with FSS/NAC contract specifications.
10. **NON-PERSONAL SERVICE STATEMENT:**
  - 10.1 Contractor employees performing services under this order will be controlled, directed, and supervised at all times by management personnel of the contractor. Contractor management will ensure that employees properly comply with the performance work standards outlined in the PWS. Contractor employees will perform their duties independent of, and without the supervision of, any Government official. The tasks, duties, and responsibilities set forth in the contract may not be interpreted or implemented in any manner that results in any contractor employee creating or modifying Federal policy, obligating the appropriated funds of the United States Government, overseeing the work of Federal employees, providing direct personal services to any Federal employee, or otherwise violating the prohibitions set forth in Parts 7.5 and 37.1 of the Federal Acquisition Regulation (FAR). The Government will control access to the facility and will perform the inspection and acceptance of the completed work.
11. **NON-PERSONNEL SERVICE STATEMENT:**
  - 11.1. The Contractor shall be responsible for employing technically qualified personnel to perform the work specified in this PWS. The Contractor shall maintain the personnel, organization, and administrative control necessary to ensure that the work delivered meets the contract specifications and requirements. The work

history of each contractor employee must contain experience directly related to the task and functions he/she is intended to perform under this contract. The Government reserves the right, during the life of the resulting contract, to request work histories on any contractor employee for the purposes of verifying compliance with the above requirements; additionally, the Government reserves the right to review resumes of contractor personnel proposed to be assigned. Personnel assigned to, or utilized by, the Contractor in performance of work shall be fully capable of performing the requirements contained in the PWS in an efficient, reliable, and professional manner. The normal manner of dress is business casual.

11.2 Specific Personnel Qualifications Requirements –Personnel assigned to or utilized by the contractor in the performance of this contract shall, as a minimum:

11.2.1 Be qualified by the contractor as capable to perform as a field service representative.

11.3 Specialized Experience: The Contractor shall provide technical guidance to Supply Operations customers concerning supply requirements; provide logistical technical assistance to civilian personnel of all units, elements and activities assigned to, or stationed in the South Florida area; ensure adherence to management, administrative, operational, and safety requirements of the DOL standard operating procedures; ensure that internal control checklists are prepared and submitted to meet established suspense dates and that corrective actions are completed within acceptable timeframes.

## 12. **PERFORMANCE STANDARDS AND QUALITY MEASUREMENT:**

12.1 Performance standards define desired services. The Government performs surveillance to determine if the Contractor exceeds, meets, or does not meet these standards. The Government shall use these standards to determine Contractor performance and shall compare Contractor performance to the Acceptable Quality Level (AQL). The Quality Assurance Surveillance Plan (QASP) method of surveillance will be by random inspection.

12.2 Performance Evaluation: After acceptance of the contract, the system will be monitored for equipment performance including but not limited to; safety (recall Notifications and changes in reagents and equipment notifications), quality assurance (emergency repair response, hot line troubleshooting response, quality of results compared to peer groups and CAP survey performance) and documentation (invoice accountability and invoice verification, equipment specification and user manuals), customer satisfaction (response to complaints and laboratory employees training).

## SECTION E - SOLICITATION PROVISIONS

- (2) Federal Supply Group (FSG) 87, Agricultural Supplies;
- (3) FSG 88, Live Animals;
- (4) FSG 89, Food and Related Consumables;
- (5) FSC 9410, Crude Grades of Plant Materials;
- (6) FSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) FSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) FSC 9610, Ores;
- (9) FSC 9620, Minerals, Natural and Synthetic; and
- (10) FSC 9630, Additive Metal Materials.

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

"Restricted business operations" means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—
