1. **Contracting Activity:** This Justification for Other Than Full and Open Competition is prepared by the Department of Veterans Affairs Network Contracting Office (NCO 6) on behalf of the Veterans Affairs Medical Center in Fayetteville, NC in support of Purchase Request No 565-14-3-1019-0113.
2. **Nature and/or Description of the Action Being Processed:** This justification provides the rationale for soliciting using Brand Name Only for Olympus 30 Watt Laser and Fibers. A competitive RFQ will be issued as a small business set-aside. A firm fixed price Purchase Order is planned with a required delivery date of June 01, 2015.
3. **Description of Supplies/Services Required to Meet the Agency's Needs:** Items needed in the Urology section to perform surgery in the Fayetteville Health Care Center (HCC):

5. Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority): VAMC

Fayetteville currently has the Olympus 30 watt Holmium laser and urology instrumentation. The new Fayetteville HCC requires the same brand equipment for standardization between the facilities. The urologists will be performing surgery at both sites of care. If different instrumentation were used, they would have to be trained and maintain competency on two different systems. In addition to the clinical staff, biomed and sterilization processing personnel would also require training, and would have to maintain competency on maintenance and sterilization procedures for two different systems. Introduction of a different system could increase the potential for error and pose a risk to patient safety. Accordingly, Olympus is the only brand capable of meeting the requirement without the facility experiencing substantial duplication of cost that is not expected to be recovered through competition.

6. Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable: These particular Olympus items for urology are not under GSA/FSS. A Sources Sought notice was posted to FBO seeking interested contractors. Responses were received from 2 SDVOSBs and 1 small business, all offering the Olympus brand.

7. Determination by the Contracting Officer that the Anticipated Cost to the Government will be and Reasonable. The price will be determined fair and reasonable based on competition.

8. Description of the Market Research Conducted and the Results, or a Statement of the Reason Market Research Was Not Conducted: Market research conducted on GSA Advantage, GSA E- Library, the VA National Acquisition Center catalog and other government databases the part number and nomenclature.






