
The Chaperone Exit System, and recovery chair positions are not found on competitors' products; increasing risk of flight and patient injury. This is the only motorized stretcher with a dual zone exit alarm.
6. **Describe your market research efforts and efforts to ensure that offers are solicited from as many potential sources as is practicable:** Searches under Unicor, Ability1, and GSA Advantage found no products which meet the minimum requirements. Research on competitors' websites has shown that other patient stretchers do not offer all the salient features required by the facility that the Stryker Patient Stretchers does. Hill Rom and Pedigo stretchers were researched, but do not grant the necessary level of safety for patients and staff. The Hill Rom and Pedigo stretchers do not offer all of the features that the Stryker Stretcher does, including the Chaperone Exit System and Recovery Chair Position. These unique features are required to help increase the quality of care and safety of patients. Any other products will result in increased injury/flight risk, and a reduced level of patient care.
7. **State why you feel that the anticipated cost to the Government will be fair and reasonable:** This acquisition will be competed as an SDVOSB set-aside to ensure competition and reasonable pricing.






