The Department of Veterans Affairs in Erie, Pennsylvania requires a service contract for the digital x-ray equipment that is in use. The equipment covered under this contract is listed below and includes the generator, tube, wall bucky, table, computer, and the fluoroscopy monitor.

It is the intent of the Erie VA Medical Center to award a contract for one base year plus four – one year option periods. The Period of Performance can be seen in Section B. of this solicitation and resulting contract.

Services:

The services covered under this contract include, but are not limited to, the following.

- Technical inspections
- Cleaning, lubricating
- Adjusting, calibrating
- Installation of preventative maintenance kits
- Replacing parts including the x-ray tube and all other tubes
- Replacing batteries as needed
- Troubleshooting and repair
- Updating of software and travel zone charges without additional cost to the Government
- Maintaining the equipment in first-class operating condition to include all emergency calls in between regular inspections
- Excepted services are those necessitated by fire, accident, or abuse

Services are to be performed between the hours 8:00am and 4:30pm, Monday through Friday, unless otherwise approved by the Biomedical Engineering COR. The Contractor shall confirm the date of the preventative maintenance inspection 48 hours prior to the date of the planned visit.

Emergency Repairs

The Contractor is required to respond by telephone within two (2) hours after notification of an emergency repair for the equipment. A service technician shall arrive at the Medical Center within 24 hours to evaluate or initiate repair of the equipment. The repair shall be completed as expeditiously as possible to minimize downtime. The following VAMC employees are authorized to make Emergency Repair calls.

1. Jerry Skalko, Spvr. Biomedical Equipment Support Specialist
2. Steve Sommers, Biomedical Equipment Support Specialist
3. Ann Pesta, Biomedical Equipment Support Specialist
4. Ken Watkins, Medical Equipment Repairer
5. Chief of Engineering

Any work directed by an unauthorized employee will be done at the liability of the Contractor. All work shall be performed in accordance with all commercial “good manufacturing practices”.

Replacement Parts, Hardware Upgrades, and Software Upgrades

Only new standard parts produced by the manufacturer shall be furnished and installed by the Contractor. All parts shall be of current manufacturer and shall have full versatility with the equipment in use. The Contractor shall maintain an adequate supply of parts so that no delays will occur in returning the equipment to operational status. All software upgrades, necessary to correct operational problems, shall be provided by the Contractor and at no additional cost to the Government. The Contractor shall inform the COR of any operational changes that may occur due to software upgrade

and user training shall be provided for these changes. The Contractor shall obtain approval from the authorized persons listed above, prior to using any parts/supplies that are not covered under this contract.

Frequency of Inspections

The equipment covered under this contract will receive one (1) preventative maintenance inspection per year. The preventative maintenance inspection will be performed during the month of July of each contract year. Within 30 days after receipt of contract award, the Contractor and the VAMC will establish a mutually-acceptable schedule for the PM inspections for each piece of equipment listed. In no event shall the schedule be deviated from by more than two (2) weeks without the approval of the Contracting Officer or the Contracting Officer's Representative.

Inspection of Premises and Equipment

Offerors are encouraged to visit the Medical Center to become fully aware of the condition under which services will be performed. Offerors shall make technical inspections of the equipment to ensure a thorough knowledge of existing conditions. The submission of an offer to maintain the equipment shall constitute acceptance of the equipment in the existing condition. If the equipment is not in acceptable working condition, the cost to bring the equipment to an acceptable state shall be included in the cost of this contract and will not result in an additional cost to the Government. The Contracting Officer reserves the right to either order the equipment repaired or delete the specific item of equipment from the contract.

Reports

Contractor employees shall report to the Medical Center Police Department to sign-in and obtain a visitor's badge prior to performing any services under this contract. The contractor shall then notify the Contracting Officer's Representative of their arrival on station. Upon completion of the services provided, the Contractor's representative shall inform the Contracting Officer's Representative and provide a copy of the service report. The report shall include:

- Date of service
- Equipment serviced
- Action taken
- Parts replaced
- Any costs not covered under the service contract
- Signature of authorized VAMC employee
- Copy of all pertinent data and test results against the equipment

Evaluation of Offerors

All offerors shall submit documentation, along with their quote, verifying their competency to work on the equipment. The documentation may consist of a letter from the manufacturer verifying the representative has been trained or a Manufacturer's training certificate.

Information Security

1. General

Information made available to the contractor or subcontractor by VA for the performance or administration of this contract or information developed by the contractor in performance or administration of the contract shall be used only for those purposes and shall not be used in any other way without the prior written agreement of the VA.

2. Security Incident Investigation

Upon discovery of any known or suspected security/privacy incidents or any unauthorized disclosure of sensitive information, including that contained in system(s) to which the contractor/subcontractor has access, the contractor/subcontractor shall immediately and simultaneously notify the COTR, the designed ISO, and Privacy Officer for the contract. The term "security incident" means an event that has, or could have, resulted in unauthorized access to, loss or damage to VA assets, or sensitive information, or an action that breaches VA security procedures.

3. Liquidated Damages for Data Breach

- a) In the event of a data breach or privacy incident involving any SPI (sensitive personal information) the contractor processes or maintains under this contract, the contractor shall be liable to VA for liquidated damages for a specified amount per affected individual to cover the cost of providing credit protection services to those individuals.
- b) Based on the determinations of an independent risk analysis, the contractor shall be responsible for paying to the VA liquidated damages in the amount of \$37.50 per affected individual to cover the cost of providing credit protection services to affected individuals consisting of the following:
 - a. Notification;
 - b. One year of credit monitoring services consisting of automatic daily monitoring of at least 3 relevant credit bureau reports;
 - c. Data breach analysis;
 - d. Fraud resolution services, including writing dispute letters, initiating fraud alerts and credit freezes, to assist affected individuals to bring matters to resolution;
 - e. One year of identity theft insurance with \$20,000.00 coverage at \$0 deductible; and
 - f. Necessary legal expenses the subjects may incur to repair falsified or damaged credit records, histories, or financial affairs.

Training

1. Before being granted access to VA information or information systems, all contractor employees and subcontractor employees requiring such access shall complete on an annual basis either: (i) the VA security/privacy awareness training (contains VA security/privacy requirements) within 1 week of the initiation of the contract, or (ii) security awareness training provided or arranged by the contractor that conforms to VA's security/privacy requirements as delineated in the hard copy of the VA security awareness training provided to the contractor. If the contractor provides their own training that conforms to VA's requirements, they will provide the COTR or CO a yearly report (due annually on the date of the contract initiation) stating that all applicable employees involved in VA's contact have received their annual security/privacy training that meets VA's requirements and the total number of employees trained.
2. Before being granted access to VA information or information systems, all contractor employees and subcontractor employees requiring such access shall sign on an annual basis an acknowledgment that they have read, understand, and agree to abide by VA's Contractor Rules of Behavior which is attached to this contract (Appendix D). *Note: If a medical device vendor anticipates that the services under the contract will be performed by 10 or more individuals, the Contractor Rules of Behavior may be signed by the vendor's designated representative. The contract must reflect by signing the Rules of Behavior on behalf of the vendor that the designated representative agrees to ensure that all such individuals review and understand the Contractor Rules of Behavior when accessing VA's information and information systems*
3. The contractor shall provide to the VA COR a copy of the completed training certificate(s).

Performance Measures

The Contractors performance will be evaluated for each contract year. Documentation will be maintained by the COR on the Contractors compliance with the performance measurements. Failure to meet the performance requirements could result in the loss of future consideration for a contract. The performance measurements are:

- a) The Contractor must obtain an Identification badge, from the Police office, and notify the Biomed department of their arrival on station. This must occur each time the Contractor arrives on station to perform preventive maintenance inspections or repairs.
- b) The Contractor must perform the preventive maintenance inspections during the months scheduled, according to the contract.

- c) The Contractor will provide all preventive maintenance and repair documentation to the Biomedical Engineering department.
- d) The Contractor must provide copies of the Completion Certificate for Privacy Awareness and Cyber Security training to the COR before December 31 of each contract year.

The Contractor shall provide sufficient experienced personnel during the phase-in, phase-out period to ensure that the services called for by this contract are maintained at the required level of proficiency.

(c) The Contractor shall allow as many personnel as practicable to remain on the job to help the successor maintain the continuity and consistency of the services required by this contract. The Contractor also shall disclose necessary personnel records and allow the successor to conduct on-site interviews with these employees. If selected employees are agreeable to the change, the Contractor shall release them at a mutually agreeable date and negotiate transfer of their earned fringe benefits to the successor.

(d) The Contractor shall be reimbursed for all reasonable phase-in, phase-out costs (i.e., costs incurred within the agreed period after contract expiration that result from phase-in, phase-out operations) and a fee (profit) not to exceed a pro rata portion of the fee (profit) under this contract.

SECTION E - SOLICITATION PROVISIONS

E.1 52.212-2 EVALUATION—COMMERCIAL ITEMS (JAN 1999)

(a) The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate offers:

Lowest-Priced, Technically Acceptable

Technical and past performance, when combined, are not as important as price.

(b) *Options*. The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. The Government may determine that an offer is unacceptable if the option prices are significantly unbalanced. Evaluation of options shall not obligate the Government to exercise the option(s).

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

E.2 52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS—COMMERCIAL ITEMS (MAY 2014) ALTERNATE II (JAN 2012)

An offeror shall complete only paragraph (b) of this provision if the offeror has completed the annual representations and certifications electronically via <http://www.acquisition.gov>. If an offeror has not completed the annual representations and certifications electronically at the System for Award Management (SAM) website, the offeror shall complete only paragraphs (c) through (o) of this provision.

(a) Definitions. As used in this provision—

"Economically disadvantaged women-owned small business (EDWOSB) concern" means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States and who are economically disadvantaged in accordance with 13 CFR part 127. It automatically qualifies as a women-owned small business eligible under the WOSB Program.

"Forced or indentured child labor" means all work or service—

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

"Inverted domestic corporation", as used in this section, means a foreign incorporated entity which is treated as an inverted domestic corporation under 6 U.S.C. 395(b), i.e., a corporation that used to be incorporated in the United States, or used to be a partnership in the United States, but now is incorporated in a foreign country, or is a subsidiary whose

parent corporation is incorporated in a foreign country, that meets the criteria specified in 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c). An inverted domestic corporation as herein defined does not meet the definition of an inverted domestic corporation as defined by the Internal Revenue Code at 26 U.S.C. 7874.

"Manufactured end product" means any end product in Federal Supply Classes (FSC) 1000-9999, except—

- (1) FSC 5510, Lumber and Related Basic Wood Materials;
- (2) Federal Supply Group (FSG) 87, Agricultural Supplies;
- (3) FSG 88, Live Animals;
- (4) FSG 89, Food and Related Consumables;
- (5) FSC 9410, Crude Grades of Plant Materials;
- (6) FSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) FSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) FSC 9610, Ores;
- (9) FSC 9620, Minerals, Natural and Synthetic; and
- (10) FSC 9630, Additive Metal Materials.

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

"Restricted business operations" means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
- (2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;
- (3) Consist of providing goods or services to marginalized populations of Sudan;
- (4) Consist of providing goods or services to an internationally recognized peacekeeping force or humanitarian organization;
- (5) Consist of providing goods or services that are used only to promote health or education; or
- (6) Have been voluntarily suspended.

"Sensitive technology"—

- (1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—

- (i) To restrict the free flow of unbiased information in Iran; or
- (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

"Service-disabled veteran-owned small business concern"—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

"Small business concern" means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

"Subsidiary" means an entity in which more than 50 percent of the entity is owned—

- (1) Directly by a parent corporation; or
- (2) Through another subsidiary of a parent corporation.

"Veteran-owned small business concern" means a small business concern—

(2) *Representation and certifications.* Unless a waiver is granted or an exception applies as provided in paragraph (o)(3) of this provision, by submission of its offer, the offeror—

(i) Represents, to the best of its knowledge and belief, that the offeror does not export any sensitive technology to the government of Iran or any entities or individuals owned or controlled by, or acting on behalf or at the direction of, the government of Iran;

(ii) Certifies that the offeror, or any person owned or controlled by the offeror, does not engage in any activities for which sanctions may be imposed under section 5 of the Iran Sanctions Act; and

(iii) Certifies that the offeror, and any person owned or controlled by the offeror, does not knowingly engage in any transaction that exceeds \$3,000 with Iran's Revolutionary Guard Corps or any of its officials, agents, or affiliates, the property and interests in property of which are blocked pursuant to the International Emergency Economic Powers Act (50 U.S.C. 1701 *et seq.*) (see OFAC's Specially Designated Nationals and Blocked Persons List at <http://www.treasury.gov/ofac/downloads/t11sdn.pdf>).

(3) The representation and certification requirements of paragraph (o)(2) of this provision do not apply if—

(i) This solicitation includes a trade agreements certification (*e.g.*, 52.212–3(g) or a comparable agency provision); and

(ii) The offeror has certified that all the offered products to be supplied are designated country end products.

E.3 52.217-5 EVALUATION OF OPTIONS (JUL 1990)

Except when it is determined in accordance with FAR 17.206(b) not to be in the Government's best interests, the Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. Evaluation of options will not obligate the Government to exercise the option(s).

However, the Government reserves the right to conduct exchanges if later determined by the contracting officer to be necessary.

E.6 52.209-5 REPRESENTATION BY CORPORATIONS REGARDING AN UNPAID TAX LIABILITY OR A FELONY CONVICTION UNDER ANY FEDERAL LAW (DEVIATION)(MAR 2012)

(a) In accordance with Division H, sections 8124 and 8125 of P.L. 112-74 and sections 738 and 739 of P.L. 112-55 none of the funds made available by either Act may be used to enter into a contract with any corporation that—

(1) Has an unpaid federal tax liability, unless the agency has considered suspension or debarment of the corporation and the Suspension and Debarment Official has made a determination that this action is not necessary to protect the interests of the Government.

(2) Has a felony criminal violation under any Federal or State law within the preceding 24 months, unless the agency has considered suspension or debarment of the corporation and Suspension and Debarment Official has made a determination that this action is not necessary to protect the interests of the Government.

(b) The Offeror represents that—

(1) The offeror does ☐ does not ☐ have any unpaid Federal tax liability that has been assessed and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability.

(2) The offeror, its officers or agents acting on its behalf have ☐ have not ☐ been convicted of a felony criminal violation under a Federal or State law within the preceding 24 months.
