

This is a copier lease contract, period of performance 10-1-2014 to 12-31-2014. This is an interim measure to continue copier service until a base plus four 1 year options contract is in place beginning 10-1-2014. This bridge will allow new contractors to install their equipment while the incumbent removes their equipment if required.</p>				
<p>8. Dollar Value of proposed purchase and past experience concerning vendor's prices. \$106,828.50. Previous NovaCopy pricing is considered fair and equitable to Konica Minolta GSA contract GS-25F-0030M equipment and is already in place. Competing for another vendor will leave Memphis VAMC without copier service beginning 9-30-2014 until a new contractor can install their own equipment.</p>
