The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. PROCUREMENT STATEMENT OF NEED

Bulk Salt Brine Solution and/or 100% Bulk Road Rock Salt

The Erie VAMC has a current need for bulk salt brine solution and/or bulk road rock salt at the Erie VAMC. It is the intent of the Erie VAMC to establish a BPA with 1 base plus 4 options years. Vendor shall provide pricing for 100% bulk rock salt and/or bulk salt brine solution.

Vendors may just quote one line item (bulk rock salt or bulk salt brine solution) if they do not offer both. Vendors must quote a price for all option years. Offers will be evaluated based on Lowest-priced, Technically Acceptable criteria per the average of the base option years pricing provided. The VA reserves the right to award BPAs to more than one vendor.

-- Services --

PROVIDE: The contractor shall procure and deliver bulk road rock salt (100%) and/or bulk salt brine solution to the Erie VA Medical Center 562 (EVAMC). The government reserves the right to select more than one bidder to provide one or the other or both to the Erie VAMC. Bidders need to indicate which form they will be providing and the cost of providing one or both mixtures. Bidders do not need to bid on that mixture to which they cannot provide.

-- Project Scope --

GENERAL: The contractor shall procure and deliver item/s to the EVAMC Grounds Garage when notified via email or phone. The purpose is to melt snow and ice from asphalt and concrete lots and drives.

1. Bulk Salt Brine Solution

SPECIFICS:

- Contractor shall deliver bulk road salt brine (product) to the EVAMC Grounds Garage at 135 E. 38th St, Erie, PA or to a similar location on the EVAMC main campus as directed by the Contracting Officer's Representative (COR).
- Deliveries shall be made Monday-Friday between the hours 7 AM and 2 PM, excluding federal holidays.
- There will be no minimum seasonal quantity.

- Maximum seasonal quantity not to exceed 24,000 gallons.
- Contractor shall have sufficient quantity available at all times to provide EVAMC with up to 2000 gallons of product within 24 hours of COR's notification of need.
- Minimum quantity to deliver will be 1500 gallons and maximum of 2000 gallons.
- Contractor shall move the liquid product from the delivery vehicle into the EVAMC storage container.
- Product shall meet all of the following chemical composition criteria (target 23% salt, 77% water, Specific Gravity 1.176, Salometer 85%):
 1. Calcium Chloride 10-15%
 2. Sodium Chloride 10-15%
 3. Potassium Chloride 1-2%
 4. Magnesium Chloride 2-4%
 5. Water 64-77%
 6. Corrosion inhibitor
 7. Brine Performance Enhancer acceptable
- No solids are allowable in the solution. Product must be in liquid form. Product must be formulated as to remain in liquid form when exposed to storage in out of doors, ambient conditions.
- All specification sheets must be submitted to CO for COR evaluation with bid submittal. Substitute chemical compositions may be submitted to CO for COR evaluation of suitability for this contract.
- Product shall be compatible with dispersion using truck mounted sprayer.
- Product shall be safe for handling by personnel without the need for personal protection equipment.
- Product shall be environmentally safe for its intended use of outdoor snow and ice removal.
- Product shall not be permanently staining to pavement.
- Product shall arrive in a free flowing and usable condition.
- Product shall not require heating at an ambient temperature 0°F.
- Product must remain stable when stored in a sealed container exposed to out of doors, ambient conditions and sunlight for summer storage for up to 9 months.
- Contractor assumes responsibility for safe and legal transport of the product to EVAMC.

- Product containers must be properly labeled with the product name, information and hazard warnings.

2. **100% Rock Salt**

SPECIFICS:

- Contractor shall deliver item/s to the EVAMC Grounds Garage at 135 E. 38th St, Erie, PA or to a similar location on the EVAMC main campus as directed by the Contracting Officer's Representative (COR).
- Deliveries shall be made Monday-Friday between the hours 7 AM and 2 PM, excluding federal holidays.
- There will be no minimum seasonal quantity.
- Maximum seasonal quantity not to exceed 190 tons.
- No replenishment orders are expected to be placed by EVAMC after March 31 of each contract year.
- Contractor shall have sufficient quantity available at all times to provide EVAMC with up to 50 tons of bulk road rock salt within 24 hours of COR's notification of need.
- Minimum quantity to deliver will be 20 tons and maximum of 25 tons per order.
- Delivery shall be dropped at the location on the EVAMC main campus specified by the COR.
- EVAMC personnel shall be responsible for moving the salt from the drop location.
- Salt Product shall be in crushed nugget form. Flake product will not be acceptable. Sizing shall conform to the following test:
 1. Each sample shall be up to 1 pound in weight
 2. 3 samples shall be taken from different locations in the delivered lot at a depth of at least 1"
 3. 95% of each sample shall be between 1/4" and 5/8" in size inclusive.
- Rocks or other foreign material must be absent from the delivered product.
- Composition shall be minimum 95% Sodium Chloride and treated with Yellow Prussiate of Soda (YPS) or similar anticaking compound.
- All specification sheets must be submitted to CO for COR evaluation with bid submittal. Substitute chemical compositions may be submitted to CO for COR evaluation of suitability for this contract.

- Product shall be compatible with dispersion using hand, drop and broadcast spreading.
- Product shall be safe for handling by personnel without the need for personal protection equipment.
- Product shall be colored to visually ensure proper dispersion of the solid product.
- Product shall not be permanently staining to pavement.
- Product shall arrive in a free flowing, dry and usable condition. Product must not be caked or clumped.
- Contractor assumes responsibility for safe and legal transport of the product to EVAMC.

-- Privacy Training--

EXPECTATION: VA Privacy and Information Security Awareness Course must be completed by all contractors and subcontractor employees assigned to VA accounts prior to delivery of service and annually thereafter.

SECTION C - CONTRACT CLAUSES

C.1 52.216-2 ECONOMIC PRICE ADJUSTMENT—STANDARD SUPPLIES (JAN 1997)

(a) The Contractor warrants that the unit price stated in the Schedule for is not in excess of the Contractor's applicable established price in effect on the contract date for like quantities of the same item. The term "unit price" excludes any part of the price directly resulting from requirements for preservation, packaging, or packing beyond standard commercial practice. The term "established price" means a price that—

(1) Is an established catalog or market price for a commercial item sold in substantial quantities to the general public; and

(2) Is the net price after applying any standard trade discounts offered by the Contractor.

(b) The Contractor shall promptly notify the Contracting Officer of the amount and effective date of each decrease in any applicable established price. Each corresponding contract unit price shall be decreased by the same percentage that the established price is decreased. The decrease shall apply to those items delivered on and after the effective date of the decrease in the Contractor's established price, and this contract shall be modified accordingly.

(c) If the Contractor's applicable established price is increased after the contract date, the corresponding contract unit price shall be increased, upon the Contractor's written request to the Contracting Officer, by the same percentage that the established price is increased, and the contract shall be modified accordingly, subject to the following limitations:

(1) The aggregate of the increases in any contract unit price under this clause shall not exceed 10 percent of the original contract unit price.

(2) The increased contract unit price shall be effective—

(i) On the effective date of the increase in the applicable established price if the Contracting Officer receives the Contractor's written request within 10 days thereafter; or

(ii) If the written request is received later, on the date the Contracting Officer receives the request.

(3) The increased contract unit price shall not apply to quantities scheduled under the contract for delivery before the effective date of the increased contract unit price, unless failure to deliver before that date results from causes beyond the control and without the fault or negligence of the Contractor, within the meaning of the Default clause.

(4) No modification increasing a contract unit price shall be executed under this paragraph (c) until the Contracting Officer verifies the increase in the applicable established price.

(5) Within 30 days after receipt of the Contractor's written request, the Contracting Officer may cancel, without liability to either party, any undelivered portion of the contract items affected by the requested increase.

(d) During the time allowed for the cancellation provided for in paragraph (c)(5) of this clause, and thereafter if there is no cancellation, the Contractor shall continue deliveries according to the contract delivery schedule, and the Government shall pay for such deliveries at the contract unit price, increased to the extent provided by paragraph (c) of this clause.

E.5 52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS—COMMERCIAL ITEMS (MAY 2014)

An offeror shall complete only paragraph (b) of this provision if the offeror has completed the annual representations and certifications electronically via <http://www.acquisition.gov>. If an offeror has not completed the annual representations and certifications electronically at the System for Award Management (SAM) website, the offeror shall complete only paragraphs (c) through (o) of this provision.

(a) *Definitions.* As used in this provision—

"Inverted domestic corporation", as used in this section, means a foreign incorporated entity which is treated as an inverted domestic corporation under 6 U.S.C. 395(b), i.e., a corporation that used to be incorporated in the United States, or used to be a partnership in the United States, but now is incorporated in a foreign country, or is a subsidiary whose parent corporation is incorporated in a foreign country, that meets the criteria specified in 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c). An inverted domestic corporation as herein defined does not meet the definition of an inverted domestic corporation as defined by the Internal Revenue Code at 26 U.S.C. 7874.

"Manufactured end product" means any end product in Federal Supply Classes (FSC) 1000-9999, except—

- (1) FSC 5510, Lumber and Related Basic Wood Materials;
- (2) Federal Supply Group (FSG) 87, Agricultural Supplies;
- (3) FSG 88, Live Animals;

- (4) FSG 89, Food and Related Consumables;
- (5) FSC 9410, Crude Grades of Plant Materials;
- (6) FSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) FSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) FSC 9610, Ores;
- (9) FSC 9620, Minerals, Natural and Synthetic; and
- (10) FSC 9630, Additive Metal Materials.

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

"Restricted business operations" means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
- (2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;
- (3) Consist of providing goods or services to marginalized populations of Sudan;
- (4) Consist of providing goods or services to an internationally recognized peacekeeping force or humanitarian organization;
- (5) Consist of providing goods or services that are used only to promote health or education; or
- (6) Have been voluntarily suspended.

"Sensitive technology"—

- (1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—
 - (i) To restrict the free flow of unbiased information in Iran; or
 - (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and
- (2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

"Service-disabled veteran-owned small business concern"—

- (1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

"Small business concern" means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

"Subsidiary" means an entity in which more than 50 percent of the entity is owned—

- (1) Directly by a parent corporation; or
- (2) Through another subsidiary of a parent corporation.

"Veteran-owned small business concern" means a small business concern—

(1) That is at least 51 percent owned by one or more women; or, in the case of any publicly owned business, at least 51 percent of the stock of which is owned by one or more women; and

(2) Whose management and daily business operations are controlled by one or more women.

"Women-owned small business (WOSB) concern eligible under the WOSB Program" (in accordance with 13 CFR part 127), means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States.

(b)(1) *Annual Representations and Certifications.* Any changes provided by the offeror in paragraph (b)(2) of this provision do not automatically change the representations and certifications posted on the SAM website.
