 - a. Currently, Attachment I: Master Filter List, contains all the exact sizes required. As equipment is retired and/or replaced and new equipment is put into service, the Master List will be updated on an as needed basis.
2. Will they be rated for standard capacity or high capacity?
 - a. HEPA Filters requirements are for standard capacity.
3. Are they going to be a c-style frame or other?
 - a. HEPA Filters are not C-style.
