B.4 STATEMENT OF WORK

Statement of Work for HIV Animal Research

Contractor shall furnish all goods and services required to perform the non-human primate studies outlined in the Veterans Affairs (VA) funded merit review project, #INFA-012-11F: Chimeric SHIV VLP as an Oral Mucosal HIV Vaccine” which is funded by the Veterans Health Administration’s Office of Research and Development (OR&D), Biomedical Laboratory Research and Development Program. The project is led by Principal Investigator for 2 periods (period 1 consisting of 8 months and period 2 consisting of 6 months).

This proposal aims to: identify effective orally administered immunogen; determine the optimal easy and effective immunization route; and uncover the mechanism of action whereby this vaccine can induce potent mucosal immune responses to protect from mucosal viral challenge. This study will increase our understanding of oral mucosal immunity, which may contribute to future oral mucosal vaccine design.

Required Goods:

-Purchase/ Supply of Rhesus macaques species. Animals will be male ≥ 2 years of age and of Indian origin. Study will include a total of 13 animals.

-Animal tests: HIV vaccine challenge studies which will provide valuable information regarding the ability of humoral and cellular immune responses to our vaccine candidates. Testing will evaluate the vaccine potential of different chimeric SHIV VLPs mucosal immunization in protecting Indian-origin rhesus macaques from mucosal routes challenge with pathogenic strains of simian human immunodeficiency virus: SHIVSF162p3. Data gathered will be analyzed for determining antigen-specific cellular immune responses in macaques using various human reagents.

-Supplies for animal tests: Items include tissue culture media, serum and plastic supplies. Required Services:

-Veterinary Care: Animals will be cared for in accordance with Animal Welfare Act guidelines in an AAALAC (the Association for Assessment and Accreditation of Laboratory Animal Care) facility.

-Animal Housing: All animals will be provided with a clean, comfortable, adequately sized living quarters; fed and checked daily by the clinical veterinary staff including weekends and holidays.

-Medical Attention: Any animal discomfort or pain is alleviated by the appropriate use of anesthesia or analgesic drugs. All subjects will be chemically restrained with ketamine injection IM (11 mg/kg) for all clinical procedures (blood draw/lymph node biopsy) and inoculations. However, if an animal is moribund, unresponsive to treatment, cannot eat or drink, or severely sick, it will be euthanized as per guidelines. Lymph node and spleen samples as well as several intestinal and other mucosal tissues will be obtained at the time of complete necropsy.

-Testing Procedures: Appropriate measures will be taken to assure that discomfort, distress, pain and injury will be limited to that which is unavoidable in the conduct of the research plan. Procedures of the following type will be performed:

a. Immunization. Oral submucosal injection and Intradermal injection will be administered following ketamine sedation (i.e. injection at a dose of 11 mg/kg). Ags by oral submucosal immunization will be administered to the cheek buccal mucosa and intradermal immunization will be administered at both sides of the forearms. Analgesics will be used for any local pain at the injection site.

b. Bleedings. Peripheral venipuncture will be performed following sedation with Ketamine.

c. Surgical Procedures. Lymph node and mucosal biopsies will be performed under ketamine and/or Telazol anesthesia. Analgesics and non-steroidal anti-inflammatory agents will be used post-operatively as needed for pain and/or inflammation. Antibiotics will be chosen according to culture sensitivities in the event of bacterial infections.

d. Euthanasia. Euthanasia will be performed in the event of severe morbidity without possibility of medical or surgical correction and at the completion of studies. Contractor will utilize i.v. injection of sodium pentobarbital (100-200 mg/kg) for this purpose. This method is consistent with the recommendations of the Panel on Euthanasia of the American Veterinary Medical Association.

-Research Collaboration Required Personnel: Contractor's research group shall have over 20-plus years of experience in the area of HIV vaccine development employing various animal models including non-human primate models. Contractor must have adopted and standardized several analytical techniques for determining antigen-specific cellular immune responses in macaque using various human reagents. Contractor shall direct the macaque studies and coordinate with the Principal Investigator on any proposed changes to planned immunization/challenge studies.

Contractor shall provide the Research Investigator. The contractor shall be versed with a variety of virology and immunology techniques, specifically the flow cytometry for analyzing mucosal T cell responses in the rhesus model. The individual shall have a strong experience in safe handling of HIV/SHIV stocks as well as infected cells and tissues in the BSL-3 laboratories. Contractor's Research Investigator shall participate in periods 1 and 2 of the research in assaying for cellular immune responses along with flow cytometric analyses using the blood/tissue samples obtained from the rhesus monkeys.

The COTR (Contract Officer Technical Representative) will be appointed by the VA Medical Center and will be the primary contact for this project. The COTR will manage this agreement and will provide performance reports to the CO, Contract Office and will make sure that individuals have required security and background checks as required. Invoice payments shall be reviewed by the assigned COTR and approved prior to being submitted for payment to the service center and a copy shall be provided to the CO for the contract folder. Changes in the contract must be approved and can only be changed by the authorized Contract Officer representing the government.

SECTION E - SOLICITATION PROVISIONS

E.1 52.212-1 INSTRUCTIONS TO OFFERORS—COMMERCIAL ITEMS (APR 2014)

(a) *North American Industry Classification System (NAICS) code and small business size standard.* The NAICS code and small business size standard for this acquisition appear in Block 10 of the solicitation cover sheet (SF 1449). However, the small business size standard for a concern which submits an offer in its own name, but which proposes to furnish an item which it did not itself manufacture, is 500 employees.

(b) *Submission of offers.* Submit signed and dated offers to the office specified in this solicitation at or before the exact time specified in this solicitation. - (9) Acknowledgment of Solicitation Amendments;
- (10) Past performance information, when included as an evaluation factor, to include recent and relevant contracts for the same or similar items and other references (including contract numbers, points of contact with telephone numbers and other relevant information); and
- (11) If the offer is not submitted on the SF 1449, include a statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation. Offers that fail to furnish required representations or information, or reject the terms and conditions of the solicitation may be excluded from consideration.

(c) *Period for acceptance of offers.* The offeror agrees to hold the prices in its offer firm for 30 calendar days from the date specified for receipt of offers, unless another time period is specified in an addendum to the solicitation.

(f) Late submissions, modifications, revisions, and withdrawals of offers.

(1) Offerors are responsible for submitting offers, and any modifications, revisions, or withdrawals, so as to reach the Government office designated in the solicitation by the time specified in the solicitation. If no time is specified in the solicitation, the time for receipt is 4:30 p.m., local time, for the designated Government office on the date that offers or revisions are due.

(2)(i) Any offer, modification, revision, or withdrawal of an offer received at the Government office designated in the solicitation after the exact time specified for receipt of offers is "late" and will not be considered unless it is received before award is made, the Contracting Officer determines that accepting the late offer would not unduly delay the acquisition; and—

(A) If it was transmitted through an electronic commerce method authorized by the solicitation, it was received at the initial point of entry to the Government infrastructure not later than 5:00 p.m. one working day prior to the date specified for receipt of offers; or

(l) *Debriefing.* If a post-award debriefing is given to requesting offerors, the Government shall disclose the following information, if applicable:

- (1) The agency's evaluation of the significant weak or deficient factors in the debriefed offeror's offer.
- (2) The overall evaluated cost or price and technical rating of the successful and the debriefed offeror and past performance information on the debriefed offeror.

- (5) For acquisitions of commercial items, the make and model of the item to be delivered by the successful offeror.
- (6) Reasonable responses to relevant questions posed by the debriefed offeror as to whether source-selection procedures set forth in the solicitation, applicable regulations, and other applicable authorities were followed by the agency.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Should the taxpayer seek tax court review, this will not be a final tax liability until the taxpayer has exercised all judicial appeal rights.
