## B.3 PERFORMANCE WORK STATEMENT

### 1. BACKGROUND

The Department of Veterans Affairs (VA) Office of Financial Business Operations (OFBO) provides financial systems and operations services to VA administrations and staff offices. Among its responsibilities is enterprise-wide time reporting in support of accounting and personnel benefit services. Administrations of these services are complicated by the needs of Title 5 and Title 38 employees. To date, the VA employs a decentralized system to support time reporting throughout the enterprise. This system is referred to as the Enhanced Time and Attendance (ETA) System. OFBO and the VA Financial Services Center (FSC) are leading the effort to deploy VATAS to VA Central Office (VACO). Deployment activities will include role-based training for all VACO personnel. OFBO's and VA-FSC's plan is to conduct instructor-led, face-to-face training in a classroom environment. OFBO and VA-FSC have a requirement to secure the use of one (1) computer-equipped classroom.

### 2. SCOPE

VA-FSC is seeking a contractor to furnish and/or make available one (1) training room, equipment, and services to conduct training classes, over five (5) consecutive weeks (24 business days), in support of web-based common system user training for up to thirty (30) students per day. The VATAS training will be for 1400 VACO personnel in the Washington D.C. area. A total of 720 attendees will be trained at the contractor facility and the remaining 680 attendees will be trained at a VA training facility in the Washington D.C. area. VA-FSC VATAS personnel will be conducting the training and will provide the required training material to all participants.

### 3. PERIOD OF PERFORMANCE

The period of performance shall be for five (5) consecutive weeks (24 business days). The period of performance shall begin February 23, 2015 and end March 27, 2015. The specific training schedule/dates within this period of performance shall be coordinated between VA-FSC and the contractor.

### 4. PLACE OF PERFORMANCE

All work shall be performed at the Contractor's furnished facilities in Washington, D.C. Normal duty hours are defined as 8:00 a.m. to 4:30pm Monday through Friday except on Federal holidays.

There are ten (10) Federal holidays set by law (USC Title 5 Section 6103) that VA follows:

Under current definitions, four are set by date:

New Year's Day	January 1
Independence Day	July 4
Veterans Day	November 11
Christmas Day	December 25

**5. SPECIFIC TASKS**

- 5.1. The Contractor shall furnish and/or make available one (1) room to conduct training classes, over five (5) consecutive weeks (24 business days), in support of VATAS training for up to thirty (30) students per class/room. The training room shall be located in Washington, D.C.
- 5.2. The Contractor is solely responsible for compliance with the Occupational Safety and Health Act (OSHA) Public Law 91-596 – OSHA of 1970 and the resulting standards and OSHA Standard 29 CFR 1910 – Occupational Safety and Health to ensure all safety requirements are met.
- 5.3. The Contractor shall provide equipment and supplies to support a maximum of thirty (30) students to include, but not limited to, the following in the training room: tables, chairs, projector, screen, podium, microphone, conference phone, easel with papers and markers, and computers for each student plus trainer.
- 5.4. The Contractor shall provide Information Technology support for administration of commercial internet connection and Citrix access.
- 5.5. The Contractor shall provide classroom computers with internet capability for up to thirty (30) students.
- 5.6. The Contractor shall provide technical support on site to resolve hardware/software problems issues.
- 5.7. The Contractor shall provide the utility services within the training facility such as telephone, electricity, etc.
- 5.8. The Contractor shall provide audio/visual support for the duration of the training.
- 5.9. The Contractor shall provide Wi-Fi connectivity and internet access.
- 5.10. The Contractor shall be responsible for receiving, maintaining, and returning Government furnished supplies.
- 5.11. The Contractor shall have personnel available to provide administrative support during classroom training as required.

Purchases paid with a Government-wide commercial purchase card are considered to be an electronic transaction for purposes of this rule, and therefore no additional electronic invoice submission is required.

Submission of payment requests by mail may be required for:

(2) The offeror, its officers or agents acting on its behalf have  have not  been convicted of a felony criminal violation under a Federal or State law within the preceding 24 months.

### E.2 52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS—COMMERCIAL ITEMS (DEC 2014)

The offeror shall complete only paragraph (b) of this provision if the offeror has completed the annual representations and certifications electronically via <http://www.acquisition.gov>. “Manufactured end product” means any end product in Federal Supply Classes (FSC) 1000-9999, except—

- (1) FSC 5510, Lumber and Related Basic Wood Materials;
- (2) Federal Supply Group (FSG) 87, Agricultural Supplies;
- (3) FSG 88, Live Animals;
- (4) FSG 89, Food and Related Consumables;
- (5) FSC 9410, Crude Grades of Plant Materials;
- (6) FSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) FSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) FSC 9610, Ores;
- (9) FSC 9620, Minerals, Natural and Synthetic; and
- (10) FSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

(1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

(2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;

(3) Consist of providing goods or services to marginalized populations of Sudan;

(4) Consist of providing goods or services to an internationally recognized peacekeeping force or humanitarian organization;

(5) Consist of providing goods or services that are used only to promote health or education; or

(6) Have been voluntarily suspended.

“Sensitive technology”—

(1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—

(i) To restrict the free flow of unbiased information in Iran; or

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

“Service-disabled veteran-owned small business concern”—

(2) Through another subsidiary of a parent corporation.

“Veteran-owned small business concern” means a small business concern—

(1) Not less than 51 percent of which is owned by one or more veterans (as defined at 38 U.S.C. 101(2)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and

(2) The management and daily business operations of which are controlled by one or more veterans.

“Women-owned business concern” means a concern which is at least 51 percent owned by one or more women; or in the case of any publicly owned business, at least 51 percent of its stock is owned by one or more women; and whose management and daily business operations are controlled by one or more women.

“Women-owned small business concern” means a small business concern—

(1) That is at least 51 percent owned by one or more women; or, in the case of any publicly owned business, at least 51 percent of the stock of which is owned by one or more women; and
