### 2. BRIEF DESCRIPTION OF SUPPLIES OR SERVICES REQUIRED AND THE INTENDED USE:

This contract effort is for transitional housing services for the Pittsburgh VAMC. The Contractor provides a supervised environment, room and board, laundry facilities, and group activities. This is an interim contract effort which will cover the period of March 29, 2015 – August 1, 2015.

# 3. UNIQUE CHARACTERISTICS THAT LIMIT AVAILABILITY TO ONLY ONE SOURCE, WITH THE REASON NO OTHER SUPPLIES OR SERVICES CAN BE USED:

The current contract, VA244-P-1422, expires on March 28, 2015. The new contract will not be in place by that time, which will create a lapse in coverage, unless an interim contract is established. A lapse in coverage would mean that veterans would not be able to stay in the facility and would, therefore, be homeless which is unacceptable. The services required are highly specialized and require 24/7 attention and supervision. The Contractor's facility must be in compliance with federal and state laws and regulations and shall be located within 120 miles of the Pittsburgh VAMC. Shepard's Heart has been successfully performing services under this contact for the past five years. A lapse in coverage would be unacceptable.

### 4. REASON THAT SUGGESTED SOURCE IS THE ONLY SOURCE, WHICH CAN PROVIDE THE SUPPLIES OR SERVICES:

Veterans are currently residing in the facility at Shepard's Heart, which is located at 13 Pride Street, Pittsburgh, PA. There are three contracts for this service at the Pittsburgh VAMC: VA244-P-1422, VA244-13-D-0444; VA244-13-D-0452 and each Contractor's facility is located in a different area, thereby serving different veterans. Shepard's Heart has the capability to house up to three veterans at one time. The VA cannot move the veterans who are staying at Shepard's Heart to another location because there is no space available under the other contracts. A lapse in housing services would be unacceptable and cause the veterans to lose their housing services. Shepard's Heart has successfully performed under contract, VA244-P-1422 for the past five years.

## 5. DESCRIPTION OF MARKET RESEARCH CONDUCTED AND RESULTS OR STATEMENT WHY IT WAS NOT CONDUCTED:
