B.2 NOTICE TO OFFEROR

1. Introduction:

The Veteran Integrated Service Network (VISN) 22, Network Contracting Office (NCO) intends to establish a Lowest Price Technically Acceptable (LPTA) single award firm-fixed price (FFP) contract to provide Legionella testing for sampling for potable and non-potable water systems for the VA Southern Nevada Healthcare System (VASNHS).

- 2. Submission of Quotes:** Quotes must be returned to the below listed address no later than the date and time specified in block #8, Page #1 of the SF 1449. Quotes may be hand carried, submitted by mail through the U.S. Postal Service or commercial courier services (FedEx, UPS, etc.). Faxed quotations shall not be accepted. Emailed quotations are the preferred method of submitted quotes. The Government reserves the right to make award solely on initial quotes received. Offerors bear the burden of ensuring that all portions of the offer (and any authorized amendments) reach the designed office before the deadline specified in the solicitation. Quotations can be delivered to address shown in block #9, Page #1 of the SF 1449. **This RFQ shall be completed in its entirety, and signed and dated, failure shall not be considered for award.**

- 3. Contract Authority:** The Government will solicit and award this contract using Simplified Acquisition Procedures, in accordance with FAR subpart 13.5. As a result of this authority, certain requirements for soliciting, awarding, and notification are streamlined. In accordance with FAR 12.102(c), when a policy is inconsistent with FAR 12, Part 12 shall take precedence.

- 4. Period of Acceptance of Offerors:** The pricing terms and conditions of the quotes shall be valid for 30 days unless stated otherwise in the quote.

- 7. Performance Period:** One (1) base year contract with one (1) option year, base year starts 1 May 2015 to 30 April 2016.

8. Format Of Quotations:

This section specifies the contents and format that offerors shall use when submitting quotations. All offerors shall submit a technical quote and a price quote. Offerors must include the name, title, address, and phone number of the individual responsible for the inquiries to the quote. Offerors shall submit one quote. To expedite the review of quotations, offerors shall submit their quotes in sections based on the following format:

- a. Standard Form of the Contract (1449), Amendments: Standard Form of Contract (SF 1449). Blocks 17a, 30b, and 30c of page I of Standard Form 1449 shall be completed by offerors and Block 30a shall be signed to show the offeror has read and agrees to comply with all terms, conditions, and instructions provided in the solicitation document. SF 1449 shall be filled out in its entirety, signed, and dated, failure shall not be considered for award.

- b. Amendments. All amendments issued shall be signed and dated, failure shall not be considered for award.
- c. Price Quote: Price quotes shall contain pricing information. The prices shall be provided in the SF 1149, failure to provide pricing shall be cause for rejection of the quote.
- d. Technical Proposal: **Technical shall not contain pricing information nor contractors name, logo or trademarks.** General statements that the offeror can comply with the requirements will no, by themselves, be adequate. Failure to provide the technical information requested or providing unclear/inadequate information may be cause for rejection of the quote. One copy of the technical proposal shall be submitted unbound (email), to allow for reproduction for source selection purposes.

B.3 PERFORMANCE WORK STATEMENT

1. General Requirements:

The contractor shall provide all personnel, supervision, equipment, supplies, materials, facilities; transportation and resources necessary to collect water samples, pack, and ship samples to a Center for Disease Control and Prevention (CDC) Elite certified laboratory proficient at performing the culture of *Legionella* from environmental samples.

2. Description of Services:

The contractor performing field sampling shall provide all services, materials, labor, travel, and equipment necessary in order to collect water samples. The contractor must be familiar with the requirements specified within the Statement of Work and VHA Directive 1061 as well as the VA requirements and national standards, regulations and policies listed below:

Laboratories that process the water samples for *Legionella* must be certified by the Centers for Disease Control and Prevention (CDC) Environmental *Legionella* Isolation Techniques Evaluation (ELITE) program or the Public Health England (PHE) *Legionella* External Quality Assessment (EQA) scheme as proficient at performing the culture of *Legionella* from environmental samples. Information about CDC ELITE certified laboratories can be found at <https://wwwn.cdc.gov/elite/Public/MemberList.aspx>. Laboratories must also be able to determine if the *Legionella* detected in environmental samples is the species *Legionella pneumophila* serogroup 1.

3. Qualifications and Duties of the Contractor

- a) The contractor must demonstrate experience performing *Legionella* testing and reporting of in-patient hospitals, dormitories, and/or nursing home facilities.
- b) The contractor performing field sampling must meet all VA badging requirements for security.
- c) The contractor must have staffed personnel which can demonstrate formal training and/or education in environmental sciences or related coursework.
- d) The contractor performing field sampling and reporting must be a separate entity than the analytical lab providing the *Legionella* analysis (Testing Laboratory) in order to maintain free from a conflict of interest that can arise by a laboratory providing interpretation and consulting of test result.

- e) The contractor shall ensure that all employees drawing water samples shall provide proof of having taken and pass the annual TB test, and provide proof of having received other inoculations such as measles, mumps, rubella (MMR).
- f) The government reserves the right to refuse any contractor employee at any time.

4. Required Analytical Sampling:

The contractor will provide the labor and materials to conduct sampling for potable and non-potable water systems throughout the Medical Center. The sampling will be conducted on a scheduled quarterly basis, with a minimum of ten (10) outlets on the hot water distribution system and ten (10) outlets on the cold water distribution system; in all VHA buildings in which patients, residents, or visitors stay overnight. Additionally, water samples will be collected from, any hot or cold water storage tanks, heat exchangers, and from any other locations by request of the Contracting Officer Representative (COR). Samples must be delivered to the analytical laboratory within 30 hours from when they are collected. All sampling must be done by the contractor; no field work can be done by a subcontractor.

The contractor must be able to provide sampling within two (2) business days of notification from the COR. Samples will be collected at various locations throughout the facility as designated by the COR or his representative. Contractor must schedule for testing in all hospital buildings which house overnight patients as well as some additional high risk locations to include, but not limited to Emergency Department, Dental Clinic and Pharmacy. Samples will be collected using proper standard sampling techniques as described in the SOW. Proper chain of custody forms will be completed by the contractor during the collection of samples. Samples must be delivered to the testing laboratory per the CDC and VHA Directive 1061 for sample collection. The CDC Method for *Legionella* culturing known as "Procedures for the Recovery of *Legionella* from the Environment" will be used for the sample analysis. Other methods of *Legionella* analysis are prohibited. The contractor will provide a written report of the analytical sampling results within 10 to 14 days as described below. All aspects of water sampling will be held in strict confidence and are to be discussed only with the VA Engineering Service.

5. Qualifications, Sampling and Duties of the Contractor

- a. Contractor must have experience in *Legionella* testing.
- b. Prior to sample collection, the testing laboratory should be consulted regarding requirements and recommendations on sample collection to include sample volume and shipping. Sample collection must be conducted using the following procedures:
 - 1) Outlet will be run for 15 seconds prior to collecting sample.
 - 2) When sampling potable hot and cold water fixtures, cold water will be drawn prior to collection of hot water sample.
- c. At the time of sample collection, the following must be tested and documented:
 - 1) Water temperature testing using probe.
 - 2) Level of residual biocide using EPA approved method for potable water.
 - 3) pH testing using probe or equivalent.
- d. Sample collection bottles must have the following:
 - 1) Sterile plastic bottle with cap.
 - 2) Sodium thiosulfate preservative.
 - 3) Adhesive label with sample identification.
- e. Samples will be stored in an ice chest with cold packs until delivered to the laboratory. The Contractor will provide a written, electronic Analytical Interpretation from each Testing Laboratory report received. In addition, two hardcopies of each Analytical Interpretation must be provided to the COR. This report will be delivered within two (2) days of receipt of the testing laboratory results. If results indicate positive counts of *Legionella* bacteria, the COR will be contacted via phone, or email, the day of receipt of the results. This analytical interpretation will include the following:
 - 1) A description of the sampling project, including outlet locations, and results.

- 2) Recommendations for corrective actions, if necessary. These recommendations should be based on the facility's existing Water Safety Committee and the guidelines as per the VHA Directive 1061.

6. Qualifications and Duties of the Testing Laboratory

In accordance with VHA Directive 1061, the laboratory processing the water samples for *Legionella* must be certified by the CDC ELITE program as proficient at performing the culture of *Legionella* species from environmental samples. The testing laboratory will utilize the "CDC Method" for *Legionella* culturing known as "Procedures for the Recovery of *Legionella* from the Environment" this method includes the "Presumptive Phase" and "Confirmatory Phase" as described below:

- a. The "Presumptive Phase" will be used for potable water and non-potable water. Potable waters will be filtered and plated on Buffered Charcoal Yeast Extract (BCYE) agar for primary culturing of *Legionella*. Non-potable water requires an acid buffer treatment prior to plating on the BCYE. Due to the overall high bacterial count present in the non-potable water, this step is used to reduce the number of these non-legionella bacteria from the water before culturing.
- b. After the "Presumptive Phase", the "Confirmatory Phase" will be conducted. All colonies that do not grow on the BCYE agar plates will be analyzed using the "*Legionella* Latex Test". This test is a serology method used to identify *Legionella* colonies by its serotype. This test will determine *Legionella pneumophila* serogroup 1 and serogroup 2-14. It will also identify the presence of non-pneumophila *Legionella* bacteria, or "other *Legionella* species" including *Legionella anisa*, *Legionella bozemanii*, *Legionella dumoffii*, *Legionella gormanii*, *Legionella jordanis*, *Legionella longbeachae* 1 and 2, and *Legionella micdadei*.
- c. Upon completion of the *Legionella* culturing and enumeration, the original results will be emailed to the contractor for immediate interpretation. The testing laboratory shall submit copies of the reports tests promptly and directly to the contractor. All reports shall contain at least the following information:
 - 1) Testing Laboratory Name and Address
 - 2) Project Name/Lab Request Number
 - 3) NELAC Accreditation Number
 - 4) Sample Receipt Date
 - 5) Report Date
 - 6) Location of Sampling (i.e., building and room numbers)
 - 7) Name and Signature of Laboratory Director or Manager
 - 8) Copy of Chain of Custody Form
 - 9) Sample results in colony forming units per milliliter (cfu/ml)
 - 10) Water temperature, biocide residual level, and pH for each sample collected
 - 11) Method of Analysis

7. Water Sample Result Reporting and Tracking

- a. All positive sample result reports will be sent to the VA via email by contractor within 24 hours of the receipt of positive sample results from lab. A list of email recipients will be provided after contract award.
- b. Attached to email from contractor will be a recommended course of mitigation action.
- c. All sampling results will be tracked on a spreadsheet approved by the COR. The spreadsheet must include "L" results, free chlorine residual, pH, water temperature, date. Mitigation date, locations (room number) and retesting. Spreadsheet will be submitted monthly and after each retest cycle.
- d. Contractor shall meet with VA quarterly for contract/program review and testing result problems or issues.

8. **Contractor Employees:** Contractor personnel shall present a neat appearance and be easily recognized as contractor employees. Example: wearing of distinctive clothing such as uniform, badges, patches, etc.

9. Federal Legal Holidays

10. Note: Any of the above holidays falling on a Saturday will be observed on the preceding Friday; holidays falling on Sunday will be observed on the following Monday. Contractor's days to perform are reflected in the Performance Work Statement/Statement of Work.

11. Overtime and holidays: Any overtime or holiday pay that may be entitled to Contractor personnel performing under this contract shall be the sole responsibility of the Contractor and shall not be billed to nor reimbursed by the Government.

12. Parking policy: It is the responsibility of contractor personnel to park only in designated parking areas. Parking information is available from the VA Police. The VA shall not invalidate or make reimbursement for parking violations of contractor's personnel under any circumstances.

13. Smoking policy: Contractor personnel may smoke only in designated areas. Smoking is allowed in all outside areas that are 25 feet away from entrances to buildings unless indicated otherwise. Enclosed patios connected to facility buildings are considered part of the building and as such are non-smoking areas.

14. Ordering activity: Contractor shall not accept any instructions issued by any person other than the CO or COR acting within the limits of his/her authority.

15. Changes to Contract: Only those services specified herein are authorized. Before performing any service of a non-contractual nature, contractor shall advise the CO of the reason(s) for the additional work and/or service. Prior authorization must be obtained from the CO before performing the services.

16. Complaints: Contractor shall promptly and courteously respond to complaints within 3 working days. Including complaints brought to contractor's attention by the CO. Contractor shall maintain a written record of all complaints, both written and oral showing the identity of the individual, the nature of the complaint, and contractor's response. Contractor shall permit the Government to inspect such records upon reasonable notice.

17. Badges: All contractor personnel shall be required to wear VA provided identification (I.D.) badges above the waist at all times while on the VA grounds. Contractors shall be required to coordinate with COR in order to obtain the VA provided I.D. badges for all staff. All VA provided I.D. badges shall be returned at the end of the contract or upon completion of service. Failure to wear ID badges may result in removal from any of the VA facilities and/or otherwise referred to federal property.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub.
