**AGENCY NAME:** Department of Veterans Affairs, Office of Construction and Facilities Management.

**PROPOSED ACTION:** To procure a new lease for the Worcester Outpatient Clinic (OPC) for 5 years, with one 2-year renewal option. This justification is being submitted in accordance with the General Services Administration (GSAR) 570.402-4 to approve the procurement of a succeeding lease with a sole source as a result of identification of only one potential source.

DESCRIPTION OF REQUIREMENTS (INCLUDING ESTIMATED VALUE): The OPC provides area Veterans with services which include primary care; optometry; cardiology; mental health; neurology; podiatry; dermatology; rheumatology; geriatrics; laboratory test; physical therapy; radiology; rehabilitation medicine; nutrition counseling; preventive services such as annual flu and pneumonia shots; electrocardiograms; pharmacy, and preventive health. This succeeding lease is necessary to stay in place at the current facility location and prevent any interruption in service until the long-term solution can be approved and procured. A lease, not to exceed seven years, including all options, is being requested for 26,008 net usable square feet square feet (nusf). The annual rental for this space is approximately \$ (\$\left(\text{min}\)), unserviced, to commence on or about February 2015. One hundred and twenty-five parking spaces are included in the request. Should all options be exercised, the total contract value would be \$\left(\text{fully serviced}\).

**DESCRIPTION OF EFFORTS TO ENSURE SOLICITATION FROM MAXIMUM SOURCES PRACTICAL:** RPS placed an advertisement conforming to GSAR 570.402-2 on the Federal Business Opportunities Web site (fedbizopps.gov) on September 30, 2013, with the announcement number VA10113I0169 and received one response. The expression of interest was from the incumbent Lessor.

**DESCRIPTION OF MARKET SURVEY AND RESULTS:** Market research revealed three additional potential properties; however, each building was approximately 100,000
