SOLICITATION VA69D-15-R-0064

PERTINENT CHANGES TO THE SOLICITATION:

1. The maximum NET value of all task orders and modifications issued to a single contractor under this MATOC has been increased from \$9,000,000 to **\$20,000,000**
2. The NET AGGREGATE VALUE of all task orders and modifications awarded under this MATOC during the period of performance has been increased from \$10,000,000 to **\$26,000,000**.
3. Davis Bacon Wage Rate Determination MI117 has been updated to reflect DOL's modification 1 (published 3/20/2015). See Solicitation Attachment 7c in the attached, revised solicitation.

BIDDER RFI QUESTIONS/ANSWERS:

1. On the SF 1442, Section 13 does not give a date the Offers are due, only the time. Can you please provide the date? **VA RESPONSE: OFFERS ARE DUE 4/27/2015 AT THE TIME AND LOCATION SPECIFIED IN THE REVISED SOLICITATION, ATTACHED.**
2. The Site Visit time and date are listed as TBD in the Solicitation. I want to attend any scheduled Site Visit and do not want to miss the date. Can you please tell me the date and time? **VA RESPONSE: SITE VISIT WILL BE HELD ON FRIDAY, APRIL 10TH AT 10AM. PLEASE SEE PAGES 85 & 86 OF THE REVISED SOLICITATION, ATTACHED.**
3. I have a question about the Past Performance Questionnaires that are to be sent to our clients and returned to you. We have done many of these MATOC proposals and have asked the same clients for identical questionnaires many times. As many as 6-8 times for the same project. In lieu of asking them to fill out another PPQ, could we send you a previously completed form or, better yet, a final CPARS/CCASS rating for the same project? **VA RESPONSE: PLEASE FOLLOW THE INSTRUCTIONS PROVIDED IN THE SOLICITATION**
4. On the first page of the proposal instructions, you are requesting that an electronic copy of the proposal be sent to the Contracting Specialist via e-mail. On the next page under 4.5 Electronic copy, you mention electronic copies on CD-ROM. Please clarify. **VA RESPONSE: PLEASE PROVIDE AN ELECTRONIC COPY OF YOUR PROPOSAL ON A CD-ROM AND SHIP IT WITH YOUR HARD COPY PROPOSALS.**
5. You are asking for an offer guarantee in box 13 B of the 1442. Is that necessary for a Seed project that you do not intend on awarding? **VA RESPONSE: NO BID GUARANTEE IS REQUIRED FOR THE SEED PROJECT.**
6. Please confirm that the 15 page limit in the Quality Analysis Section does not include resumes that illustrate "Detailed information about key personnel" as requested in 5.3.4 **VA RESPONSE: PAGE LIMIT FOR THE QUALITY ANALYSIS SECTION HAS BEEN INCREASED TO 20 PAGES AND SHALL INCLUDE THE RESUMES.**
