## B.2 NOTICE TO OFFEROR

### 1. Introduction:

The Veteran Integrated Service Network (VISN) 22, Network Contracting Office (NCO) intends to establish a Lowest Price Technically Acceptable (LPTA) single award firm-fixed price (FFP) contract to provide Legionella testing for sampling for potable and non-potable water systems for the VA Greater Los Angeles Healthcare System (VAGLAHS).

- 2. Submission of Quotes:** Quotes must be returned to the below listed address no later than the date and time specified in block #8, Page #1 of the SF 1449. Quotes may be hand carried, submitted by mail through the U.S. Postal Service or commercial courier services (FedEx, UPS, etc.). Faxed quotations shall not be accepted. Emailed quotations are the preferred method of submitted quotes. The Government reserves the right to make award solely on initial quotes received. Offerors bear the burden of ensuring that all portions of the offer (and any authorized amendments) reach the designed office before the deadline specified in the solicitation. Quotations can be delivered to address shown in block #9, Page #1 of the SF 1449. This RFQ shall be completed in its entirety, and signed and dated, failure shall not be considered for award.

- 3. Contract Authority:** The Government will solicit and award this contract using Simplified Acquisition Procedures, in accordance with FAR subpart 13.5. As a result of this authority, certain requirements for soliciting, awarding, and notification are streamlined. In accordance with FAR 12.102(c), when a policy is inconsistent with FAR 12, Part 12 shall take precedence.

- 4. Period of Acceptance of Offerors:** The pricing terms and conditions of the quotes shall be valid for 30 days unless stated otherwise in the quote.

- 7. Performance Period:** One year contract from 1 May 2015 to 30 April 2016.

### 8. Format Of Quotations:

This section specifies the contents and format that offerors shall use when submitting quotations. All offerors shall submit a technical quote and a price quote. Offerors must include the name, title, address, and phone number of the individual responsible for the inquiries to the quote. Offerors shall submit one quote. To expedite the review of quotations, offerors shall submit their quotes in sections based on the following format:

- a. Standard Form of the Contract (1449), Amendments: Standard Form of Contract (SF 1449). Blocks 17a, 30b, and 30c of page I of Standard Form 1449 shall be completed by offerors and Block 30a shall be signed to show the offeror has read and agrees to comply with all terms, conditions, and instructions provided in the solicitation document. SF 1449 shall be filled out in its entirety, signed, and dated, failure shall not be considered for award.
- b. Amendments. All amendments issued shall be signed and dated, failure shall not be considered for award.
- c. Price Quote: Price quotes shall contain pricing information. The prices shall be provided in the SF 1149, failure to provide pricing shall be cause for rejection of the quote.
- d. Technical Proposal: **Technical shall not contain pricing information nor contractors name, logo or trademarks.** Offeror shall complete a self-certification and acknowledgement form (attached to RFQ) which will certify their understanding of the requirement and their technical approach to meeting the requirements of the Statement Of Work (SOW).

### B.3 STATEMENT OF WORK

#### 1. Scope of Work:

- a. The contractor shall provide the labor, transportation, and materials to conduct sampling for potable and non-potable water systems throughout the VA Greater Los Angeles Healthcare System.
- b. The sampling shall be conducted on a scheduled basis (Required Analytical Sampling). The contractor must be able to provide follow up sampling to positive results within 1 (one) business days of notification from the Contracting Officers Representative (COR).
- c. Samples shall be collected at various locations throughout the designated facility as designated by the COR.
- d. Chain of Custody forms shall be completed by the contractor during the collection of samples as described in SOW.
- e. Samples shall be obtained using sampling techniques as described in the SOW.
- f. Samples shall be delivered same-day as collected to a certified "Center for Disease Control" and Prevention (CDC) "Environmental *Legionella* Isolation Techniques Evaluation" (ELITE) laboratory located within Southern California.
- g. The "Center for Disease Control (CDC Method)" for *Legionella* culturing known as "Procedures for the Recovery of *Legionella* from the Environment" shall be used for the sample analysis
- h. The contractor shall provide a written report of the analytical sampling results within 10-14 calendar days to the COR.
- i. Upon receiving notice from the COR to begin sampling, the contractor shall ensure that all samples required are collected within a period no longer than 14 business days per quarter.

#### 2. Qualifications and Duties of the Contractor

- a. The contractor must demonstrate experience performing Legionella testing and reporting of in-patient hospitals, dormitories, and/or nursing home facilities.
- b. The contractor must have staffed personnel which can demonstrate formal training and/or education in environmental sciences or related coursework.
- c. The contractor must be able to report for sample collection within 24 hours' notice from facility management.
- d. The contractor performing field sampling and reporting shall not engage in the sale of Legionella detection and/or prevention chemicals or equipment. This is in order to avoid potential conflict of interest that can arise by a water treatment vendor providing interpretation and consulting of test results.

- e. The contractor performing field sampling and reporting shall be a separate entity than the analytical lab providing the Legionella analysis (Testing Laboratory) and must not own their own water testing lab.

**3. Sample Collection:** Sample collection shall be conducted following field protocols in accordance with the CDC Legionella Testing Method , while assuring that the following requirements are also met:

- a. Outlet shall be run for 15 seconds prior to collecting sample. When sampling potable hot and cold water fixtures, cold water shall be drawn prior to collection of the hot water sample.
- b. At the time of sample collection, the following must be tested and documented:
  - 1) Water temperature testing using probe.
  - 2) Level of Free Chlorine residual biocide using an EPA-approved DPD colorimeter. EPA-approved test strips have not shown adequate accuracy in the field compared to a colorimeter method; therefore, the use of the test strip in this contract is not allowed.
  - 3) pH testing using digital electronic probe or equivalent. Litmus strips or color matching are not acceptable methods due to lack of accuracy.
  - 4) Sterile 100-mL wide mouth plastic bottle with cap, or larger volume for sample collection if requested by the Water Safety Committee.
  - 5) Adhesive label with sample identification including the date and time the sample was taken
  - 6) Samples shall be stored in an insulated container until delivered to the laboratory. Samples shall be delivered same-day as collection to the certified CDC ELITE testing laboratory located in Southern California. **Overnight shipping of samples is prohibited.** A physical address of the Analytical Laboratory must be provided before and after each test to ensure that same-day delivery is feasible.
- c. The contractor shall provide a written, electronic Analytical Interpretation from each laboratory report received to the COR within 10 to 14 calendar days of sample gathering. In addition, one hard copy (8 ½"x11" portrait) of each Analytical Interpretation per building, per sampling event and one electronic file per building shall be provided to the COR. In addition, one excel spreadsheet per building, per sampling event containing sample ID, date drawn, location, room number, source, volume, temp, biocide level, ph, date sample sent to lab, date results received, results, lab sample ID and whether or not sample was stored for molecular typing. These reports shall be delivered within two (2) business days of receipt of the Testing Laboratory results. If results indicate positive counts of *Legionella* bacteria, the COR shall be contacted via phone, or email the same day as the receipt of the results unless results are released after 5pm, in which case facility management will be contacted before 9am the following day. This Analytical Interpretation shall include the following:
  - 1) A description of the sampling project, including outlet locations, and results.
  - 2) Recommendations for corrective actions, if necessary. These recommendations shall be based on the Guidelines set forth in VA Directive 1061.

**4. Qualifications and Duties of the Testing Laboratory**

- a. In accordance with VHA Directive 1061, the laboratory processing the water samples for *Legionella* must be certified by the Centers for Disease Control and Prevention (CDC) Environmental *Legionella* Isolation Techniques Evaluation (ELITE) program as proficient at performing the culture of *Legionella* species from environmental samples.
- b. The Testing Laboratory shall utilize the "CDC Method" for *Legionella* culturing known as "Procedures for the Recovery of *Legionella* from the Environment". The minimum detection limit for potable water samples must be 1colony forming unit per milliliter (cfu/ml). The CDC method includes the "Presumptive Phase" and "Confirmatory Phase" as described below:

- 1) The "*Presumptive Phase*" shall be used for Potable water and Non-Potable water. Potable waters shall be filtered and plated on Buffered Charcoal Yeast Extract (BCYE) agar for primary culturing of *Legionella*. Non-Potable water requires an acid buffer treatment prior to plating on the BCYE. Due to the overall high bacterial count present in the Non-Potable water, this step is used to reduce the number of these *non-Legionella* bacteria from the water before culturing.
- 2) After the "*Presumptive Phase*", the "*Confirmatory Phase*" shall be conducted. Relevant colonies shall be analyzed using the "*Legionella* Latex Test". This test is a serology method used to identify *Legionella* colonies by its Serotype. This test shall determine *Legionella pneumophila* Serogroup 1 and Serogroup 2-14. It shall also identify the presence of non-pneumophila *Legionella* bacteria, or "*Other Legionella species*" including *Legionella anisa*, *Legionella bozemanii*, *Legionella dumoffii*, *Legionella gormanii*, *Legionella jordanis*, *Legionella longbeachae* 1 and 2, and *Legionella micdadei*.
- c. The contractor's analysis and report shall contain at least, but is not limited to the following information:
  - 1) Testing Laboratory Name and Address
  - 2) Project Name/Lab Request Number
  - 3) NELAC Accreditation Number
  - 4) Sample Receipt Date
  - 5) Report Date
  - 6) Name and Signature of Laboratory Director or Manager
  - 7) Copy of Chain of Custody Form
  - 8) Sample results in colony forming units per milliliter (cfu/ml)
  - 9) Water temperature, biocide residual level, and pH for each sample collected
  - 10) Method of Analysis

##### 5. Required Analytical Sampling

1. The following sections provide a breakdown of sampling locations/frequencies: This contract covers the Veterans Administration Greater Los Angeles Healthcare System.
2. Sampling is required on a QUARTERLY basis. The minimum number of samples is 10 hot and 10 cold per building. Some buildings may require additional sampling at the direction of the COR and some buildings may be added or subtracted by the COR.
  - 1) If samples are positive additional testing shall be performed according to the needs of the facility as determined by the testing results and directed by the COR.
  - 2) Sample testing locations shall be determined by, and assigned to the contractor by the COR prior to and/or during each testing period.
  - 3) The estimated sampling per quarter is 430 samples, to include resampling.
3. Cooling tower systems shall be required to be sampled on a QUARTERLY basis, with one (1) *Legionella* sample drawn from each basin if possible depending on operation of the towers (drained towers are not able to be tested):

##### 6. Government holidays:

The contractor is not required to provide service on the following National holidays, nor shall the contractor be paid for these holidays.

If a holiday falls on Sunday, the following Monday shall be observed as the National Holiday. When a holiday falls on a Saturday, the preceding Friday is observed as a National Holiday by U.S. Government agencies. Also included would be any day specifically declared by the President of the United States.

- 7. Overtime and holidays:** Any overtime or holiday pay that may be entitled to Contractor personnel performing under this contract shall be the sole responsibility of the Contractor and shall not be billed to nor reimbursed by the Government.
- 8. Parking policy:** It is the responsibility of contractor personnel to park only in designated parking areas. Parking information is available from the VA Police. The VA shall not invalidate or make reimbursement for parking violations of contractor's personnel under any circumstances.
- 9. Smoking policy:** Contractor personnel may smoke only in designated areas. Smoking is allowed in all outside areas that are 25 feet away from entrances to buildings unless indicated otherwise. Enclosed patios connected to facility buildings are considered part of the building and as such are non-smoking areas.
- 10. Ordering activity:** Contractor shall not accept any instructions issued by any person other than the CO or COR acting within the limits of his/her authority.
- 11. Changes to Contract:** Only those services specified herein are authorized. Before performing any service of a non-contractual nature, contractor shall advise the CO of the reason(s) for the additional work and/or service. Prior authorization must be obtained from the CO before performing the services.
- 12. Complaints:** Contractor shall promptly and courteously respond to complaints within 3 working days. Including complaints brought to contractor's attention by the CO. Contractor shall maintain a written record of all complaints, both written and oral showing the identity of the individual, the nature of the complaint, and contractor's response. Contractor shall permit the Government to inspect such records upon reasonable notice.
- 13. Badges:** All contractor personnel shall be required to wear VA provided identification (I.D.) badges above the waist at all times while on the VA grounds. Contractors shall be required to coordinate with COR in order to obtain the VA provided I.D. badges for all staff. All VA provided I.D. badges shall be returned at the end of the contract or upon completion of service. Failure to wear ID badges may result in removal from any of the VA facilities and/or otherwise referred to federal property.

(B) *The taxpayer is delinquent in making payment.* A taxpayer is delinquent if the taxpayer has failed to pay the tax liability when full payment was due and required. A taxpayer is not delinquent in cases where enforced collection action is precluded.

(ii) *Examples.*



(A) The taxpayer has received a statutory notice of deficiency, under I.R.C. Sec. 6212, which entitles the taxpayer to seek Tax Court review of a proposed tax deficiency. This is not a delinquent tax because it is not a final tax liability. Should the taxpayer seek Tax Court review, this will not be a final tax liability until the taxpayer has exercised all judicial appeal rights.

(B) The IRS has filed a notice of Federal tax lien with respect to an assessed tax liability, and the taxpayer has been issued a notice under I.R.C. Sec. 6320 entitling the taxpayer to request a hearing with the IRS Office of Appeals contesting the lien filing, and to further appeal to the Tax Court if the IRS determines to sustain the lien filing. In the course of the hearing, the taxpayer is entitled to contest the underlying tax liability because the taxpayer has had no prior opportunity to contest the liability. This is not a delinquent tax because it is not a final tax liability. Should the taxpayer seek tax court review, this will not be a final tax liability until the taxpayer has exercised all judicial appeal rights.

(C) The taxpayer has entered into an installment agreement pursuant to I.R.C. Sec. 6159. The taxpayer is making timely payments and is in full compliance with the agreement terms. The taxpayer is not delinquent because the taxpayer is not currently required to make full payment.

(D) The taxpayer has filed for bankruptcy protection. The taxpayer is not delinquent because enforced collection action is stayed under 11 U.S.C. 362 (the Bankruptcy Code).
